# Challenger Mark Gjonaj swamps assemblywoman in heated primary

Bronxites woke up September 14 to a changed political landscape, with one veteran assemblywoman dumped and a longtime party regular filling a vacated seat. Morris Park/Allerton Assemblywoman Naomi Rivera, rocked by scandal and investigations, criticized for a lackluster performance as an elected and underfunded, went down to defeat, crushed 52 percent to 41 percent by well-funded businessman Mark Gjonaj.

Luis Sepulved a stomped Danny Figueroa by a 4-1 margin in an open race to fill longtime Parkchester/ Castle Hill/West Farms Assemblyman Peter Rivera's seat with Rivera moving up as new state labor commissioner.

Most other incumbents handily fought off challenges by minor candidates, though longtime Mott Haven Assemblywoman Carmen Arroyo pulled a disappointing 53 percent of the vote, political observers said, given that she had two relatively unknown challengers.

First-term west Bronx Senator Gustavo Rivera was also a strong victor, despite challenger Manny Tavarez getting support from Senator Ruben Diaz Sr.

A Pentacostal minister miffed at Rivera's support for gay marriage and pro-choice, Diaz provided Tavarez with both sound trucks and troops in the campaign to unseat Rivera in the 33rd Senate District.

Gjonaj (Joe-nigh) had the wide support of the Albanian-American community, but pretty much swept across the 80th Assembly District for winning numbers.

He crushed the three-term assemblywoman at the large Tracey Towers complex, where the vote was 360-66 in what had been her strong political base.

Gjonaj had stepped in with legal help to temporarily halt a 65 percent rent hike there, while Rivera did little to help. That was enough *Continued on page 62*

# **New leader for 45th Precinct**

The 45th Precinct now has a new leader sitting behind the large, stately desk in the commander's office.

Captain James McGeown, a 26-year veteran with almost his entire career as a patrol cop on the streets, took the helm of the precinct at a time when local crime has been down at perhaps the lowest rate in the borough.

At the same time, relations with the community were at their highest during the two-year run of his predecessor, Deputy Inspector Russell Green.

McGeown officially took over on Wednesday, August 29 when Green was transferred to the busier 43rd Precinct in neighboring Soundview shorlty after his promotion.

McGeown came from the 52nd Precinct in University Heights and Bedford Park, for quality-of-life initiatives," where he was the executive officer, and also in charge of the local Impact program.

"I know Russ Green for a very long time," said McG-

eown. "I know that Russ is very good at what he does, and we want to keep things moving in the same direction that things have been going crime down and community relations up."

"There is a bigger need said McGeown. "Since I have been here, a large amounts of the complaints that I have heard are quality-of-life type issues. There are crime is-

sues too, and we will have sergeant in 1993 and landed to deal with both. I am very confident in the personnel here. In partnership with the community, we should have a smooth run here."

Three of his top priorities, he noted, are reaching out to community leaders and elected officials and developing relations with them. familiarizing himself with crime trends and known offenders while interacting with his officers, and learning the lay of the land.

As of yet, he has not planned any major reorganizations of the precinct's manpower, but is learning his personnel and will not rule anything out, he said.

McGeown said that his experience in a patrol oriented function for much of his career, will serve the people of the precinct well.

"You pick up some things in 27 years," said Mc-Geown.

McGeown came "on the job" in January 1986 and was assigned to Manhattan North in 1987. He was promoted to

first in the 19th Precinct, and then the 20th, both in upper Manhattan.

He subsequently served in the 25th and 28th Precinct as a sergeant, before becoming a lieutenant - and his first Bronx assignment in the 43rd Precinct. He worked there in patrol and as an integrity control officer for about four vears.

He was assigned to Riverdale and Kingsbridge's 50th Precinct in 2008, where he was in special operations, and then, upon promotion to captain earlier this year, to the 52nd Precinct.

McGeown who grew up in Queens, is the son of a police lieutenant who retired in 1988. His brother is also a police officer in the 109th Precinct in Queens, as his wife Marjorie is a police officer in Manhattan.

The couple, who live in Rockland County, have an 8-year-old and 10-year old, and McGeown has two college-age children from a previous marriage.

## Fundraiser for one of NY's Finest

Police Officer Owen Ortiz has upheld his oath to save lives. Now he needs help to save his.

His fellow 49th Precinct brothers and sisters in blue will host an October 2nd fundraiser for the nine-year veteran, who is fighting Stage IV cancer.

The Pine Bar & Grill at 1634 Eastchester Road will be open exclusively for the fundraiser that evening.

Organizers will hold raffles on hot items from professional New York sports teams. The grand raffle prize is a private concert by pop sensation Katy Perry.

The cancer was found in Ortiz' cheek last year, and soon settled into his head, neck and throat.

He initially beat it after undergoing daily radiation treatments.

But it soon returned.

The months have been rough for Ortiz, who once weighed 260 pounds, a "teddy bear" with a frame that came in handy while playing football for Syracause University.

"He's going to sack this cancer," said 49th Precinct Community Affairs Police Officer Vic DiPierro. Ortiz's ordeal hits home for DiPierro, himself a survivor of cancer, a result of working on The Pile at the World Trade Center site after 9/11.

But Ortiz' potentially life-saving treatments came with unintended consequences, namely an intestinal condition and recurring fever.

His lack of daily food intake brought down Ortiz's weight. The treatment also placed a burden on his finances. After several weeks

Amerigroup RealSolutions of daily treatments, his NYPD benefits for cancer treatment expired, explained DiPierro. Ortiz has now accrued several out-ofpocket expenses, a tough spot for a married father of a 4-year-old daughter.

Ortiz joined the NYPD ranks in 2003, eventually assigned in 2006 to the 49th Precinct covering Morris Park, Allerton, Van Nest and Pelham Parkway.

"He's the kind of guy you want to be around offduty because he's a fun guy," said DiPierro. "And he's the kind of guy you want on-duty because he is an awesome police officer."

The Tuesday, Oct. 2 fundraiser will run from 7 p.m. to 11 p.m. Tickets are \$20, available at the door or by calling DiPierro at (718) 918-2025, or Sergeant Ryan Hughes or Police Officer Eric Rivera at (718) 319-8435. Donations are always accepted.

# **Bronx veterans receive final honors**

Military veterans spanning three wars, they died poor and alone.

But fellow vets from the Bronx and elsewhere helped send them to their final rest this week with military honors.

Carey Johnson, 58, who served in Vietnam; George Goodwin, 79, who served in Korea, and Lensey Roosevelt Carrington, 88, who served in World War II, received military funerals on Tuesday, Sept. 18, thanks to the efforts of City Islander Jim Mullarkey, head of the state chapter of the Catholic War Veterans of America.

Under leaden gray, damp skies, the sad echo of taps mixed with the crack of rifle volleys from an honor guard as Mullarkey and other chapter veterans snapped to attention at their graves in Calverton National Cemetery on Long Island for one final salute.

Their bodies had wound up in the city morgue, unclaimed. When their fingerprints showed all were veterans, the Medical Examiner's Office notified the Mayor's Office of Veterans Affairs.

Mullarkey, 74, who saw combat with the 82nd Airborne Division in Vietnam, said he contacted the office, hoping like other veteran's groups, to sponsor burials for indigent veterans.

"We felt no matter who you are, what religion, we want to honor you with a proper military burial," said Mullarkey. While the government only provides \$900 for military burials, a member of Mullarkey's veterans' group reached out to the Brooklyn Funeral Home in Brownsville, where owner Anthony Cassieri was glad to handle the arrangements, absorbing any extra costs.

With a motorcycle escort, a cortege of hearses and members of the Catholic War Veterans, brought Johnson, Goodwin and Carrington to their final home.

Next week, Mullarkey said his group and the Lucchese Funeral Home on Morris Park Avenue will hold a military funeral for another fallen veteran.

"We are more than glad to help," said funeral home director Joe Lucchese.

# Steep fines send strong message to Pompeii

An east Bronx bar that's raised hell and neighbors' hackles - has been slapped with heavy fines. But the violations apparently were not enough for the Pompeii Bar and Lounge on E. Tremont Avenue to have its liquor license suspended or revoked.

An administrative law judge fined it \$15,000 over State Liquor Authority violations from 2011. It was fined about \$14,000 in January over eight 2010 charges - which were quickly paid. Senator Jeff Klein and Councilman Jimmy Vacca, both active in the fight against the bar, hailed the new fine.

"Hopefully, this steep fine sends a strong message to all nightclub owners that crime doesn't pay," said Klein.

The new fine - for a disorderly premise appears related to a brawl, and for overcrowding and lack of an assembly permit in a multi-agency raid on March 20, 2011.

But the ruling, issued Wednesday, September 12, will not yet cause the bar's liquor license to be suspended or revoked.

"Another day, another fine or shut down!," said Vacca, who last week worked to forced Pompeii to cancel a planned rap talent show after learning it had no public assembly permit.

"I want to make this clear - Pompeii has not been a good neighbor, and our community will be vigilant at every turn when it comes to Pompeii's violations and their thinking they can do what they want, when they want."

# **Traffic light finally installed**

### **BY DAVID CRUZ** Let there be light! A traffic study coupled with an outcry of concern has finally brought a muchneeded traffic signal to a Pelham Bay intersection.

Until recently, crossing the corner of Middletown Road and Mayflower Avenue was a potential gamble.

Without a clear line of sight from both sides of Middletown, locals often took their chances, dodging cars speeding eastbound.

Children looked twice. The elderly hightailed it beyond their lumbering pace.

But the street was also congested, with gridlock becoming the norm along the residential street.

"It was something that was needed," said longtime merchant Estrella Negron of Embroidery Zone, whose shop sits on the crashprone corner. "There were so many accidents."

The fourteen-block stretch, divided by the

Bruckner Expressway, had experienced several smashups in the past, mainly on Crosby Avenue, where a traffic light was eventually

installed in 2005.

But resident Ann Boller of Pelham Bay wanted one at Mavflower Avenue, made up of two-story homes just at the tip of a small business area.

"I've been in Pelham Bay for ten years, I was always saying we need a light," said Boller. "Traffic on Middletown was relentless." She and members of the Mayflower Block Association went door-to-door. petitioning their fellow neighbors to get a signal light hooked up.

Signatures were sent to Councilman Jimmy Vacca, chair of the council transportation committee. He put in an official request to the city Department of Transportation to conduct a traffic study.

A team convened at the site, examining whether there was a need. By May, DOT concluded a traffic light was needed.

Getting the light came quick. Work finished two weeks ahead of schedule.

"DOT has made Middletown Road much safer for drivers and pedestrians," said Vacca.

With the traffic light on, residents can now rely on the blinking red hand and the solid white figure to get to the other side.





### One thing we need in NYC is Walmart

Larry Penner's recent pro-Walmart letter overlooks the many negative effects that accompany this organization whenever it comes to town. While some citizens might save a few dollars shopping at Walmart the hidden costs to society are much higher.

One way that this highly profitable enterprise keeps the money rolling in is by maltreating its low wage workers. By hiring many parttime workers and few full time employees, the company dodges the costs of medical coverage, effectively transferring this burden to the public treasury when these individuals seek medical attention in our emergency rooms.

Walmart also has little or no respect for the civil liberties of its personnel. Potential employees are required to take a so-called "personality" test: this questionnaire is designed to eliminate candidates who might view unionization favorably. Walmart is infamous for its staunch opposition to labor groups.

Walmart has consistently failed to treat its workers fairly. In 2008 the company paid \$352 million to settle 63 lawsuits filed by employees denied rest and meal breaks. 

Some good neighbors are galloping to help Rusty. He's the last horse remaining at the dilapidated one-acre stable on Pelham Parkway in Morris Park that's finally been condemned.

A group of local neighbors and officials are now concerned over what former occupant Buster Morango will do with his horse, who remains in the rundown stables, reportedly living in squalor.

Because of a stipulation in state law, the accompanying order to vacate a condemned property applies only to humans.

Senator Jeff Klein has partnered with Assemblywoman Linda Rosenthal. an animal rights advocate, to sponsor legislation enabling animal protection officers to save animals like Rusty from condemned properties.

"It defies common sense that even after we've condemned this dangerous stable, Rusty is forced to suffer inside," Klein said.

The city shut down the property at the end of the 1600-block of Pelham Park- residentsh to hold an animal



### 11 YEARS LATER, BRONX PAUSES FOR 9/11 ANNIVERSARY









# Pre-owned cars can be a smart financial bet

any people look to the used-car lots when shopping for vehicles. The allure of a lower price is what drives some consumers to purchase a pre-owned car or truck. Considering many of the used vehicles available are only a few years old, this can be a smart decision.

With the widespread availability of leases, many pre-owned vehicles are lease turn-ins that are only a few years old and in relatively good condition. ties that cover many of the same items one would find with a new vehicle. Certified vehicles can be a safer investment, primarily because the service history and the condition of the car is verifiable. Buying from a private owner may be a riskier purchase.

That doesn't mean that buying a used car from a private owner should be avoided at all costs. Many private sellers are honest individuals and will offer proof documenting the vehicle's maintenance history. There are also car history reports that can be obtained using the VIN number on the vehicle to check to see if it was in any major accidents or had other kinds of damage.

Buying used is also a green investment. While a brand-new hybrid may certainly save on fuel use, the energy needed to produce that new hybrid can be considerable. Purchasing a used car means less demand for a new one to be made.

Another advantage to used vehicles is that insurance premiums may be lower. That's because new cars usually require comprehensive insurance coverage, when a used vehicle may only require the basics.

People looking to save money on a vehicle should consider pre-owned cars as viable options for their next vehicle.

# Selecting a teen driver's first car

otor vehicle crashes are the leading cause of death among U.S. teenagers, accounting for more than one in three deaths, according to the Centers for Disease Control and Prevention. The good news is that, with a sturdy car and some well-ingrained safety lessons, many of these crashes are largely preventable.

Parents of teens are reticent to have their children join the millions of drivers on the nation's roadways. A teen driver can test one's nerves. Once a teenager receives his license, the family will have to reassess its automotive needs or risk fighting over the family car somewhat regularly.

Industry experts agree that there are some tips parents can follow when selecting a teen's first car. •Shop for pre-owned vehicles. Most families are already feeling the heat of overtaxed budgets. Another car payment could be unaffordable.

Plus, insurance premiums for

a teenage driver could be very expensive, especially if that teen is driving a brand-new car. Shop for a car that is a few years old. Not only will it have plenty of miles still left in it, but also, if an accident occurs, the repairs likely won't be as expensive as they would if a new car gets dinged up.

•Seek out sedans. Sure, they may not be the ultra-cool sports car or the behemoth sports utility vehicle, but sedans are large enough to effectively protect a driver in an accident and will have plenty of room to carpool friends to movies, sports games and such.

•Make kids bear some of the financial burden. Parents should make their children financially responsible for the car in one way or another. Whether they contribute a few dollars to the monthly bill or are responsible for oil changes and fuel costs, having a financial investment may encourage kids to be more careful with the vehicle.

•Teach defensive driving. A vehicle is only as safe as its driver. Consider defensive-driving courses in addition to the regular driving courses and exams the teen has taken. It will help him learn even more about being safe on the road. Of course, experience through road miles is another way to gain expertise.



Eleven years to the day after the attack on the World Trade Center, American embassies in Libva and Cairo were brutally assaulted, resulting in the death of U.S. ambassador J. Christopher Stevens and several others. Despite warnings 48 hours in advance of last week's attacks on our embassies, nothing was done to protect American diplomats, military, and civilian personnel.

It must be remembered that the 9/11/01 attack was the second attempt to destroy the Twin Towers. On February 26, 1993, these buildings were targeted by the same al Qaeda forces that later succeeded, eight years later. That try, using a van full of explosives in a parking garage below the WTC, didn't succeed in collapsing the towers, but it did manage to kill six people and injure one thousand.

Unlike the invasion of Afghanistan ordered bv President Bush after 9/11, President Clinton's

response to the 1993 attack was minor and ineffective. Al Qaeda gained the confidence that it could engage in a direct assault on the American homeland without suffering a significant counter-attack. Osama Bin Laden believed he could bring massive destruction to the U.S. and have a possible chance of keeping his organization intact. Seven vears later, the USS Cole. docked in Yemen's Aden harbor for refueling, was bombed.

After 9/11, however, the forceful response by the Bush Administration. the heroism of our armed forces, and the constant vigilance of the NYPD and federal counterintelligence forces prevented the additional massive attacks that all feared would follow.

Thanks to the decadelong effort initiated by President Bush and completed with the heroism of the Navy Seals, with the approval of President Obama, Bin Laden is finally dead. But is Washington again sending signals of weakness, encouraging those who wish harm to America and its allies?

The answer is unsettling. President Obama ordered a withdrawal of most U.S. forces from Iraq before taking steps to counter influence from Iran. The delay by the White House implementing strict in sanctions against Iran for its nuclear program has brought both the U.S. and Israel to the very brink of a holocaust.

The danger exceeds just the Middle East or Al Qaeda. The vacillation of the Obama Administration to Moscow in the ABM issue further enhances an image of an America in full retreat, as does the White House's approval of the New Start treaty which gives Moscow a permanent advantage in nuclear weapons. One hideous example: Russia now has a ten-to-one advantage over the U.S. in tactical nuclear weapons.

Nor is the weakness confined to Europe and the Middle East. In the Pacific, China has engaged in outright aggression against the Philippines, thanks to its massively enlarged navy. Beijing's warships literally invaded and now occupy a resource-rich area belonging to Manila. The assault remains unanswered by Washington, despite America's treaty obligations to our ally.

China, Russia, and sharply have in-Iran creased their military budgets, and all three have a significant presence in the Caribbean and throughout Latin America, a dangerous threat ignored by the White House. Russian nuclear capable bombers have patroled our west coast, and enemy nuclear subs have cruised under the waters of our Eastern and Southern

coasts

Despite these vast and still growing dangers, our defense budget is being cut, and there are plans to further slash it drastically in the very near future. This weakness breeds extraordinary danger to America, just as Britain's weakness encouraged Nazi Germany to launch the Second World War in Europe.

Those conversations with brave but tearful administrators and nursing officials are etched forever in my mind. In the week that followed, I was in the area of City Hall, and witnessed the nightmarish metamorphosis of one of the most vital parts of our city into a surreal disaster scene

Numerous Northeast Bronx police, fire, and emergency management personnel, along with their counterparts from throughout the region and other public employees exhibited heroism both on the day itself and in the hellish weeks and months that followed.

Those who lost their lives have left a permanent hole in our hearts. Cancers and other enduring injuries still linger in those who were there but survived. Now, we must add additional names to the roster of those lost to terrorists who sensed American weakness. Coming Soon: Of course there is the projected Golf Course, The coming Target Shopping Center, The Woodbury Commons type Mall. the future work on the Unionport Bridge and the restroom and water construction in our Park. In these matter we keep a photo archive, attend whatever meetings we are allowed to participate in and give time to reporters and writers that need info on these topics. Many times we will accompany a reporter to help them find locations. access for photos and or interviews.

Animals: There is the ongoing spay /neuter/adoption of our neighborhood cats. I just attended a seminar to re certify as a TNR Rescuer with Neighborhood Cats and ASPCA. We encourage Brush Avenue area residents to call us 917-741-2768 to report any new cats in the neighborhood so we can neuter them before the cycle of kitten's starts again. There are no "un fixed" females and only two new males that need to be "fixed". (In our Colony) BAAC: Our Brush Ave.

Action Committee was also responsible for notifying a portion of our area that they were being excluded from the IBZ new boundary map. Since then we have been supporting the request by our business and residential neighbors along Yznaga Place and Brush Avenue (from Schlev to Yznaga) to stay in the boundaries of the IBZ (industrial business zone) designation. We entered comments within deadline online (thanks for follow through to Joanne Miller ). This is an M-1 zoned area and there is no reason to remove them from this status. We thank CB10 for their letter to the Boundary Commission and to the Economic Development Committee for inviting representatives from this Commission and SOBRO to their next Meeting to discuss this situation. We will attend the Oct. Committee meeting where the BOEDC/ or Boundary Commission rep. will be available. CB10 was very open to work with SOBRO and we see a great cooperation between the two in the future. SOBRO reps. were very informative and we will



be sitting with our rep. soon to network and see how we can help them help our industrial zone.

Parking: There is also questionable ticketing of (I counted 11 cars) across from Home Depot on Brush Avenue during the day. I can't see any reason for those tickets and will be discussing with the businesses in that area. We have been reading about the problems with overnight parking of trailer trucks in CB10. Luckily we have eliminated this problem years ago by placing the no parking 10am-5am signs that we saw on Zerega near the sanitation depot (thank you Jimmy Vacca). We later had to enforce them due to the needed clarification that "US Mail Trucks do not get courtesy parking privileges" (thank you Jeff Klein). We are still working on the problem with HOPenn delivery trucks idling overnight waiting to drop off parts across from children trying to sleep.

Maintenance: As for repairs: We had the dangerous catch basin on Brush and Schley replaced (nicely) and the holes filled in front of the homes from 680 to 710 Brush (Badly). (Thank you 311 and CB10). We have been working with Ciminello Properties on various dust abatement and graffiti removals with great success and are now working with them to clear up the pallets and debris behind Home Depot along Brush Avenue.

Relocating: Art Forms at 711 Brush Ave. will be relocating soon and BJ's still holds the lease from when it was Pro Foods. We are always afraid of who will come across the street from our homes but we leave it to Ciminello Properties to choose the most non invasive tenant.

The Bus Company on the corner of Brush and Bruckner will "really" be moving. Ciminello Properties has notified us that even though there were delays in the building of the new location for the school bus co. the Nov. date is still viable.


The Senior Care Ambulette Co. says it will be relocating but that remains to

be seen. We would welcome their move because they are working from an office in an M-1 zone with little if any parking for their employees. These employees are in the habit of emptying debris from their personal cars into our streets morning and night. Also their fleet takes up the two sides of Brush most of the day with frequent double parking, open doors with inconsiderate conversations happening in the middle of the street (making traffic bog down and enter oncoming lanes).

Street Trees: We are having a dilemma as to the care of the street trees along 711 Brush Avenue. We need them cared for. We have personally done it a few times; we even spent 45 minutes each night watering flowers (Thank you Sal Profita) with hoses that kept getting damaged from vehicles. We have had community service volunteer's care for them a few times (thank you Tom Accomando Jr. and friend). The tenant Art Forms then had a caretaker caring for them. We now have to ask the City to come and weed and mulch around these ten street trees.

Graffiti: Suddenly has become a bit of a problem in our area....we believe it is connected with the new soccer leagues that have entered FP Park on Saturdays, we could be wrong but that is when it blossomed. We hope to design a flyer and send out a E-blast to the industrial businesses to help the appearance of the area by removing this mess ASAP.



# F & M Schaefer now owned by Pabst

My wife and I were wandering around Woodlawn Cemetery when we had the good fortune of meeting the superintendent. He's extremely knowledgeable and took the trouble to bring our attention to the Schaefer family site. It is located in a rather out of the way place in the Highland plot and is the final resting site of the one time beer baron family.

Most older readers will recall their popular jingle: Schaefer is the one beer to have if you're having more than one. Some baseball fans may also recall the illuminated Schaefer sign in the outfield of Ebbets Field where the letter h lit up when a player reached first base unless it was due to an error in which case an e would light up.. The stadium at Sullivan Place and Bedford Avenue in Flatbush, by the way, was named for Charlie Ebbets. the owner, and the first game played there was in

1913. It closed in 1957 and was demolished in 1960.

Another popular beer from that era was Rheingold which would later become the official beer of the New York Mets. Their jingle is also widely recalled as "My beer is Rheingold the dry beer. Think of Rheingold whenever you buy beer. It's not bitter, not sweet, it's the extra dry treat. Won't you try extra dry Rheingold beer?" It was sung to Waldteufel's Estudiantina waltz but most people who hear it refer to it as the Rheingold song


Schaefer and Rheingold were fierce competitors in the 1940s and 1950s with Rheingold having a little edge because of their popular beauty contest that was sweeping the nation. Everyone wanted

to vote for their favorite beauty queen. Both beers were on tap in all the local saloons but when Schaefer altered their recipe to save a few dollars, they started losing their share of drinkers. Budweiser entered the fray about that time and they had the best marketing staff eventually putting both Schaefer band Rheingold into subordinate positions.

Schaefer beer was advertised as the first lager beer to come to America. Frederick came over from Wetzlar, Prussia (now Germany) in 1838 and his brother Maximilian arrived year later, thus we get the name F & M Schaefer Brewing Company. They opened their first brewery in America in 1842. When they passed away in 1912,

the brewery passed to Rudolph J. Schaefer. He died in 1923 and his two sons, Frederick M. E. and Rudolph J. Schaefer Junior took control of the family business. There have been numerous changes since then and title to the company is now held by Pabst. By the way, should you decide to stop by the family plot for a visit don't be surprised if you come across a family member as some still come to pay their respects. Now, that's class.







vote winning margin.

Two minor challengers, Adam Bermudez and Irene Rukaj, drained about seven percent of the vote, from the new heavily Hispanic portion of the redistricted 80th A.D. Instead of bolstering Rivera's numbers, it turned into an anti-Rivera vote.

The final vote tally was 2407 to 1894, with 100% of the votes counted.

A new Board of Elections voting system using printed ballots and electronic scanners to record them created a long, dramatic late night finger-biting wait for results. What normally would bring in an unofficial county by 9:30 to 10 p.m. dragged on to well after midnight before a final count.

Emotions soared and sank as the latest tallies seesawed, with a wide lead for Gionai, then a closing gap, until the final results, with pandemonium breaking out about 12:30 a.m. at Maestro's Caterer's in Van Nest where his supporters had gathered.

The mood at Rivera's campaign headquarters on Allerton Avenue quickly turned grim early on.

Before the numbers were tallied, a haggard-looking Rivera briefly stopped there at 10:30 p.m., thanking well-wishers while blasting the campaign season's "smear attacks."

"This has been a difficult campaign," said Rivera. "A campaign unlike anything that I've ever witnessed in my career."

Rivera stood side by side with her family, including assemblyman father Jose and Council majority leader brother Joel. She dismissed allega-

tions of nepotism, funneling nonprofit funds for private use, and hiring boyfriends for taxpayer-funded jobs.

"There were a lot of accusations and allegations without evidence that were leveled at me and my family."

Twenty minutes later, Rivera left with her father and brother, ducking reporters' questions. But even with the loss, Rivera vowed to plow ahead with her duties as the assembly woman representing Allerton, Morris Park, Pelham Gardens, and Pelham Parkway communities, as well as parts of Norwood and Bedford Park.

She reminded her campaign workers she still remains the assemblywoman for the next three months.

the predominantly blue-collar borough.

Most pumps around the borough this week were pumping regular at \$4.15 (and a sneaky 9/10ths) a gallon. And a few were charging even more outrageous prices.

But gasbuddy.com was a bit behind, saving locals were forced to deal with an average price of \$4.11 a gallon of regular gas, about 30 cents higher than the national average.

The price is draining for Tito Rivera's bottom line. A City Island-based tow truck driver. Rivera filled up at the Sunoco station at 410 City Island Avenue.

"Work wise it hurts," explained Rivera. "The little extra change you put in your tank could pay for your breakfast."

Rivera is often forced to tack on extra costs to customers to make up for the revenue going towards gas.

But the steepest prices can be found at a Citgo station resting on both sides of the Hutchinson River Parkway by the Whitestone Bridge. There, drivers can't deal with nearly \$5 a gallon gas.

On a visit there, most of the customers were outof-towners on the parkway's southbound side, walloped by the sticker price at the Citgo station.

"It's all about convenience," said Jessica Kastner. a Connecticut resident filled up a portion of her tank before heading into Queens.

But getting gas at a Gulf at 2007 Williamsbridge Road

west coast have the highest gas prices in the nation, with the national average at around 3.87 a gallon.

This was almost as high as the previous record at about \$4.12 nationally set during the summer of 2008. As the economy tanked at the end of 2008 and beginning of 2009, so did gas prices, which bottomed out at about \$1.61 nationally.

But there has been a slow and steady rise ever since, especially in late 2010. During this time, gas prices in New York have been consistently higher than the national average.

Sajjad Yaqub, who was manning the counter at the Shell station on Bruckner Boulevard and Brook Avenue in Mott Haven, said he couldn't believe the price spikes when the station got their weekly delivery from their distributor.

"A couple of weeks ago, it jumped 18 cents. I had to call my distributor and ask, 'Are you sure that's the right price?"

His station sits be-

tween a Hess station just down the boulevard, which was matching his \$4.15 and 9/10ths price, and a Gulf up at the exit off the Willis Avenue Bridge, where motor-

ists had to eat \$4.29 a gallon to fill up.

"A lot of motorist buy \$5 to \$10 gas here," he said, "then they drive to New Jersey to fill up."

The high cost of gas is linked with the complicated cost of war in the Middle East, where civil unrest continues in Syria and Lybia. The two nations are major exporters of crude oil, the raw material used for gas.

But refineries have limited their production because of the turmoil. causing gas prices to jump, according to Monroe College economics professor Deve Rawana.

He noted that behind the low exports is global demand, mainly from countries China and India.

"China and India never used a lot of oil until the last 10 years," said Rawana. "They're demand is rising up each year."

But Rawana warns that until an alternative source hits mainstream Bronx. locals will have to bear the brunt of high gas prices.
