



### Board 9 district mgr. escapes ax



### Community Activist Louis Curcio passes

A community icon in public education will be greatly missed in his Pelham Bay community and beyond after his death last earlier this month.

Louis Curcio, 68, a public high school teacher and education leader for almost 40 years, passed away from cancer at Calvary Hospital on Friday, Dec. 14. who served two, Curcio served for two four-year terms on Community School Board 8 in the late-1980s, including as its president for a term.

He was instrumental in naming Junior High School 101 (later M.S. 101) after slain police officer Edward R. Byrne, said longtime friend Councilman Jimmy Vacca, who served on the school board with Curcio.

"He was a person of unquestioned integrity and honesty," said Vacca. "He was someone who deeply cared about the schools -

whether they were in Hunts Point or Throggs Neck."

Curcio's teaching job helped on the school board, Vacca added.

"He brought to the school board not only a very level temperament, but also a knowledge of curriculum and of teaching that was very rare," said Vacca. " It was an expertise that really helped us on the board."

A Queens College graduate, Curcio taught social studies at Francis Lewis HS and Benjamin Cardoza HS in Queens, and Samuel Gompers HS and lastly at Lehman High School in the Bronx, said Curcio's sisterin-law, Margaret Curcio.

"He just lived for his three nephews," she said of Curcio, who never married. "They were his life and his everything. He was just a family person."

Vacca said that in recent years Curcio was an advocate for graffiti removal in the Pelham Bay

community he loved. Senator Jeff Klein stated Curcio would provide weekly reports to his graffiti clean up program.

"He wanted to maintain Pelham Bay as a viable community," said Vacca, who along with NYPD Assistant Chief Edward Delatorre, eulogized Curcio on Tuesday, Dec. 18.

Curcio is also survived by his brother John and nephews Michael, John, and Louis Curcio.

### New Bronx rep for Dept. of Ed panel

The Panel for Education Policy has a new go-to man from the Bronx.

Borough President Ruben Diaz Jr. selected Robert Powell as the borough's representative to panel, which reviews and votes on city Department of Education issues.

He is one of 13 members on the panel, which also includes Schools Chancellor Dennis Walcott and a number of mayoral appointees.

The panel is currently dealing with several issues, including a potential strike by yellow school bus drivers at the start of 2013, policy surrounding sibling-preference for gifted and talented programs, and point-of-entry for kindergarten programs.

"Robert Powell is dedicated to the growth and well-being of our borough's public school system, and has shown a strong commitment to the children of this borough and this city during his many years of service," said Diaz. "I look forward to working with him to continue our work in developing a strong agenda for the future success of our public school system." Each borough presi-

dent gets one appointment to the PEP, with the rest of the members appointed by the mayor.

Powell, who replaces former Bronx representative Wilfredo Pagan, hails from Wakefield and is the parent of six children in the New York City public school system.

He is the former parent association president at Lehman High School.

He also served as parent association president of a District 75 school for four years.

He was both co-president and president of the Bronx High School Federation from 2008 to 2011.

Powell also served on the Citywide Council on High Schools, serving as recording secretary from 2010 until his appointment to the PEP. The CCHS is an advisory board providing input and comment to the chancellor and PEP regarding public school needs.



Soundview/Parkchester Community Board 9 district manager Francisco Gonzalez dodged a board vote to dump him by only two votes, despite Ruben's behind-the-scenes maneuvering.

Then Community Board 11 in Morris Park/Allerton voted down Ruben and Councilman **Jimmy Vacca**'s candidate for new board chairman.

#### Soundview shakeup

Board 9's Francisco G. managed to keep his job - for now - after a preliminary vote on a motion to hold a dismissal vote resulted in 15 votes to remove, ten against and seven abstentions.

Ruben dumped - er - failed to reappoint 15 members - almost half the board - last August when their two-year terms expired, reportedly hoping his new appointees would back his push to dump Francisco after almost 20 years there as district manager. On one side of the issue, the annual Bronx Puerto Rican Day Parade run by Gonzalez failed to pay some state taxes for a few years ("We working that out," sayeth Francisco) and parade work was done from the board office, allegedly on city time ("That was a volunteer."). On the flip side, Frankie has managed to keep the board fairly independent of the politically powerful Diaz family - BP son Ruben Jr. and state Senate dad Ruben Sr.

#### Political deal

Meanwhile, over in Morris Park, we're told Ruben's candidate for chairman, local Democratic state committeeman **Joe McManus**, pretty much didn't stand a chance, despite all the behind-the-scenes politickin' by Jimmy, and by the BP, who personally phoned a number of board members to make his feelings known.

The odds were stacked after candidate **AI D'Angelo** of the Morris Park Community Association pledged to throw his support-

ers' votes to vice chair – and ultimate winner – **Tony Vitaliano** if it wound up in a runoff with Joe.

We hear Vitaliano, acting chair for two years during the lengthy illness of the late Dom Castore, was ready to reciprocate. Another winner

#### Assemblyman-elect **Mark Gjonaj** was also a winner in the board vote.

We hear McManus, who vigorously campaigned for incumbent **Naomi Rivera** might now be facing a Gjonaj-backed challenger for his state committeeman's job. Mark will certainly be backing early supporter **Diane Cerino** for her old state committeewoman's job, after she lost it to a McManusbacked challenger from their mutual Liberty Dem club.

Gjonaj has been keeping his distance from the Liberty Dems, and with that mob scene of supporters at his holiday party at the Lighthouse on City Island last Friday night, could easily form his own political clubhouse.

#### PRAY FOR US

We got a number of calls from chuckling political types on Wednesday after State Senator **Ruben Diaz Sr.** had us and **Jim Odato** from the Albany Times-Union in the No. 2 slot on The Rev's Top Ten Wishes for 2013 newsletter, wishing we'd "learn how to be impartial and objective journalists."

Speaking of objective, we ran an item last week with the senator telling us he got a phone call from an unnamed person offering him chairmanship of the aging committee - and flat out turned it down.

That came as a surprise after we checked with both GOP leader Dean Skelos and Independent Dem Conference leader **Jeff Klein**'s now ruling coalition.

But The Rev insists he's not getting delusional.

"Someone called and asked me what my reaction would be if I were offered it," he told us. "I'm not lying."

### ALBANY FOLLIES

Now that Senate Dems have replaced Brooklyn's John Sampson with Yonker's Andrea Stewart-Cousins as conference leader, folks are wondering if it'll shake breakaway Bronx Senator Klein and his five-member IDC's tree. Don't count on it.

Jeff initially left the Dem Conference because of Sampson, whom he openly can't stand. He most recently snatched the Dem's newly won close majority away by forming a coalition majority with GOP conference leader Dean Skelos.

West Bronx Senator **Gustavo Rivera**, who served as Stewart-Cousins' chief of staff in 2007, told us he's hopeful "she'll be able to bring folks together...and someone that Gov. Cuomo can talk to now."

Meanwhile, both Diaz and northeast Bronx/Mt. Vernon Senator **Ruth Hassell-Thompson** wound up losers in the Dem conference shakeup, as two of only six members who voted to keep Sampson.

Ruth had hoped for awhile in all the Albany *tsuris* to be a compromise candidate for the leadership post.



# Jan. 3 deadline to save **Bronx Catholic schools**

**BY KIRSTEN SANCHEZ** It was a chilly holiday for parents and students at eight Bronx parochial schools, with the clock ticking on them to come up with financial plans to save themselves.

With a January 3 deadline looming to come up with a financial plan to raise nearly \$1 million over the next three years, parents at one school have recruited Senator Gustavo Rivera to help join their plight.

He and about a dozen parents rallied outside of Our Lady of Mercy in Fordham on Wednesday, Dec. 19.

The senator wrote a letter to the Archdiocese of New York requesting it show some Christian charity and give the school more time to come up with a plan to raise the money it needs to stay open.

But Rivera said the diocese denied his request for a deadline extension. It doesn't mean the school and parents will give up.

"This is not the only school in my district that is in danger of closing – I have four in my district," he said. "It is extremely disconcerting when you have a school that serves an overwhelming Latino and African-American community and need in this area."

The other Bronx parochial schools at-risk for closure are: Holy Spirit elementary school in Morris Heights, Our Lady of Angels school in Kingsbridge, St. Jerome school in Mott Haven. St. Anthony's School in Wakefield, St. Mary's Elementary School in Williamsbridge, St. Mary Star of the Sea school on City Island and Blessed Sacrament in Soundview, the alma mater of U.S. Supreme Court Justice Sonia Sotomavor.

The schools were notified of their impending closures by the diocese in November. Diocesean officials said the next step will be to have pastors and principals of the at-risk elementary schools meet with the local board or committee to discuss the factors that led the schools being selected and the next steps to be taken.

Parents from the atrisk schools have been struggling to come up with ideas, including setting up fundraisers, emergency Pay Pal accounts and holding rallies, to help raise funds and draw attention to their struggle.

Soraya Alvarez said her daughter graduated from Our Lady of Mercy in 2000,

that is certainly in serious and went on to graduate college and receive her masters. Now she is desperate to keep the school open for her grandson, now in first grade there.

> "It makes me really sad to know that it will be closing," she said. "What can we do? It's almost like we are being set up for failure."

Jose Cornelio, who has two sons attending the school, said he thinks so highly of the school he drives his sons there from Yonkers.

"I am a product of the Catholic school myself," Cornelio said. "It's not right what they are doing. These children are in need of a good education."

One of Elma Defreitas' daughters graduated from Our Lady of Mercy, and another is now in third grade there.

"It's a tradition in our family to go here," she said. "When other parents in the neighborhood ask me where to send their kids, I tell them here. The people that work here are like family. I don't want to send my daughter to public school, I purposefully chose not to. If the school winds up closing I will send my daughter to the Carribean to finish her education."


## Vacca's Year in Review

As the 2012 legisla- to affect the quality of life for tive year draws to a close, Councilman and Transportation chair James Vacca announced that the Transportation Committee of the NYC Council was one of the most active committees in the entire body in 2012, accounting for a quarter of the 63 local laws enacted so far this year. The Transportation Committee passed 14 bills that were ultimately signed by the Mayor and also overrode two mayoral vetoes.

"I take my responsibility as Transportation chair quite seriously," said Vacca. "This is a committee that has a real opportunity

all New Yorkers, and I think we have done a good job making positive changes that will have a significant impact on people's lives. My committee has produced meaningful legislation because its members constantly have good ideas worthy of consideration. I think this speaks to the heavy handedness that's been used to change policies without proper care, and the corrective action that my committee has had to take on behalf of residents."

The bills vary widely, addressing sex trafficking in the taxi and for hire vehicle industry to new regulations on commercial cyclists. As chair, Vacca also focused on expanding the mobility rights of blind and visually impaired New Yorkers, passing three bills on this topic. Vacca fought for parking fairness, passing legislation that allows New Yorkers: to transfer muni meter time: to use an affirmative defense for valid muni meter receipts; a 5-minute grace period to purchase a muni meter receipt; and cancellation of an open ticket when proof of muni meter purchase is given. Vacca led the fight to ban the use of the Department of Sanitation's hard to remove window stickers for alternate side violations.





# A special 85th anniversary celebration for Amalgamated Houses

One of the oldest housing cooperatives in the Bronx is celebrating its 85th anniversary this year.

Amalgamated Housing Cooperative, originally the Amalgamated Cooperative Apartment House when first opened in 1927 just south of Van Cortlandt Park, is a limited-equity cooperative apartment complex.

The complex was originally organized by the Amalgamated Clothing Workers of America, headed by Signey Hillman, as affordable housing for the working class.

It was the first cooperative housing complex in the United States founded under the limited equity rules.

Amalgamated Housing had grown from the original 300 families to over 1400 families by 2007. The newest buildings were completed in 1971.

On Dec. 22 and 23, members of the cooperative celebrated its anniversary by premiering a 12-minute film about the coops titled "An uplifting portrayal of Amalgamated Housing from yesterday to today," about how the complex has changed since it was first built.

The film was produced by Gary Axlebank, host of cable-TV's Bronx Talk, with help from Ira Merritt, Erin Olshan, and Doris Spencer.

"The idea was to illustrate this remarkable housing development and explain a little why it survived, how it survived and why it is still one of the most wonderful places in NYC to live," said Axlebank, the fourth generation of his family to live in the development. "The idea came from Ira, Erin and Doris just to commemorate the anniversary of the nation's oldest coopertive."

Long-time Amalgamated resident and photographer Merritt, also helped to depict the story of the housing complex through pictures of its residents. The portraits were also put on display during the anniversay celebration.

"Documenting the

Merritt said he wanted to concentrate on the people rather than the surroundings, which would have added another element and would have taken away from the focus on the individual. 'When pairing indi-

viduals I looked for similarities in physical attributes, clothing, or from the pose itself," Merritt said. " I was able to make 23 diptychs (46 portraits). I also made 8 individual portraits that I felt were needed to break up the diptych pattern. These images were chosen to stand alone because they were important in telling the story of the community and because there was no image to complement them."

Axlebank said it was

relatively easy to capture the

esssence of the co-op. "When you attend any one of the amalagamated events, it's plainly evident what the qualities are of Amalgamated that has led to the longevity of development," Axlebank said. "It has all the foundation within its people, which has made it last."

remembered for their enduring Top 40 Doo Wop classic "Could This Be Magic," one of the more memorable songs of 1957. Their first taste of success came with an East Coast hit "Don't Ask Me To Be Lonely" and quickly hit national recognition when "Could This Be Magic" peaked at #23 on the Pop charts. They followed this with two other great Doo Wop favorites, "Chapel of Dreams" and "Be Sure My Love."

Herb Cox and The Cleftones were originally formed in 1955 at Jamaica High School in Queens, New York as the Clefs, later becoming known as The Cleftones. In 1955, the group recorded their first single, "You Baby You," followed by "Little Girl of Mine" and "You're Driving Me Mad." They were in Alan Freed's legendary 1956 "Easter Jubilee of Stars" show at the Brooklyn Paramount. That year turn," with Gladys Knight

they recorded "Can't We Be Sweethearts" and "String Around My Heart." and in 1961 they recorded "Heart and Soul." While the group stopped touring regularly in 1963, The Cleftones reformed for a revival show in New York City in 1970. delighting fans ever since.

Maurice Williams and The Zodiacs were originally called The (Royal) Charms, changing their name to The Gladiolas in 1957 and The Excellos in 1958, before finally settling on The Zodiacs in 1959. Born in Lancaster, S.C. Maurice Williams grew up as a church singer. His first single "Little Darlin'" was covered by The Diamonds who turned it into a 1957 hit, and by Elvis Presley in 1977. Known for their trademark falsettos, the band released their pivotal song "Stav" in 1960 which Williams had written seven years before when he was only 15. They followed up with the soulful recording "May I," and then "Re-

& the Pips singing behind them. "Stay" has became one of the classic singles in the history of rock 'n roll and R&B, having been rereleased by the Hollies (1963), The Four Seasons (1964), Jackson Browne (1978), Bruce Springsteen (1979), Cyndi Lauper (2003) and in the 1987 movie "Dirty Dancing."

Barbara Harris and The Toys: Barbara Harris also started singing in her hometown churches, first in North Carolina and later in Queens, New York, where she moved at age 11. In high school, she became part of a group called The Charlettes that did background vocals for recording artists. Changing their name to The Toys, the group released "A Lover's Concerto" in 1965, a song that took a classical finger exercise from Bach, and put a Motown bass line to it, and sold over a million copies. Their second hit song "Attack" (1966) was followed by "Sealed With A Kiss" in 1968.





# Pet therapy at Schervier

Health System, Schervier Nursing Care Center has received a \$58,400 two-year grant from Amie's Place Foundation to launch a "first-of-its kind" comprehensive in-patient pet therapeutic treatment program, "Come Mend with Your Friend." How can you tell if vou are catching a cold or coming down with the flu? Both diseases cause many of the same symptoms. In general, colds tend to have a mild course, while the flu is much more severe.

**Cold Symptoms** 

A cold often starts with feeling tired, sneezing, coughing and having a runny nose. You may not have a fever or you may run a low

Our Christmas goose ო 201 arrived this morning, a new tradition in our little familv. We ordered our first one ດ່ last year when our friends JAN. at Lewis Waite Farm told us they had a dozen available from a local farmer. We had 27 to do a little research (Jov DEC. of Cooking again my best resource) and I have to say, it was quite a success. The **BRONX TIMES REPORTER** meat was juicy and flavorful and believe it or not, reminiscent of roast beef...made a delicious gravy too! Last vear I made a cornbread stuffing with the goose liver and some dried figs. This year I plan on trying a potato galette with the goose fat.

In anticipation of our Christmas Feast, I planned a few "meat less" meals to offset these rich dishes. Serving a "meatless meal", maybe even instituting "Meatless Mondays" is an idea for those of you look-**WWW.BXTIMES.COM** ing to make a New Year's Resolution or two. It's not as hard as it sounds - I've gotten quite a few vegetarian meals past my husband without him even noticing.

Use it as an opportunity to try some new recipes or

cuisines. Indian food has quite a few delicious vegetarian dishes such as yellow lentil soup, samosas and paneer. The other night, we ate a Middle Eastern meal of falafel in pita with tahini, hummus, tabouli and babaganoush. You can set up "Make Your Own Taco" а dinner with beans, avocado, roasted corn, peppers, homemade salsa and cheese. Eggplant Parmagiano, Pasta with Marinara Sauce or Risotto with Peas are also good standbys if Italian is your "Make Your Own thing. Pizza" is also a fun idea. Using meat as a "condi-

ment" is another way to cut down and is worth trying once or twice a week. A stir fry can be filled with vegetables like bok choy, baby spinach, mushrooms, corn, peppers, carrots, peas and some grated ginger so your family won't notice you only used one pork cutlet for the whole meal. A "make your own" salad is topped with a sprinkle of grilled chicken in addition to chopped hard boiled egg, chickpeas or shredded cheese for a good protein boost.

One of my mainstays

food thought

when I'm trying to serve a meal that's low on meat is "Greens Eggs and Ham Pizza". We get a lot of greens with the CSA and there are only so many times we can eat sautéed greens. Luckily, the chard, kale and spinach we get are so beautiful and fresh that I can trim them, clean them and run them through the salad spinner before putting them in dated freezer bags. You can use any kind of frozen pizza dough; I had a whole wheat one in my freezer. I also had a bag of Bright Lights Swiss Chard which I thawed out in a colander, squeezed the water out of until it was the size of baseball and chopped it. The ham can be anything you want, I've used proscuitto, pancetta, bacon...this time I used two leftover pork sausages from dinner the night before. The cheese is also whatever you have on hand, basic grated cheese

415 degrees. I top the dough with a scattering of the greens and the ham leaving four open spaces, one in each quadrant. Put it in the oven for 4 minutes and take it out. Crack one egg into each reserved space. A sprinkle of cheese and return it to the oven to finish off for 8 more minutes. Serves a family of four, but I bet if you made it with six eggs and a side of tomato soup you could stretch it even further.

There are so many good reasons to cut down on the amount of meat we eat. Besides the health benefits, there is the opportunity to spend a little bit more on fresh vegetables and fruit as well as on grass fed meat, eggs and cheese to support local farmers. Experimenting with some of these ideas and letting your kids make their taco or pizza or salad, encourages them to think about their food, try new tastes and combinations. It can also be a way to open up a conversation with your kids, one in which you might find that your teenager is much more savvy about this issue than you are. Maybe after dinner, instead of sitting down to a movie or a TV

is fine. Preheat the oven to show, try watching a documentary. "Carbon Nation", "Cafeteria Man" and "Save the Farm" could be good conversation starters are all easily accessible and not too heavy or preachy. HBO's recent series "The Weight of the Nation" is worth finding on the DVR.

> One of the best conversations I've had recently about eating meat vs. vegetarianism was with my 15 vear old niece. She was telling me about a discussion in class between some students that were vegetarians and some that were not. The argument against eating meat seemed to be mostly ethical. While the pro meat crowd admitted that had merit, they felt that humans had always eaten meat and didn't think we should have to stop. I asked her what she thought and without hesitation, she said that she loved to eat meat. But, she added. she would not eat fast food because she felt that was cruel to animals. Her dad is a hunter and eating venison is not strange for her, but I was so thrilled to see that she understood the difference between factory meat and everything else.

important the power of the purse is. Any chance you have to eat better food helps you hedge your bets against future illness and disease. Invest in good food today and you are investing in local farmers, jobs and the environment. If you think taking away the junk food will cause your family to rebel, think again. You may have their support!



The East Bronx History Forum announces that the Forum's 76th meeting on Wednesday, December 19, was strongly supported by the community. The Huntington Free Library and Reading Room at 9 Westchester Square was filled with over 60 concerned historians and community activists both young and old.

A lack of resources had gutted the military. Even the vaunted Apollo space program, which in 1969 had provided a glorious uplifting of hearts throughout the planet with the first manned landing

on the moon, was cancelled. governmental Misguided policy had prompted an inflationary cycle that was destroying the economy. "IT'S THE MOST WON-DERFUL TIME OF THE YEAR!" We almost endlessly hear these joyful words set to melodious music during this special time of year. If I might be permitted by you, friends and neighbors, a bit of liberty. I would suggest that these words be amended to say: "IT IS THE MOST WINDER-FULLY HOLY TIME OF THE YEAR!" Indeed, in addition to the celebrations of Chanukah commemorated by our Jewish friends and Christmas, the Feast of the Birth of Jesus Christ, observed by me and all of my Christian brothers and sisters of whatever Church or faith community. there are a number of other religious holydays kept by our brethren of other faiths. I mentioned in a prior column that the Sikh community had an important date on their calendar earlier this month. Other faiths with holydays this month include Muslims marking the Day of Ashura; Buddhists keeping Bodhi Day; Zoroastrians keeping

winter solstice, and the death of their Prophet, Zoroaster or Zarathushtra as he is known in the Eastern Hemisphere, on December 26th; and Wiccans and other pagan groups marking Yule ("Juul"), an ancient feast connected to the winter solstice. Connecticut confounds all comprehension and defies all explanation as much as it engenders horror and heartache. War looms, yet again, in a land called "Holy," in the very region of the world where Jesus, "the Prince of Peace," was born centuries The precipice loomago. ing below the edge of the socalled "fiscal cliff" beckons as our national leaders hold fast to what they ascribe as "principle" even as the principle of serving the public interest seems to take a second and very far back seat. The stock market tumbles even as I pen these words, perhaps portending even greater economic woes and hard times ahead. Closer to home, a past Lieutenant Governor of the State of New York along with a former Chairman of



"Peace on Earth. Good Will to All!" Say what? At this point, we might be tempted to agree with and echo old Ebenezer Scrooge and exclaim. "BAH! HUMBUG!"

I do not ascribe to this mindset. I shall explain myself in my column next week as we find ourselves underway in celebrating the Twelve Days of Christmas. I am still processing the mindless carnage of the Newtown bloodbath and so shall defer comment on it for the time being. However, in an effort to release all of the gloom and the grief of the moment at once, I regret to inform my neighbors in Community Board #12 (The Bronx) and in our beautiful Borough of the death of one of our truly great leaders, MRS. CHRISTINE HAIRSTON FOREMAN.

Folks in our local area and beyond came to know Mrs. Foreman in a variety of ways: as Treasurer and Chairwoman of the Standing Committee on Parks and Recreation of Community Board #12 (The Bronx); as Founder and President of The Seton Falls Park Preservation Coalition, Incorporated; as President of The Baychester

Quality of Life Council; as a foremost advocate for our New York City Parks; and as a generous neighbor whose door, hands, and heart were always open to others.

Christine Foreman was an always dependable partner to me. She was a faithful and tireless Community Board colleague. Most importantly, she was a genuine friend. These personal affections and connections aside, I believe that she was an authentic leader, in every sense of the word, in our area. Her endeavors on behalf of children, parks, public safety, and schools did much to enrich our local quality of life. I believe that the work and the achievements of Mrs. Foreman should not be confined to the memory of history or. worse yet, overlooked or forgotten. There is, I believe, an appropriate manner in which to honor her and to enshrine her memory in our civic heart. I propose that the children's playground in Seton Falls Park, which Christine fought to rescue from decay and from commercial development -- and most successfully so -- be christened "THE CHRISTINE HAIRSTON FOREMAN CHILDREN'S PLAYGROUND." This would constitute a Christmas gift to Community Board #12 (The Bronx) that would give joy all year round. I have written to Commissioner of the New York City Department of Parks and Recreation (N.Y.C.D.P.R.) Veronica M.

White announcing that, at its fist Stated Meeting in 2013, Mrs. Foreman's co-workers on Community Board #12 will receive, and I trust approve with unanimity and enthusiasm, a resolution calling for the dedication of the Seton Falls Park Playground in her honor. I am sending my correspondence to Commissioner White to our local newspapers as a "Letter to the Editor" that I hope they will find the generosity and the space to print. It aptly sums up why Mrs. Christine H. Foreman has so rightly earned this distinction. This correspondence, along with a letter that I wrote to Christine's Son, Clifton, can be found on the website of Community Board #12 (The Bronx) at www.bronxcb12. info.

In the meantime, my humble suggestion for the present is that when we feel that life is most difficult to bear and running amok, such is precisely the time to run towards God and into the security of His loving arms and not away from Him. Just about every portrayal of the newborn Infant Savior of Bethlehem has arms that are wide open. Maybe there is a very good reason for this -- viz., that is where God call us, that is where God wants us, and that is where we all belong.

ters Local 638 for over 40 years, and is currently its Bronx political representative. He is also a Democratic state committeeman for the 80th Assembly District who actively campaigned for local Assemblywoman Naomi Rivera, who lost in the September primary to Mark Gionai.

Although, under City Charter rules. McManus' political position wouldn't bar him from chairing the board, nominee D'Angelo expressed reservations, as did some other board members.

Borough President Ruben Diaz Jr. and Councilman Jimmy Vacca came under some fire for actively campaigning for McManus. Though legal, some complained it raised a potential conflict of interest since many developers who con-

tribute heavily to electeds' campaigns must also come before local community boards to win approval for their projects.

City Council members nominate board members for two-year terms, and borough presidents appoint them to the boards - and can choose not to re-appoint them, as Diaz recently did with 13 members of Community Board 9 in Soundview, where he has been wrangling with the district manager there.

The Board 11 vote was to fill the seat of longtime chair Dom Castore, who died in November after a lengthy battle with illness that left the board without a chair for two years. Vitaliano had filled in as acting chairman of the board, which covers Morris Park. Pelham Parkway, Van Nest, Eastchester and Allerton.

office to run the Bronx Puerto Rican Day Parade. At the Dec. 20 general board meeting, two-year member William Rivera initially put the "out of the blue" removal request to a vote.

Among other complaints, Rivera protested Gonzalez's non-binding approval of liquor licenses to eateries, along with the lack of an operable website.

The board covers Soundview, Parkchester, Castle Hill and Unionport.

But the motion fell short by just two votes, as abstentions and nayers prevailed.

Among those defeating the motion was Angel Miranda, a newly-appointed member who spoke in support of Gonzalez. "He can give great years to the community board," he told the Bronx Times.

But despite Gonzalez's latest victory, he's still under investigation from the city Department of Investigation for allegedly running the Bronx Puerto Rican Day Parade non-profit, which lost its 501(c)(3) status after not paying taxes for six years.

Chairwoman Chervl Marrow shed light on the investigation for the sake of other CB9 members during the meeting, a point Gonzalez's attorney argues violated his privacy rights.

"I can assure you," Gonzalez told The Bronx Times, "at the end of the day, the Bronx Puerto Rican Day Parade documents can prove the parade hasn't done anything wrong."

The motion to remove Gonzalez stretches back over a decade, with the latest attempt last in May after Borough President Ruben Diaz Jr. axed fifteen CB9 members, including longtime chairman Al Heyward, with Diaz failing to re-appoint them.

Miranda charged that Diaz told newly appointed members that he wanted them to dump Gonzalez.

"Diaz Jr. said they were bringing in new members because they feel the need to remove Gonzalez," said Miranda, adding that Tom Lucania, the BP's director of community boards, and General Counsel Al Rodriguez were on hand at the Borough Hall meeting.

Gonzalez has had bad blood with Diaz Jr. and his senator father Ruben Sr. for years, according to former CB9 member Ken Padilla.

Padilla was chosen for the board in 2002 and claims Diaz Sr., then Councilman for the 18th district, picked him with the stated goal of staging a coup against Gonzalez

That never came to light. Padilla soon changed sides, saying he became convinced Gonzalez was an effective leader, and the animosity against him was simply "personal and political.'

Gonzalez's fate mirrors former Community Board 7 district manager Fernando Tirado, who survived an ouster attempt at a September general board meeting. He later resigned to take a job at a Long Island charity.


Felicia Contreras, another pro-Gonzalez member, said she expects another attempt at removing Gonzalez at the next CB9 general board meeting Jan.17.

"I'm sure it's not over, but this is causing the board to be divided," she said. "We're losing sight of what we're really here for."



# BY DR. WILLIAM WOLFSON When Does A Child **Need A Dentist?**

In fact, the infant Oral Healthcare is a very important thing, even more than you probably realized. Each month, your baby reaches new milestones in their growth, including oral growth. But experts are increasingly concerned about the treatment in infants' oral health.

In most cases, your child will begin to grow teeth at any time between four and nine months. You probably know when your baby starts teething, when saliva is more copious than ever before. In addition, when the baby hand, or anything moveable and small enough is more often put in the mouth. A teething baby will chew just about anything.

The first baby teeth that appear are the two bottom front teeth followed quickly by the upper front. Use a damp cloth or 2X2 gauze to clean the gums and teeth twice a day until your child about a year. There are several brands of toothbrushes that are available for infants, all with a very soft texture brush. Choose



a baby toothbrush that has a small head, but a handle large enough to fit in your hand. As for tooth paste, select one with no fluoride in it because babies will often swallow the paste, and fluoride is not to be ingested. You can switch to fluoride paste when your child learns to spit. There are many flavored infant pastes that are ok if swallowed.

By the time your baby is one year old, it is time to schedule regular checkups with the dentist. Teeth will be counted and gifts given, but no x-rays will be taken and no treatment performed until the child is older. Again, even by taking the child to the office you are creating a habit and introducing another fun activity. If you have a lot of fear, it is a good idea to have someone else (aunt, sibling, friend) take the child. of course if you are a real fraidy-cat, never take the child when you are hav-

## ing treatment! Parental fear is highly contageous!

By age 1, you can brush baby teeth gently on the two surfaces, inside and out, twice a day. Do not forget to brush the tongue to ward off bacteria that can cause bad breath even in babies. Immediately replace a baby toothbrush after brush was beginning to look untidy.

Good habits formed early on by giving proper attention to oral health, will create a lifetime of oral health. Children are often

brushing. As a parent, you certainly should not give in to the situation. Make it a family affair, with parent and child doing it together at least twice a day. It's good for both of you! Remember, if left unchecked, the accumulation of plaque. even on baby teeth, will cause health problems in the mouth.

Finally, there is one more vitally important item you should consider, namely, baby bottles. Baby bottles, even with milk

of sugar (Lactose.) Fruit juices are even worse, as they contain both sugar (fructose) and acids (citric acid.)

A child put to bed with a bottle containing anything other than water is a cavity waiting to happen! There is even a name for the rampant decay this causes, "Nursing bottle svndrome." This is far more common than most people think because many parent's don't realize the

fussy and lazy about tooth or formula, contain loads with a bottle in the crib. We have seen toddlers with rampant decay requiring crowns and root canals because of a simple, avoidable and all too common parental mistake. Maintain your baby's teeth now, and save in the long run, when your children are grown. Its a win-win situation.
