ARRESTS SHARE UP BORD Two assemblymen, GOP leader busted

The culture of corruption that has swept the borough in previous years and previous scandals was once again reverberating across its political landscape.

The head of the Bronx Republican Party and two state assemblymen, along with other Bronx individuals were swept up in federal sting operations involving bribery charges.

Some quarters have called the plots amateur tragi-comedies, with the players risking their careers over chump change.

Among the latest major latest developments:

•The city Board of Elections is weighing asking Gov. Cuomo to delay calling a costly special election to fill the west Bronx assembly seat of Nelson Castro, snagged in a perjury indictment in 2008 who went undercover for the feds.

• John Greany picked as new Bronx GOP chair, replacing Jay Savino, swept up in a federal bribery sting.

• Morrisania/Crotona Assemblyman Eric Stevenson, declared his innocence, saying he would fight federal bribery charges. He was allegedly caught "greenhanded," shoving an envelope stuffed with \$10,000 cash into his pocket for agreeing to push a special interest bill for adult daycare operators.

•The big prize in all of the political circus, of course, was for-

Pelham Parkway residents lose sidewalk fight

It looks like it is the end of the road for residents of Pelham Parkway south.

A judge last week granted the city's motion to dismiss the law suit filed by a dozen local residents to rip up the sidewalk installed along the mall side of the parkway during major parkway re-construction.

Supreme Court Justice Howard Sherman dismissed the law suit, which claims the new sidewalk dangerously narrows the southside service road to emergency vehicles.

He dismissed the suit, however, on the grounds that is was filed after the four-month filing deadline.

The judge noted in his written decision that the petitioners "saw the actual construction commence, watched it proceed, and by April 2012, witnessed its completion. All the while. neighborhood residents collected petitions, and communicated with public officials,

and met with various officials and met with various officials and the local community board, yet petitioners still waited almost six months before commencing this proceeding."

As for installation for a similar sidewalk on the service road of Pelham Parkway north, the Department of Design and Construction said it is still unclear whether one will be installed there as well.

"The Pelham Parkway North project is still in design and plans are still being developed," said a spokesperson for DDC. "After the plans are reviewed by various agencies, the plans will be made available to the community board and we'll make a presentation. Construction is expected to begin in the summer of 2014."

"We are very surprised and disappointed in the court's decision," said Will Madonna, attorney for the 16 plaintiffs. "We will continue to weigh our legal options."

Dr. David Stevens, one of the plaintiffs and owner of an orthodontist practice on the parkway, said the community is disappointed that Judge Sherman's "narrow interpretation of the statute of limitation played into DDC's plan of stalling the public with months of misin-

formation."

"We find it rather astonishing that one city agency the judicial system - would be so rigid in judgment against the people of our community and yet another agency, DDC, can be so sloppy with their road design that five feet of lost roadway

(accessing a hospital) and ignorance of written FDNY guidelines can be callously ignored by this administration."

He called on the City Council "to establish an investigatory oversight committee to scrutinize the competency of DDC's design group."

City lawyers first filed a motion to dismiss the case in January.

Work on the five-footwide sidewalk, running along the parkway service road from White Plains Road to Jacobi Medical Center, began in January 2012.

Resident and local officials immediately became concerned, claiming the street would be too narrow, and that the city never disclosed its plan to add a sidewalk to the road.

City agencies argued the narrower road is the same width as "literally thousands" of other city streets, which fire and other emergency vehicles manage

to use. In June, the City Department of Design and Construction issued a statement saying the new sidewalks comply with city standards and would not be ripped up.

City officials argue that even with narrower streets, FDNY fire trucks can still get through safely.

But opponents, including Community Board 11 and the Uniformed Firefighters Association, disagreed arguing on top of losing already scarce corner parking spaces, the sidewalk makes getting to fires at hi-rise apartments lining the roadway just plain dangerous.

Other concerns included tower ladders now have no room to extend their stabilizers to keep them from tipping while trying to reach hi-rise floors, and firefighters can't reach their equipment when compartment doors become wedged in from cars parked on both sides of the narrowed street.

Push angle parking along MP Avenue

Community Board 11 hopes move will help local business

Community Board 11 has come up with a new angle to find parking along Morris Park's crowded main shopping strip.

It wants to install angle parking along an eightblock stretch of Morris Park Avenue, from Tenbroeck to Radcliff Avenues.

The move is high on Board 11's list of capitol budget requests for the city's new fiscal year starting July 1.

The request is supported by the Morris Park Community Association, and according to the communithy board will "add additional metered parking on the Morris Park business strip and will prevent the loss of more businesses due to the lack of parking."

MPCA president and CB11 vice chair Al D'Angelo said trying to find a spot on Morris Park Avenue on a Saturday afternoon is nearly impossible.

'You just can't find one," D'Angelo said. "Over Easter weekend, there were meter maids walking up and down the avenue galore. That is a busy time for our business people. They would've been doing good business, but people are scared to leave their cars double parked because of ticketing, and they can't find spots. Everyone wants to talk about helping out the small businesses, but they are hitting them over the head with a hammer with this parking situation."

With the limited amount of parking along the avenue, it has become difficult for small store owners to make a living, D'Angelo said.

"The angle parking would open up more spots and give people the opportunity to walk and shop the avenue," he said. "It will also make the area more appealing for stores to come into the community."

D'Angelo does, however, see some issues with the project.

"The problem I see is that it is a busy street," he said. "Cars will have to back in so they don't back out into traffic and cause a problem. They might also have to narrow the sidewalk slightly, so the parked cars don't cause a problem with the cars traveling along the street."

CB 11 district manager Jeremy Warneke said that while there is a parking problem, "I think the city is very reluctant to chop up the sidewalk, as they are on more of a pedestrian push these days to keep less cars on the road and for people to use more mass transit."

According to the city Department of Transportation, because Morris Park Avenue is a main artery that includes a bus route, angle parking would require major re-construction, including cutting back sidewalks and relocating street lights.

Board 11, which made a similar request in 2009, recently requested a preliminary cost estimate from the DOT on the project.

Sal Paljevic, president of the Morris Park Business Alliance and owner of Conte's bakery at 786 Morris Park Ave., said he is definitely in favor of angle parking.

"Of course it is going to help, it's a no brainer," Paljevic said. "This is something we've been talking about for years. People are reluctant to come down here because they get ticketed, especially on the weekend. I'm a weekendbased business. My customers come in, and double park to run in for a \$20 cake and wind up getting a \$150 ticket. I think it will open things up a lot more. It will also give the area more of a village feel. It looks better

too."

Ken Baker, co-owner of Sidestreet Sports at 1048 Morris Park Ave., said he sees how extra parking could help business owners, but also understands it would require a major overhaul.

"They would definitely have to cut the sidewalk back," Baker said. "I'm all for anything that will help the neighborhood, as long as it doesn't block the street lanes. I think it will help especially with Target and the new mall at Co-op City coming. That will be the death of mom and pop stores around here, because they have big free parking lots so people can take their time and shop."

Wait for it.

That could be the word going out to Gov. Cuomo over calling a special election to the fill the west Bronx seat of disgraced now ex-Assemblyman Nelson Castro.

Castro, swept up in citywide political bribery scandals involving Bronx Assemblyman Eric Stevenson, Bronx Republican Party Boss Jay Savino and others, resigned his seat on Monday, April 8.

The governor could call a special non-partisan election, with the vote to be held within 60 to 80 days in the 86th A.D. covering University Heights, Tremont and south Fordham

But the commissioners of the city Board of Elections met Tuesday, April 9 to discuss asking the governor to lump the Bronx vote on a single ballot in the November general election.

"The most effective way to run a special election is in fact with a general election," said Board of Elections spokeswoman Valerie Vazquez, who estimated a standalone special election would cost

the cash-strapped board an estimated \$350,000.

And in this case, it would likely overburden board staffers already at DEFCON 3 preparing for the June petitioning process and September mayoral, council and other cith office primaries.

Not sure if Bronx Democratic Party boss Carl Heastie might want to add his two cents in with the governor, since the party candidate will likely carry the most weight anyway, but a party insider noted that while it was not Carl's job to suggest it, "everybody should be interested in fiscal responsibility - saving some money here."

"It does make sense," they added, "to wait a bit and do it all in one day.

Boro parking lots go bust

A Bronx boondoggle is officially broke, leaving community groups shouting "I told you so."

Facing barren business, Bronx Parking Development Company, owning several garages and lots around Yankee Stadium, skipped its \$6.9 million interest payment due April 1, Opening Day for the Bronx Bombers.

The default, part of \$237 million in tax-exempt bond financing, is considered one of the biggest business flops in the city's history.

Now, in an attempt to recoup its losses, the city New York City Economic Development Corporation okayed BDPC to issue a Request for Proposal for the 151st Street north and south lots off River Ave. next to the Bronx Terminal Market.

Geoffrey Croft, president of NYC Park Advocates, called the move "absurd." "They should be turning it into a park," said Croft, outraged the community already lost three acres of parkland following the building of its 9,000 space network of garages and lots.

Money Troubles

The Municipal Securities Rulemaking Board's website indicated BPDC is going through "financial difficulties," making it impossible to render payment.

BPDC opened with plenty of community uproar in 2007 shortly after spending \$237.6 million of tax-exempt bonds to build its garages and lots, scattered in and around Yankee Stadium. Some of the garages replaced several baseball fields.

The 151st Street surface lots, owned by the Parks Department, were handed over by the EDC to BPDC a year later.

The allocation was

fronted by private developers working with the city's Industrial Development Agency, a branch managed by the city Economic Development Corporation.

BPDC was required to pay back the private bondholders through revenue from the lots, believing the demand to be there. The Yankees, with no stake in BPDC, exclusively uses 600 spots.

Revenue losses The firm hit a snag once Metro-North Railroad built the 153rd Street-Yankee Stadium station in 2009, drawing more out-of-towners who refused to pay the \$43 per spot.

"They didn't calculate 3,000 people would be coming to the Metro-North," said Cary Goodman, executive director of the 161st Street BID.

Revenue soon dropped by half following the station's opening. Cheaper parking at the nearby Gateway Mall also drained customers. Eventually reserved money from BPDC's coffers dried up.

"It was doomed to fail," said Bettina Damiani of Good Jobs NY, a Manhattan-based development thinktank. Damiani opposed building the lots. She said that while taxpayers are not on the hook when paying back this payment, but it "simply looks bad."

"Why would you in invest parking garages in an area with abundant transportation?" asked Damiani.

Goodman was equally thrilled to see the city renege on keeping the lots opened. "They're sort of admitting that there was some overbuilding."

An EDC spokesman referred questions to the Office of Management and Budget, handling the RFP. Calls were not returned.

For now, BPDC has hired Steven Polivy, an attorney for Akerman Senterfitt LLP to serve as bankruptcy counsel. He did not return calls on whether his client plans to pay the money back. Another payment is due Oct. 1.

Bathroom break'll have to wait

Ferry Point restroom work to begin in 2014

BY PATRICK ROCCHIO You gotta wait!

Thousands of visitors to Ferry Point Park's soccer fields and baseball diamonds summer weekends are not told that directly, but they certainly get the message when they find there are no working restrooms on the west side of the park.

Community Board 10 and Ferry Point Park Advocate group leader Dotti Poggi are calling on the Parks Department to speed up construction of a planned comfort station in that area of the park.

Thousands of people use the soccer fields on a busy weekend, said Poggi. "To me, it is just one big health hazard over there," said Poggi, noting that she and other park volunteers find used tampons, diapers – and worse – in wooded areas on the west side of the park. Plans for a new comfort station have been in the works since construction on the first of two phases of park upgrades began in November 2008.

But the situation is not likely to change this summer. A new comfort station for the west side of the Park has been slated for construction for the summer of *next* year, said Parks Department spokesman Philip Abramson.

"We anticipate beginning construction by Summer 2014," Abramson said in an e-mail. "The project required a redesign to change utility layouts and to incorporate review comments into the final design."

A new contractor also has to be hired for the comfort station, he said. This after another contractor opted out of the project in 2011.

The board also wants Parks to make needed repairs and upgrades, including removing dead trees and fixing a pot-holed road that leads under the Whitestone Bridge in the park.

"I don't know what the delay is," CB 10 district manager Kenneth Kearns said of the comfort station. "The money is dedicated and the design is done."

Parkgoers need to be responsible for themselves and remove debris from the park when they leave, said CB 10 chariman John Marano, who is also pushing to speed up work on public restroom.

"It is definitely something that is needed in Ferry Point Park," said Marano.

Meanwhile, he added, "I would like see more Port-O-Sans as a temporary fix until the construction of the permanent bathrooms."

George Street may be mapped

After nine decades, improvement may be on way for Waterbury-LaSalle street

George Street may finally become a real street. After nine decades as an

unimproved city street, the process is now underway that will put George Street fully onto the city map.

The official move will allow for capital improvement, including asphalt paving for the first time and having catch basins and a fire hydrant installed.

It also marks the end of an era for the dead-end street, located off Dudley Avenue near Mayflower Avenue.

The street is one of the last windows into what the pre-World War II Bronx looked like, when some blocks were left unpaved with just Bluestone Gravel, said local resident Paul Armstrong, a retired historical archeologist for the U.S. Army Corps. of Engineers who has lived there since 1980.

"A lot of the Bronx used

to look like this," said Armstrong. "When they first started to subdivide the colonial estates most the streets were unpaved. All of the families traditionally would chip in once a decade to pave it with Bluestone Gravel."

Up until the 1990s, most of the residents in the four houses facing the street liked things the way they were, said Armstrong.

Many nearby residents thought that it was a private street, he said, which helped it remain relatively unused, with not much parking on the street and children playing on it in the warm weather.

Families with young children no longer live on it, and cars that park on the block get ticketed, he said. Additionally, snow plows designed for use on asphalt tend to push gravel to the end of the block.

Ralph Jacco led this push to have the street put onto the city map, getting support from the Community Board 10 municipal services committee and the full board in February.

It was not the first fight to get George Street improved, but it is the first in about a decade, said Jacco.

In enlisting the support of homeowners who have frontage on the street, Jacco said he pushed a list of reasons, including protecting car undercarriages, getting a fire hydrant on the block instead of the nearest one available around the corner on Dudley Avenue, and hopefully improving property values.

"It is a quality-of-life issue," said Jacco.

Community Board 10 unanimously approved the measure to pave and im-

prove George Street, said district manager Kenneth Kearns, noting that he has written to the Borough President's office of topography to speed along the process.

Councilman Jimmy Vacca said that the way things currently stand on George Street, all the city will do is make garbage collections and fill potholes. "George Street is one of the few remaining streets in my district that is not officially dedicated to the city," said Vacca. "Now with the residents unanimously seeking action, I have been working closely with the community board and the borough president's office to have the matter quickly resolved."

This 49th Precinct cop a Sherlock

Sharp eye ends knife-wielding duo's crime spree

With some clever powers of deduction, 49th Precinct Police Officer Shamrat Akanda has been rewarded for breaking a cell phone robbery spree in Pelham Parkway.

His Watson on the case was fellow Four-Nine partner Aby Varghese.

The crime fighting team was honored with the Cop of the Month distinction at the 49th Precinct Community Council meeting April 2.

Precinct Captain Lorenzo "Andy" Johnson said the robbery pattern was allegedly pulled off by Niko Velasquez and a 15-year-old accomplice.

Johnson said a third suspect, who sold the cell phones for \$40 each, remains at large, but "We're very close to getting him." The arrested duo hit several locations around the neighborhood, donning ski masks and threatening victims with steak knives in a three-day robbery spree.

Johnson said their spree began Feb. 4 in front of the New York Institute for Special Education, grabbing cell phones from two victims.

The pair struck again later that day at Boston Rd. and Wallace Ave, robbing another victim of his smartphone.

Six incidents followed, with Johnson responding by deploying more troops towards the Pelham Parkway Houses, a known trouble spot.

"The intel we were getting was they lived or hung out in that area," said Johnson.

Akanda and Varghese, on patrol, spotted the crime

duo milling around Pelham Houses during school hours. But Akanda, a sixyear veteran, sensed some-

thing odd, mainly the direction they were headed, which wasn't toward any school.

"If they were going to go to school, they were gonna go west, but they were going east," said Akanda. "Also, they had no book bag with them."

But Akanda's suspicions were confirmed the moment the suspects put on ski masks to pounce on their next victim. Instead, they quickly wound up in handcuffs and back at the Eastchester Road stationhouse, where they later confessed to the robberies.

Johnson called the two cops' actions a "text-book" stop, question and frisk tactic, long considered controversial from mostly minority neighborhoods.

"We grabbed the right people," said Johnson.

Owen Dolen Park almost ready

Westchester Square park to open soon

a \$5 million renovation on Owen Dolen Park, and the Westchester Square Business Improvement District already has programing planned.

The Parks Department is "finishing up punch list items" on the \$5 million renovation of the park, and is planning a ribbon cutting for May, said Parks spokeswoman Tara Kiernan.

But Westchester Square BID executive director Lisa Sorin is one step ahead of the Parks Department and already has an Earth Day Celebration planned for Saturday, April 27. The event is the first of nine weekend events planned for this season, she said.

"This should really be something that is part of the launch of the BID as well as the park," said Sorin. "It is part of the revitalization of the whole area."

The Earth Day Celebration at the park should include demonstrations of composting from the New York Botanical Gardens "Get Green" program, with master composters, as well as organic arts and crafts.

"It just so happens that the BID has been focusing on putting recycling bins in the area, and we have a green team that has gone through training, and that goes out and picks up the recycling," said Sorin. "So I thought this was a perfect match up for what we are trying to promote in the area."

Also being planned for the park this summer is a Health Day @ the Square that will include Zumba and other activities from noon to 3 p.m. on Saturday, June 15.

A third event also upcoming is called "Bollywood in the Bronx," at the park from noon to 3 p.m. on Saturday

July 13.

Bollywood is an informal term that refers to the Hindi-language Indian film industry based in Mumbai, formerly known as Bombay, India.

"It is something that is culturally diverse, and something that has not been done in the Bronx," said Sorin. "Bollywood is all about music, and the elegance of dancers."

Sorin said she expects the barricades around the park to come down very soon.

The Owen Dolen Recreation Center has already been reopened.

Bronx PROFILE neighbors

BY KIRSTEN SANCHEZ Carolyn McLaughlin has dedicated her life to making other's lives better.

Now she's finally taking a well deserved rest, stepping down as the not for profit's chief executive officer since 1979, back when it was first called the Citizens Advice Bureau, helping individuals and families improve their economic and social well-being.

M c L a u g h l i n watched the organization grow from a small operation in one Bronx neighborhood to a settlement house with programs serving neighborhoods across the Bronx.

McLaughlin first came to the Bronx in the late 1960's after graduating college in her home state of Pennsylvania. She went on to receive her master's degree in social work from Columbia University, then work in welfare before joining the organization, founded in 1972.

Under her guidance, the organization expanded its services to include immigrants, the homeless, people with HIV/ AIDS, youth and working age adults moving from welfare to work.

Today, BronxWorks services make a difference in the lives of 35,000 Bronx residents annually, from preschool children to seniors.

It has 27 locations spread across a 26-square- mile area covering Bronx Community Boards 1 through 7, which McLaughlin said has made her especially proud during her 34 years at BronxWorks.

"I am proud of the high quality and range of services that we offer," she said. "I am proud we are able to meet so many needs of the people in the

community. I think the people of the Bronx deserve high quality, professional programs."

McLaughlin will say her final goodbye as executive director on June 10 at BronxWork's 40th Anniversary Celebration and fundraiser at the Landmark on the Park.

"It seems like it's time," McLaughlin said. "The city administration is going to be changing, so there is going to be a big change in city agencies, and I've already been through a number of these — at least four. There is going to be a new mayor and rather than me getting to know a new set of people, it just makes sense that somebody else will do that."

McLaughlin said she plans to continue looking for ways to volunteer and help others, spending time with her three children and five grandchildren, as well as spending time in nature and bird watching with her husband.

"I'd like to do some traveling," she said. "I have no great plans to go around the world, but some little trips. I'll probably look around for some volunteer work. I like children and senior citizens, so I'd be interested in work with that. But, I really don't know vet."

Mount Sinai Temple sold to Thessalonia Baptists

As mass transit began to flourish in the Bronx, so did the population. The overcrowded lower east side began to empty out with residents seeing the advantages of life in the suburbs. The disenfranchised of Europe were also hearing from family members newly ensconced in our borough, especially the Jews. A new way of life had beckoned and many responded.

Rabbi Max Reichler picked a grand time to establish his congregation in the Bronx circa 1911. He had recently graduated from the Hebrew Union College in Cincinnati and was ready to start his first synagogue. Four years later he married Edith Maisner of 130th Street in Harlem and by 1916 his new temple on Stebbins Avenue at 163rd Street had grown to 125 congregants.

The Sinai Congregation of the Bronx was dedicated on March 12 of that year and 1,000 people attended the grand celebration. Almost



every other household in the area would soon be Jewish and few cared that only the basement was actually ready for occupation. It held 700 people and upon completion that capacity would triple. It was a great location and served the congregation well until they finally sold the building on October 17, 1943 to the Thessalonia Baptist Church which had been located at 921 Eagle Avenue. The Baptists had taken out a \$57,000 mortgage to purchase the synagogue at 951 Stebbins Avenue and were delighted to have a home of their own after renting their current church for the prior five years, a structure that years earlier was considered their permanent home.

The church had been established in Virginia in 1892 and moved to the Fordham area of the Bronx in 1894. They finally settled at 921 Eagle Avenue in 1919 under the pastorship of Reverend L. J. Johns who would lead the congregation for the next 20 years. Then in 1934 they lost their church building, but in 1939 Minister James A. Polite was nominated for ordination and the pastorate of the church.

It was he who led the congregation in purchasing the Mount Sinai Temple on Stebbins Avenue. He would continue to lead the congregation until his death in September of 1980. He was so well loved and respected throughout the community that a portion of Stebbins Avenue was re-named for him the year after his death. The official address of the church was now 951 Reverend James A. Polite Avenue.

The church was run by the elders and sisters for the following two years until Rev. Dr. Shellie Sampson, Jr. was named pastor in May of 1982. Since then a radio ministry was established and a multimillion dollar Community Cultural Center added. Numerous new programs were inaugurated and the church is now home to a food pantry, Boy scouts, girl scouts, and numerous other important outlets for both children and adults. It's good to see that the building is still serving the people of the area in good ways after all these years.

"One child told me




they never had so much fun in their whole life," explained Brother Richard Galivin, "This party is really something that gives the children a beacon of hope that a better life is out their waiting for them."

To celebrate 25 years of service, IRI's Spring Gala, "Turning Dreams Into Reality" will be held May 2, 6:30 p.m. at the Glen Island Harbour Club in New Rochelle, New York.

ABC News personality Carolina Leid will be the evening's host and Joe Battaglia & the New York Big Band will provide music. The festivities will include an expanded cocktail hour with special entrees and a sit-down dessert, along with both a live and silent action. In celebration of reaching their quarter of a century mark, IRI will be honoring all of their former honorees who supported IRI over the last 25 years.

"Twenty five years ago, no existing agency supporting people with disabilities came forward to support people with intellectual disabilities who also had visual impairments. IRI filled that void. Today, after 25 years, IRI meets these needs as well as those of people with developmental disabilities who have other challenges including autism, mood disorders and those with multiple disabilities," says IRI Executive Director, Ray De-Natale.

IRI hopes to raise \$200,000 to continue its work, for projects such as purchasing additional and much needed vehicles to provide daily transportation for their individuals and smart home technology to improve the safety of individuals living in apartments in the community that do not require staffing 24/7. With a proposed 4 $\frac{1}{2}$ % New York State budget cut, raising money is essential to ensure that IRI will continue to provide its services and supports for some of the community's most vulnerable people. Take for example, Bill,

Take for example, Bill, who has developmental disabilities and had lived with his mom. When she had moved to a nursing home, he had to fend for himself, only to be threatened by squatters and other people living in the home. At some point he was coerced into signing some of his mother's checks and turning the money over to these people. IRI's crisis team intervened and arranged for community habilitation to assist him while living at home. During that time there was an opening in an IRI residence, he moved in. Bill was so proud to have a place of his own. "He routinely reminded people, 'This is Bill's room!' says DeNatale. When an apartment became available he wanted it. Today he lives in his own apartment, with one other person. "They live independently, but with regular supervision, but less than 24/7,"says DeNatale. Home safety technology also provides a level of safety for both roommates. The story doesn't end there. Bill is now training in IRI's Independence Cafe, learning the ropes of stocking, cleaning, marketing and delivering food to IRI customers.

"Just shy of seven months ago, Bill's life was unsafe. He was alone, feeling threatened and anxious. Today, he is flourishing in his new apartment and getting job training," says DeNatale.

IRI has helped many people like Bill. From the beginning, IRI was designed to create opportunities where none existed: opportunities for adults who are disabled to live more rewarding lives as integrated members of society, in homes designed for their special needs and with an extensive circle of support to give them access to work, volunteer, opportunities to learn, grow and dream within their communities.

For far too long, we have, as a nation. seemed unable to move out of the morass of a failing economy, a depressed morale, and a headlong retreat in the face of world threats.

It doesn't have to be this way. At the end of the 1970's, we faced a number of seemingly overwhelming challenges. Sky high inflation-up to 21%--caused our savings and buying power to evaporate before our very eyes. All the learned experts said America's role in the world was in unavoidable decline. Federal elected officials, academics, and media pundits openly discussed how to manage the transfer of international influence to the Soviet Union. We abandoned friendly governments to rebels who hated everything the West stood for. Our embassy in Iran was invaded and occupied. President Carter gave away the Panama Canal, and spoke of

malaise. But then, everything

seemed to change. Carter was defeated by Ronald Reagan, and America's new president exuded confidence. Rather than surrender our leading global position to Moscow, he promised that America would not retreat. He vowed to rebuild our hollow armed forces. He ended fiscal policies based on nothing more than wishful thinking, and almost completely destroyed inflation. He promised to protect the US homeland from Moscow's missiles, and convinced the Reds that he could accomplish this. Working with a Polish Pope and a Polish union leader who refused to bow down to his Moscowt overlords, the path to freedom from The Iron Curtain was set. Eventually, the Berlin Wall collapsed, and with it, the Soviet Union.

Today, we are in a situation similar to that of the Carter Presidency, only far



worse. After a four year experiment with sophomoric policies. America's economy is bankrupt, our workers unemployed, our international role diminished.

Obama has repeated the exact same mistake Carter made in Iran, only this time in Egypt. Our armed forces are being hollowed out. Beijing openly invades our computer systems. Our Libyan ambassador has been killed. without any response from the White House. North Korea threatens a nuclear assault, as does Iran. Russia has restarted the Cold War. Our President, our media, and our academics openly talk of China's ascendancy over the West.

It doesn't have to be this

way. The wounds and setbacks our nation has endured are self-inflicted, and they can be reversed if we have the common sense to do so.

Over the past four years, extraordinary new burdens have been placed on businesses, particularly in the form of needless regulations and unwarranted costs. These are the direct result of a White House that openly holds entrepreneurs in contempt. In a rare moment of candor, the President stated that small business owners "didn't build" their own enterprises.

His health care bill, which fails to address the very purposes for which it was first proposed, does inflict additional and unaffordable costs on employers and emplovees. His Environmental Protection Agency imposes hurdles that don't help the environment but do further

Italians say it all the time. "Buonasera!" "Good afternoon!" "Good evening!" It is about a common a greeting as one can use. However, when one is so addressed by the Pope of Rome -- and the newly elected Pope making his very first appearance before his flock and uttering his very first words to them at that -- well, this ordinary, unexceptional salutation becomes anything but run-of-the-mill. Everyday folks may speak this way. The Successors of Saint Peter, the Sovereigns of the Vatican City-State, the Supreme Pontiffs of the Universal Catholic Church usually do not. However, appearing on the loggia of the Vatican Basilica named after the first Pope, Saint Peter the Apostle, shortly after his election by the Sacred College of Cardinals on March 13 at 76 years of age as Saint Peter's 265TH Successor, these are the exact words with which Pope Francis chose to introduce himself to the world. The effect was anything but mundane. In fact, it was electrifying. The gesture immediately endeared him to the people of his new Diocese,

the See of Rome, and to both Roman Catholics and peoples of all faiths around the globe. They heralded not only a new Papacy but a new approach to "Pope-ing," if you will. This simple greeting was a forthright and self-assured indication that the new occupant of the Chair of Saint Peter had a novel concept of how to do his job. It was an instantaneous big hit with the tremendous throng hemmed in by Bernini's iconic colonnade that demarcates Saint Peter's Square.

The Papacy of Pope Francis, formerly Jorge Mario Cardinal Bergoglio, Archbishop of Buenos Aires in Argentina, is from its inception a Papacy of "firsts." Pope Francis is the first Pope to choose the name of the venerated Saint Francis of Assisi, who is the founder of the celebrated religious orders of Franciscans and who is, along with Saint Catherine of Siena, one of the two Patron Saints of Italy. He is the first Popefrom the Americas, from the Southern Hemisphere, and from Latin America. He is the first Pope to be a member of yet another renowned religious order, The Society of Jesus, or "Jesuits," as it

is more commonly known. Although a native of Argentina -- and hence, the first Pope to hail from that Nation -- he is the oldest Child of a railway worker born in Italy who married an Argentinean woman of Italian heritage. To my knowledge, Pope Francis is the first Pope to be an adept tango dancer and aficionado of the traditional Argentine music known as "milonga."

Papa Francesco in his single month as Supreme Pontiff has been fêted, both as an individual and as the spiritual leader of the world's billion and a quarter Roman Catholics, as one distinguished for his humility, his unwavering concern for the poor, and his firm commitment to dialogue as a means of building bridges between diverse peoples of all nationalities, races, backgrounds, beliefs, faiths, opinions, and political persuasions. Since his elevation to the Papacy, he has

displayed a much simpler and less formal approach to the Petrine Office, indicated by, among other actions, his determination to reside in Vatican City's guesthouse, the Domus Sanctae Marthae, or Casa Santa Marta (in English, "SaintMartha's House"), rather than in the Apostolic Palace adorned with an endless number of artistic masterpieces and utilized by his Papal Predecessors since the

vear 1903.

Indeed, Pope Francis has annunciated a "no-frills" approach to Papal protocol. For example, on the night of his election after his introduction to the world, His Holiness took the bus back to the Casa Santa Marta with the other members of the College of Cardinals, rather than driving in the Pope's official limousine. Prior to his emergence on the loggia of the Saint Peter's Basilica, instead of accepting the congratulations of his Cardinals seated on the Papal throne, the new Pope greeted each of them while standing up, an immediate signal of his shifting approach to Papal formalities at the Vatican. He chose -- and continues -- to wear only a white casnized as completely fluent in Italian Although many will hold out and agitate for change in the official tenets of Roman Catholicism, I would not expect any from the new Successor of Saint Peter. His approach to practicing Catholicism may prove to be exciting and novel in some fashion, but his adherence to the contents of the Deposit of Faith, I predict, will be unwavering. Watch, however, for an intense concern for the plight of the poor, the needy, the infirm, the marginalized, and the oppressed. Like his namesake, Saint Francis of Assisi, he will challenge those who have much on behalf of those who have little or nothing. On one occasion, speaking of affluent societies such as ours in the United

States, he inquired how some people could spend so much money on cosmetics and pet food while so many of their fellow citizens had could not afford even basic clothing, food, and housing. As time goes on, there

will be a great deal to be said of Pope Francis. He inaugurates his universal ministry with our prayers and our hopes accompanying him.

Kickoff time for the May 25 match between English Premier League teams Chelsea FC and Manchester City FC is scheduled for 5:30 p.m. Chelsea is the reigning champion of Europe, having won their first Champions League title last May by defeating Bayern Munich on penalty kicks. Since its founding in 1905, the London-based team has won four domestic league titles (1954-55, 2004-05, 2005-06 and 2009-10) and seven FA Cups (1970, '97, 2000, '07, '09, '10, '12). Manchester City clinched the 2011-12 EPL title in dramatic fashion on the last day of the season with two goals in extra-time. The club has won three domestic league titles (also 1936-37 and '67-68), five FA cups (1904, '34, '56, '69, 2011) and one European Cup Winners' Cup (1970) since its founding in 1894.

Kickoff time for the June 11 friendly match between Spain and Ireland is 8:00 p.m. Spain is ranked number 1 in the world by FIFA, having won the most recent World Cup in 2010 and each of the last two European Championships in 2008 and 2012. Ireland, led by manager Giovanni Trapattoni, participated in Euro 2012 and narrowly missed qualification for the 2010 World Cup.

Tickets for both exhibition matches will go on sale to the general public as a bundle package including both games beginning on Wednesday, April 10 at 10:00 a.m. at www. vankees.com/soccer. FBI sting nets GOP leader Savino; Stevenson, Castro charged

Democratic Senate Majority Leader Malcolm Smith, allegedly bribing Savino to add his name to the GOP line for mayor. State Senator Jeff Klein, who brought Smith into his Independent Democratic Conference, stripped Smith of committee positions.

New GOP Boss

After accepting Savino's resignation, the Bronx County Republican Committee unanimously voted to elect John Greaney as new County Chair.

Savino, who was arrested April 2 at his home in Congers, Rockland County, was charged with accepting \$40,000 in bribes to help Democrat Smith win a line on the Republican ballot for mayor.

Greaney, who previously worked for Borough President Freddie Ferrer as a special advisor, also held a number of public service posts, and previously worked at the Bronx Board of Elections.

Stevenson daycare fix Assemblyman Eric Stevenson was arrested by the feds for accepting \$20,000 in bribes to help fast track the opening of two social adult centers in the Bronx – one on Westchester Ave. in Stevenson's district and another on Jerome Avenue near ex-Assemblyman Nelson Castro's district.

He was also accused of introducing a bill putting a moratorium on other social centers as a way to create a "local economy." Throughout 2012, Stevenson met several times with Igor Belyanksy, his brother Rostislav, Igor Tsimerman and David Binman and Sigfredo Gonzalez, a minor Bronx wannabe political figure and executive director of the New Age Social Adult Center.

Gonzalez and former Assemblyman Nelson Castro secretly recorded the alleged conspiracy conversations. Video surveillance from the feds showed Stevenson stuffing a \$10,000 cash bribe inside his pocket outside Jake's Steakhouse in Riverdale.

Stevenson has vowed to fight the charges and refused to resign, although political experts say he's now virtually useless in Albany.

Castro convertible

Castro, the first Dominican to represent the Bronx in the State Assembly, was formally charged with perjury during his 2008 run for the 86th Assembly District, and quickly converted into an undercover snitch for the U.S. Attorney and the FBI.

The disgraced pol resigned Monday, April 8 as part of a deal to save his own skin that involved becoming a federal informant in 2009. On Wednesday, he pleaded not guilty in Bronx state Supreme Court to three counts of perjury. His attorney, Michael Farkas, called the proceedings a formality. Castro is next due back in court Sept. 18.

The minor charges allege Castro lied during a city Board of Elections hearing over whether he knew nine family members were registered to vote out of his one-bedroom apartment during his run for office in 2008. If convicted, he faces upwards to 7 years in prison, although that is unlikely because of his cooperation in the sting operation.

Gov. Cuomo could call for a special non-partisan election to fill Castro's seat in the 86th A.D. covering University Heights, Tremont and south Fordham – or could, as some have suggested, fold the special election into the general mayoral and City Council election in November.

Residents fighting city pushing tree plantings outside homes

in front of his home, and does not need another one to take care of.

He isn't the alone.

Councilman Jimmy Vacca said Sussman is one of a dozen residents in his east Bronx district slated to get a tree from the city they don't want.

Vacca said he was enraged when he learned that residents were having trees forced on them.

Not that he doesn't support a city push to go green with the air cleansing trees, but because homeowners have to wind up paying the bills when the tree roots crack their sidewalks or break their water and sewer pipes below.

On top of that, the city simply plants them without giving the homeowners any notice.

He said he was also upset because the city is prioritizing planting more trees instead of removing dead ones, pruning others, or removing stumps and fixing sidewalks that they have ruined.

Vacca recently contacted

the Parks Department and asked them to hold off on planting any more trees for now.

"I have insisted that the Parks Department re-assess their plan to plant trees at these locations where homeowners have objected," said Vacca.

"Our city has so many empty tree pits, dead trees, and stumps that should be removed and replaced with new trees. If homeowners choose not to have a tree planted in front of their home, that should be their choice," said the councilman. "If the city wants to plant more trees, which is a goal I support, we do not need to force homeowners to take one on their property when they do not want one."

Sussman, a retired senior said he was blindsided when he found out he was slotted to have a tree planted in front of his Colden Avenue home as part of the citywide "MillionTreesNYC" restoration project.

The public-private program is a Parks Department initiative to plant and care for one million new trees across the City's five boroughs over the next decade.

"We all noticed the markings on the sidewalk but we didn't know what they were for," Sussman said. "We thought they were from ConEd. Then I saw a guy with a drill outside my house and I went to ask him what he was doing."

Sussman said the man turned out to be a Parks engineer, who handed him a letter informing him the city would be planting a tree in front of his home as part of the project.

If the tree is planted, it would cut the width of the sidewalk in front of Sussman's home in half, leaving only a narrow path for people to walk by, and very little room to get in and out of a car parked on the street — a problem for Sussman, who needs a walker to get around.

"We already have a tree and a garden in the front of our house," he said. "We don't need another tree, and then we're going to have to be responsible for watering it."

Sussman said he is also concerned that the roots from the tree will damage the side walk he recently repaired. He also worries that tree bed will become a spot for people to throw their garbage and cigarette butts, as well as a stop for their dogs to relieve themselves.

Community Board 11 district manager Jeremy Warneke said he contacted the Parks Department on Sussman's behalf, but was told there was nothing that could be done — he would be getting a tree whether he liked it or not.

"There is nothing really we can do about it," Warneke said.

A Parks spokesperson said a trained arborist personally evaluates every proposed planting site and chooses an appropriate species of tree.

"New street trees are planted far enough apart to ensure long term health and longevity, and are 2.5 inches in diameter, providing room for passengers to get in and out of vehicles," she said.

"While we welcome any request for trees to be planted, we do not accept declinations."

She noted that since the program began in 2007, Parks has begun new planting techniques to make trees "less likely to uproot sidewalks."

"Nobody ever asked me

if I wanted this," Sussman said. "It is just going to make things difficult for me, trying to get in and out of vehicles and walking in front of my home. On top of that I am responsible for watering it, and taking care of it." But a Parks spokeswoman insisted the agency "maintains and cares for all street trees."

Tray-based tooth whitening systems, purchased either over-the-counter or from a dentist, involve filling a mouth guard-like tray with a gel whitening solution -- which contains a peroxide-bleaching agent. The tray is worn for a period of time, generally from a couple of hours a day to every day during the night for up to four weeks and even longer (depending on the degree of discoloration and desired level of whitening).

In-Office Whitening

In-office bleaching provides the quickest way to whiten teeth. With in-office bleaching, the whitening product is applied directly to the teeth. These products can be used in combination with heat, a special light, and/or a laser. Results are seen in only one, 30- to 60-minute treatment. But to achieve dramatic results, several appointments are usually needed. However, with inoffice bleaching, dramatic results can be seen after the first treatment. This type of whitening is also the most expensive technique.

How Long Do Teeth Whitening Effects Last?

Teeth whitening is not permanent. People who expose their teeth to foods and beverages that cause staining may see the whiteness start to fade in as little as one month. Those who avoid foods and beverages that stain may be able to wait one year or longer before another whitening treatment or touch-up is needed.

The degree of whiteness will vary from individual to individual depending on the condition of the teeth, the level of staining, and the type of bleaching system used.

At-Home Teeth Whitening vs. Dentist-Supervised Teeth Whitening

There are differences between whitening teeth at home and having them bleached in a dentist's office, including:


Strength of bleaching agent. Over-the-counter products and dentist-supervised at-home products usually contain a lower strength bleaching agent, with about a 10% to 22% carbamide peroxide content, which is equivalent to about 3% hydrogen peroxide. In-office, professionally applied tooth whitening products contain hydrogen peroxide in concentrations ranging from 15% to 43%.

Mouthpiece trays. With dentist-supervised athome bleaching products, your dentist will take an impression of your teeth and make a mouthpiece trav that is customized to exactly fit your teeth. This customization allows for maximum contact between the whitening gel, which is applied to the mouthpiece tray, and the teeth. A custom-made trav also minimizes the gel's contact with gum tissue. Over-the-counter whitening products also contain a mouthpiece tray, but the "one-size-fits-all" approach means that the fit will not be exact. Ill-fitting trays can irritate the gum and soft tissue by allowing more bleaching gel to seep onto these tissues. With in-office procedures, the bleaching agent is applied directly to the teeth.

Additional protective measures. In the office setting, your dentist will apply either a gel to the gum tissue or use a rubber shield (which slides over the teeth) prior to treatment to protect your gums and oral cavities from the effects of the bleaching. Over-the-counter products don't provide these extra protective measures.

Costs. Over-the-counter bleaching systems are the least expensive option, with in-office whitening being the costliest.

Supervised vs. unsupervised process. Dentist-supervised at-home bleaching and in-office treatments offer additional benefits compared with over-the-counter procedures. First, your dentist can perform an oral exam and consider your complete medical history. which can be helpful in determining if bleaching is an appropriate course of treatment based on the type and extent of stains, and the number and location of restorations. Your

dentist can then better match the type of stain with the best treatment, if appropriate, to lighten

those stains. With dentistsupervised bleaching procedures, your dentist will likely want to see you a couple of times to ensure you are following directions, to make sure the customized trav is fitting properly, to inspect the gums for signs of irritation, and to generally check on how the teeth whitening process is proceeding. With over-the-counter bleaching products, you are on your own.

Who Should Not Un-

dergo Teeth Whitening?

Whitening is not recommended or will be less successful in the following circumstances:

Age and pregnancy issues. Bleaching is not recommended in children under the age of 16. This is because the pulp chamber, or nerve of the tooth, is enlarged until this age. Teeth whitening under this condition could irritate the pulp or cause it to become sensitive. Teeth whitening is also not recommended in pregnant or lactating women.

Sensitive teeth and allergies. Individuals with sensitive teeth and gums, receding gums, and/or defective restorations should consult with their dentist prior to using a tooth-whitening system. Anyone allergic to peroxide (the whitening agent) should not use a bleaching product.
