GROUP HOME OPOSED

Van Nest site proposed for disabled women

BY JAIME WILLIAMS

A service group has set its sights on a Van Nest house as the new home of women with developmental disabilities, but first it must face a resistant community board.

Unique People Services, which provides housing and support for individuals living with AIDS, mental illness, or developmental disabilities, would like to turn a two-family house at 620 Baker Street into a group home for four young women in their 20s who have aged out of their residential programs.

The organization will present the idea to Community Board 11 at a public hearing on July 27. The plan was initially introduced to the board at the June meeting by Sonji Phillips, director of developmental disability services.

The group home would be an Individual Residential Alterna-

tive for the four women, who all have mild-to-moderate developmental disabilities, Phillips said. It would be staffed around the clock, and the women, who either work or attend day habilitation centers, have no history of dangerous behavior, she said, adding the home would be well cared for and the women will receive lots of services, Phillips said she sees no negative impact on the neighborhood.

"They'll be receiving all the support the need to participate in the community," she said.

The organization is still entertaining other housing options for the women, but Phillips said the Van Nest house is the top choice because it has a great layout and meets state requirements.

Phillips said she received a negative response when she first presented the plan to the com *Continued on Page 59*

Bronx River Art Ctr. building renovations

The Bronx River Art Center broke ground on its building renovation on Thurs. June 26.

The ceremony, well attended by elected officials and community leaders, marked the start of a \$10-million project that has been years in the making.

The BRAC executive director said she's been imagining the

renovations to the East Tremont building since she took the job in 1999, but it took a long time to get the plans and funding in place to start the project.

The center vacated the building in 2010, Gail Nathan said, and in the interim, it has continued to offer all its educational and arts programing at space provided by other organizations.

When renovated, the center will have new artist work spaces that will be offered at below market value, in addition to a coworking space for creative or environmental entrepreneurs, and a multipurpose room for performance art or community rental, Nathan said.

Those spaces will help bring in some income for the center to help reduce the reliance on grants and government, she added.

"So we're more self sufficient," she said. The center's core mission is

still education, and the youth programing that touches upon all types of art will be enhanced by these other offerings.

"Our education is expanding and integrating into all these functions," Nathan said. "So the students learn there are career prospects through the arts."

The educational mission also extends into environmentalism, which is also core pillar of the organization, and the center has an educational garden where kids can learn about local plants, wildlife, and environmental restoration.

"They learn about environmental issues relevant to the Bronx River," said Nathan.

The building itself is envi-

ronmentally friendly, and will include a green roof, along with more energy efficient systems.

The plans for the building have been designated with LEED Silver certification, deputy commissioner for Public Buildings David Resnick at the ground breaking.

"This will be a model of environmentally sustainable design," he said.

The building's new design is also visually unique, said Nathan, and it uses "super-graphics" to transform the existing structure's exterior into something striking. It was important for the design to have a bold street presence to make people aware of the center and draw them in, said Resnick.

"People will know it's here," he said. "The outreach is performed physically by the building."

The center has a commitment to serving and helping to revitalize the community, Nathan said, and she feels they increase awareness of how important the arts are in terms of quality of life.

"Art makes everybody's life better," she said. "In terms of experiencing it, participating in it, and learning from it."

The annual New York Salutes America Fireworks Extravaganza was a beautiful display of fireworks by Grucci and community unity at Orchard Beach on Fri. June 27.

The event was hosted by Borough President Ruben Diaz Jr. and state Senator Jeff Klein. They were led onto the stage in front of the Orchard Beach Pavilion before the start of the fireworks by a group of bagpipers, and were joined by many of the borough's elected officials.

Diaz took the opportunity to note that this year also marks the celebration of the 100th anniversary of the Bronx as a county, and asked the crowd to give a round of applause to the attendee veterans who had made sacrifices to uphold American freedoms. Klein

paid tribute to the war he-

roes. "This is a terrific event and I am so glad year after year many more people come because this is about the Bronx," said Klein. "This is our way of kicking

off the Fourth of July celebration and I think everyone understands that it is a time to celebrate with fami-

lies, but it is also a time to remember our veterans." Klein added: "The freedoms we enjoy — really the the life and limbs of veterans — was the coinage used to purchase that freedom."

Diaz said the event celebrated the borough as "one big Bronx happy family" of great multiculturalism.

"Everybody talks about diversity, but the Bronx is diversity, and we have been living that for a long time," said Klein.

The pair of politicians was joined by elected and appointed officials, including state Sen. Ruben Diaz Sr., Sen. Ruth Hassell-Thompson, Assemblyman and Bronx Democratic County Committee Chairman Carl Heastie, and Assemblymen Mark Gjonaj, Marcos Crespo. and Michael Benedetto. and Deputy Borough President Aurelia Greene, Councilwoman Vanessa Gibson. 80th Assembly District State Committeeman Joseph Mc-Manus, and Thomas Messina, an aide to Congressman Joseph Crowley.

Officers Lee and Paterno honored

He snagged a suspect who may have swiped a woman's purse, and now he's grabbed the honor of top cop.

Officer Tai Lee of the 49th Precinct received the "Cop of the Month" award from the precinct's community council for his savvy handling of an April pocketbook robbery.

Nabbed a snagger

The officer responded to the purse grab on April 6 at around 9 pm on E. Gun Hill Road by quickly canvassing the area with the victim, before tracking down the suspect, according to a police report.

Officer Lee apprehended the perp, who was carrying marijuana and a knife.

Lee received high marks from his boss.

"It's that bravery, really acting quickly not know-

ing whether this guy was armed or not, which is why he earned this honor," said Four-Nine commanding officer Captain Tim McCormack at the council's June meeting.

Steady vet honored

Lee was not the only NYPD officer to get some community love.

Officer Bill Paterno was also honored, as "Cop of the Month" for May.

The six-year force veteran made 12 arrests in that month, collaring alleged lawbreakers for a variety of offenses.

"It's those noise complaints that you call up, and then they refuse to abide by the noise ordinances, or that guy that's driving down Pelham Parkway recklessly with no registration and no insurance, he's making those collars,"

said Captain McCormack, as Paterno received his award.

McCormack said that Paterno earned the honor

through his consistent efforts to combat crime, more so than through one specific moment of police work.

Ride to the Bronx Y!

You can ride to the Y on two wheels now instead of four.

Folks at the Bronx YMCA on Castle Hill Avenue are feeling wheel happy after landing the borough's first city "bike corrals" – rows of circular bike parking racks installed curbside.

The Department of Transportation replaced two of the YMCA's spaces for cars with the series of circular bike racks Monday, June 16, after the Y requested the cycle shelters last year.

Healthy ride

Facility staff said the racks, which can store eight bikes, give cyclists a convenient place to store their ride — and might convince others to take up a healthier lifestyle.

"Not only does it look great, it serves our initiative of healthy living," said Sharlene Brown, the Bronx Y's executive director.

The city has already put in 39 of the "corrals" in Brooklyn, Manhattan, and Queens. But the Y's bike corral is the first to be installed in the Bronx. Corrals are different from bike racks on the sidewalk, since they include plant beds and are installed on the street.

Organizations can apply for the bike racks on DOT's website, but must promise to be responsible for maintaining upkeep, including snow and trash removal.

Love for the bikers

The Y's application was inspired by bike-riding members of the staff, who

insisted that they have a designated spot to lock up their cycles.

Yet bikers visiting the complex before could only tie their two-wheelers to a nearby tree or pole.

"We had people on staff who ride every day," said Brown, the Y's executive director. "In the morning, it can get crowded."

Brown said the Bronx

Y's embrace of the bike is only beginning. The facility has a bigger bike plan in the works, she said, including teaming up with cyclist group Bike New York to give riding lessons.

Rave rider reviews

Meanwhile, locals are still getting used to the new Y parking option. But some positive reviews have already started streaming in. "I think it's pretty great," said Jerry Brown, a Soundview resident who visits the Y many times a week.

Brown recently drove over to the Y, but said that he'd consider cruising by on his bike next time.

"It's nice, it's summer, and it's good for you," he said. "Why not?"

East Bronx Finest start Twitter account

Cops at the Four-Five made history when the East Bronx precinct used its first hashtag on June 27 at 7:57 pm.

"Fireworks @OrchardBeach. With Boro Pres Ruben Diaz #orchardbeach" tweeted — yes, tweeted — the 45th Precinct from its new Twitter account, @NYPD-45Pct, which went live on June 26.

The tweet was accompanied by a blurry photo of the precinct's commanding officer, Captain James McGeown, posing with Borough President Diaz, with Eastchester Bay in the background.

#workinprogress

The Four-Five — which covers Pelham Bay, Westchester Square, Throggs Neck and City Island is one of three Bronx police precincts to have embraced social media's newest darling and create a Twitter account. Locals who "follow" the precinct on Twitter will now get updates on community crime trends and information on upcoming police-sponsored events and workshops. At least that's the plan for now.

The precinct's top cop admits that his Twitter game is a work in progress.

"I would say I'm a novice, but I'm learning," said McGeown, adding that so far he has been the one crafting the tweets. "I think it's coming along."

McGeown said he underwent a Twitter boot camp over the last month with other commanding officers. All precincts in the city will eventually have Twitter accounts, as mandated by Police Commissioner Bill Bratton, who himself joined the social media site in January.

The department's goal is to build a more transparent and friendly relationship with the public.

"Basically, it's to show differ-

ent things that police does other than lock people up," said Anne Marie Morrison, community affairs officer at the Four-Five.

#plzfollowus!

The Precinct sent a mass email to friends and local leaders announcing the newly created Twitter account on June 26. Since then, the precinct has gained 165 followers, as of press time. The 44th Precinct in the South Bronx led all Bronx precincts with 175 followers, while the 52nd Precinct in the West Bronx had 125 followers.

"We hope it will build on itself," said McGeown. "The benefit of Twitter, apparently, is that your followers get it, and then they share it to their followers."

The chief said he never imagined that he would be able to reach hundreds of locals with just a few clicks on his smartphone when he joined the NYPD nearly three decades ago. Back then, cops got

the word out solely by posting fliers and attending local meetings — old-school methods that McGeown said will continue even with the social media push. "People still like that personal touch, and we'll still be at community meetings," said the Captain. "But this just reaches so many more people."

Patriot wants Stars & Stripes at memorial

One Bronx patriot wants to see red, white and blue flying above the Van Nest Memorial — and that's just for starters.

Richard Vitacco, president of the East Bronx History Forum, plans to push for a flagpole at the sight of the monument to honor war heroes who made the supreme sacrifice for their nation.

"It's an 88-year-old memorial, and there's no flagpole there to honor the deceased servicemen," he said.

Vitacco lives in nearby Morris Park, but he feels strongly about the historical and cultural importance of the memorial just south of Van Nest Park, at the intersection of White Plains and Unionport roads, because his mother's family is from Van Nest.

"It's a gathering place for the community," he said. "Especially on days

like Veterans Day or Memorial Day."

There was originally a flagpole inside the gated memorial, but there hasn't been one at the site for at least 35 years, said Vitacco who also wants a greenstreet, an enclosed section of grasses and plants, in the cement triangle facing the memorial.

He pointed to the renovation of Van Nest Park just north of the monument, and said that the next step is to address the memorial's concrete surroundings.

"The park's being done

over, why not beautify the slab south of the memorial?" he asked.

The plan, although still in the preliminary stages, is plausible, said Vitacco, the caveat being a matter of funding. But he points to other memorials and squares in the area that have a flagpole and a greenstreet, including Keane Square in Pelham Bay.

The city budget is set for this year, but Vitacco has high hopes the money for his project may be included in next summer's allotment. But he knows bringing the idea to life will take time.

"Things don't happen overnight," he said.

Vitacco has received support from Community Board 11. He presented his plan to the board's parks committee, which approved it and passed it to the full board, which voted unanimously in support of the proposal at its June meeting.

There should be a flagpole at the memorial, especially because of the ceremonies that are held there, said parks committee chair Joanne Rubino, who added that there are still many details for Vitacco to work out, but the committee liked his proposal.

"We'll do whatever we can to support it, if it's viable," she said.

The idea of a greenstreet replacing some of the concrete is also a positive for Rubino.

"Anything that would beautify the area, we support," she said.

27 to cut the ribbon for the new sprinkler, which was funded by the mayor's office.

Time for a swim

The new Parks head honcho also extolled the virtues of getting the family together for a dip.

"City pools provide free summer fun for the entire family," crowed Silver, a native of Brooklyn. "Swimming is a great form of recreation, but for many it is also a survival skill, a competitive

sport, and a lifetime passport to health and fitness."

Crotona Park's new sprinkler is located at the site of its former diving pool, which had sat dormant for three decades. The spray shower is designed after the sun, with yellow rays etched into the pavement.

The sprinkler also has different settings and varieties of water blasts, allowing young revelers to choose their own spray experience.

Like all of the city's parks, Crotona's new sprinkler is open to the public seven days a week, from 11 am to 3 pm, and from 4 pm to 7 pm, until it closes for the season on Labor Day, Sept. 1.

Visitors must wear swimsuits in order to enter a public pool, and only white shirts are allowed on the deck. Food, glass bottles, newspapers, and electronic devices are banned from public pools. The city also suggests bringing a combination lock to secure your belongings during your dip.

Skip hot, heavy meals: Opt for cooler fare, such as cold sandwiches, fruit, and salads to keep your body temperature cooler.

Plan outdoor activities during cooler hours: If you must spend time outdoors, do so early in the morning or in the evening when the temperatures are bound to be lower.

Indulge in a little cooling off: Take a dip in a neighborhood pool or treat yourself to an ice cream sundae to stay cool.

Financial pointers for older, unmarried couples

4-10,2014 oving in together is something typically associated with young couples, but more and more unmarried men and women over the age of 50 are choosing to cohabitate. According to an analysis of 2012 U.S. Census data conducted by the Performance Reference Bureau, roughly 10 percent of the 15.3 million oppositesex unmarried cohabiting partners in the United States are between the ages of 55 and 64, while 15 percent are between the ages of 45 and 54.

The incentives for older, unmarried couples to cohabitate are similar to those for younger ones, but older couples should heed a few financial pointers before deciding to move in together.

Iron out the financial details

Before moving in to-

gether, older couples should document their finances and how household expenses — including a mortgage, if one exists — will be paid. Decisions regarding who will receive the tax breaks you might be eligible for when paying a mortgage should also be considered. Documenting your financial situation can protect your assets, should you break up. If these arrangements are not documented, unmarried couples who break up could find themselves in a contentious financial battle not unlike couples going through a divorce.

Maintain financial independence

Older, unmarried men and women who choose to cohabitate with their partners should still maintain some financial independence after moving in together. A joint checking



or savings account might work down the road, but initially keep these accounts separate to avoid any disputes. Keep paying your own bills, including car payments and credit cards, at the onset as well.

Update documents and policies

Upon your death, a partner with whom you cohabitate does not have the same legal rights of inheritance as would a spouse. As a result, it's important for unmarried individuals who live with their partners to update their wills, especially if they have been cohabitating for an extended period of time and want their partner to be taken care of in case of their death. In addition to updating information regarding beneficiaries, older men and women might want to update certain information regarding their health, like who should take legal responsibility for medical decisions should one partner become incapacitated.

In addition to updating your will, update any existing life insurance policies and retirement benefits to include your partner if you so desire.

Discuss changes with your family

Just about everyone you speak with will agree that no recent Bronx historian can produce the quality and originality of John McNamara's columns. He began writing

them in 1956 and continued doing so for the next 44 years. He set the standard for those of us who followed by looking into areas where no one else thought to venture and sharing his findings with his readers, many of whom would follow his stories week in and week out. His column was often the first thing people read upon opening their paper.

It wasn't just Bronx history that was captured by his pen, but he also set about recording his vast and varied trips around the globe. That in itself sets him apart from other journalists as many of his experiences can never be re-lived.

His chronicles on the Great Depression have captured that historic epic as he lived it. The same can be

said about his "riding the daughter, Betty, then folrails" as a hobo or traveling aboard tramp steamers with no fixed schedule. Some things do change and some experiences simply cannot be repeated.

The Hutchinson River Corridor Study: Last week I had a few comments concerning this project. Well, since last thursday when this paper hit the stands I have received quite a bit of feed back from this community. There is a substantial demand for more up to date information and that we will get to you as it becomes available.

There has also been a lot of frustration expressed over "why wasn't this done 10 years ago". Well, I can't speak for our government agencies but I do know that the Metro Center had and has been seeking a solution to there traffic problems for years.

And as for our community civic minded members, I can't say any better than John Cummings. Here are his words:

I sat in on meetings over a decade ago when this project was originally proposed. The Hutch center was supposed to house a world class medical research facility which was to be connected to Boston, New Haven, Baltimore, and Washington, DC via an Amtrak stop at the foot of Morris Park Avenue. Metro North was to be given right of way at this stop and at Co-Op City and Parkchester. Access and egress ramps were to be built for the Hutchinson River Parkway that were to provide a direct connection so as not to create congestion locally, particularly in light of the fact that there are multiple emergency rooms in the immediate vicinity. The



plans to be proactive were there. They were just ignored by the Government. It is now up to all of us!

Senator Jeff Klein and Borough President Rubin Diaz have been pushing hard for the Metro North stops to be built. Since their original announcement over a vear ago the schuled time line for this project has slipped. The project as I understand is not yet a budgeted item in the states capital budget. And most annoving of all is that there exist some Long Island Representatives in the State Legislature who believe that Long Island has a birth right to the train slots at Penn Station. A few months ago political noise was made that Long Island might not want to give up the Penn Station slots.

What this means is that if the Penn Station slots are not made available to Metro North then the expansion of service into the East Bronx can't happen.

Well, when the time is right, we in the Bronx have to make ourselves be heard. We must be heard very loudly and very clearly. Not backing all of our elected officials on this matter is really not an option for our communities.

Back to the Hutchinson River Study. For now we are in a wait and see mode. The New York City Department of City Planning has stated that their finial report on this project with recommendations to address our communities request will be ready and made public by the end of July. Until then I suggest that we all stay informed and this time lets not let local government off the hook.

It is time the we voting citizens be recognized as being the share holders of government and not the client's of government. For Bloomberg administration holdovers to think that we citizens are an unavoidable evil is a grave mistake.

We can only be treated as client/customers of their services if we let it happen. All government exist as the saying going "for the people "

As the shareholders it is about time that we insist that all government agencies refocus and start delivering the services that they are being paid to do.

Have you ever noticed just how many people are on blood pressure medication? I thought that my noticing it was due to the fact that I'm getting older until I read an article by David Brownstein, MD.

Dr. Brownstein tells us that approximately 75 million people in the United States over the age of 20 have high blood pressure. After age 55, American's have a 90% chance of developing it.

Conventional doctors rarely look for the cause,

they just label it "essential hypertension", meaning there is no known cause. Dr. Brownstein has discovered that there is a clear and direct relationship between low magnesium levels and hypertension.

He has also discovered that even if tests show normal magnesium levels, the vast majority of patients will significantly improve by supplementing with magnesium.

Magnesium helps to relax the blood vessels, resulting in less resistance to blood flow, which helps



to lower blood pressure. Magnesium also helps to reduce nerve and muscle excitability. In addition, the mineral helps to optimize circulating levels of the hormones norepinephrine and serotonin and levels of nitric oxide, which is a powerful vasodilator, opening blood vessels for better blood flow.

Most people do not realize that most conventional blood pressure medicines work to reduce blood pressure in the same way as magnesium. However, all of those drugs are associ-

side effects. Diarrhea, the only adverse side effect of magnesium, is easily solved by lowering the dose.

ated with severe adverse

Studies have shown that 625 mgs per day caused a significant reduction in blood pressure. The effect of magnesium was similar to the best anti-hypertensive medication.

Dr. Brownstein's initial work up for his patients with hypertension always include testing for magnesium levels and a trial of oral magnesium before going on to medications. Diuretics, the most commonly prescribed anti-hypertension drug, accelerate magnesium loss leading to a deficiency.

If you are diagnosed with high blood pressure, you should ask your doctor to check your blood pressure on both arms. Often, the second or third read-

ing is lower than the first and this is thought to be the more accurate reading.

You should also take your blood pressure at home, when you are relaxed, and keep record of it over several weeks.

There are many reasons that blood pressure rises and you want to be sure that yours is consistently high before you take any medications.

They also are too quick to prescribe medication upon the first visit showing hypertension.

The heartfelt comments of critics of certain issues frequently present an opportunity to respond to sincerely felt but incorrect concerns.

Recently, in response to a column on hydrofracking, a local activist who has been a true asset to our community on other matters presented a letter with six objections to hydrofracking, a process which has extraordinarily enriched many states, created vast employment opportunities, helped the environment by providing a clean source of fuel, and given the United States a desperately needed boost towards energy independence. COMACTA is pleased to address those worries.

First, the writer describes a threat to potable water, mostly based on potential spills and other possible accidents resulting from hurricanes and other problems. Independent research and experience indicates otherwise, fortunately. A far more realistic threat to our drinking water comes from leaked and spilled oil and antifreeze from vehicles on our roadways. If we were to follow the writers' criteria, we would be forced to close down not only fracking in those states where it occurs but also a major portion of the roads throughout Amer-The writer describes ica. myths about radioactivity that have been completely proven to be false. Second, the writer criti-

cizes fracking because many of the jobs created are not long-range permanent. That is quite true. But upstate New York, where the fracking would take place, is desperately in need of employment, and local governments are in desperate need of revenue. The employment opportunities, seen region-

ally, are not that short-term. The major local revenue they produce will allow urgently required local needs to be addressed. Look at it this way: If you were to win a million dollars in the lottery, the income would also be considered a one-shot, but it would certainly address your financial problems.

Third, the writer notes that local schools would be forced to educate new students and local roads would have to bear the burden of heavy trucks. The Census Bureau reports that a stunning 1.6 million people left New York over the past decade, a trend that is continuing. For two decades, New York has led the nation in

the percentage of its people who are fleeing for greener pastures. The problem is

especially acute upstate, where the fracking would take place. In essence, the state is being depopulated. An activity that stops that is a welcome development, not a problem. And, yes, more people and economic activity brings more traffic. But that means more jobs in road building and repair, also a welcome response to New York's employment woes. New York's 6.7% unemployment rate is worse than that of 36 other states. That crisis cannot continue to be ignored.

Fourth, the writer maintains if the process was done safely, it wouldn't be profitable. If every extremist, over-the-top concern of every industrial process were to be subjected to what the extremists considered "safe," there wouldn't be a single profitable venture in the nation.

Fifth, it's pointed out that some earthquake readings have been detected in areas where fracking takes place. There is some merit in a strictly technical sense. But not only have the readings been well within the not-even noticeable range, they are fairly characteristic of many activities. The residents of Country Club, for example, experience greater tremors from the ongoing sewer projects than those resulting from fracking.

Sixth, concern is expressed over the release of methane. Methane is a natural substance also produced by cows and other mammals when they release gas bypardon the phrase-farting. Unless a law is successfully passed against farting, methane is here to stay.

There have been numerous falsehoods created by those with a financial interest in keeping the U.S. from being freed from reliance on foreign oil. One story circulated about how several workers were killed working on a fracking job. It turns out they were driving a truck on an icy road, skidded, and sadly lost their lives. Another famous myth was that in a town near a fracking site fire came out of a local facet. That turned out to be false, as well.

Preventing fracking keeps energy prices exorbitant, prevents America from becoming energy independent, and robs many of employment opportunities.

If the same level of misinformation and fear-mongering existed when electricity was first being implemented, you would be reading this article by candle light.

New York City drops fourth straight to Long Island at Empire Challenge

Anthony Cruz refused to hang his head after New York City's comeback attempt fell short in the Empire Challenge senior all-star football game.

The Kennedy quarterback had set up his team's first touchdown earlier in the game, but made one of two crucial mistakes late in the matchup that cost NYC a chance at making a serious run at Long Island in the annual event that pits city players against their Long Island counterparts on June 25 at Hoftra University. New York City fell 24-18 to Long Island for its fourth-straight defeat in the game that benefits the Boomer Esiason Foundation for cystic fibrosis.

"It's a little heart breaking, but at the end of the day, we are suppose to have fun," Cruz said.

He put forth a solid showing. Cruz rushed for 17 yards on four carries. One included hurdling a Long Island defender for an 8-yard gain. His 9-yard pass to teammate Christian Perez helped set up New York City's first touchdown with 4:20 to go in the third quarter. Cruz's two-point conversion pass to Perez pulled NYC to within 11-8.

"We had the motivation that nobody is going to stop us and beat us by 40," Cruz said. "We knew some of the weakness of the defense and we attacked."

The five boroughs had a chance drive to win the contest, down just 18-11 with 3:22 to go in the fourth quarter. But Cruz couldn't make it happen. UConn-bound linebacker Lawson Prendergast of St. John the Baptist in Long Island picked off Cruz's pass on the first play and returned it 24 yards for a touchdown.

"It's my fault," Cruz said. "I read the wrong route. I was supposed to hit the slot and I read it totally wrong."

Defensively the city had no answer for Huntington quarterback Ben Kocis, who was named the game's most valuable player. He completed 10 of 15 passes for 165 yards and a touchdown and also ran for a score. Kocis made argu-

ably the biggest play of the game when he connected with Joe Capobianco for a 17-yard gain for a first down on fourth and 10 from the Long Island 5-yard line.

The game was still scoreless at the time. Kocis went on to lead Long Island to a 10-play, 95-yard drive that put his team up 8-0. Cardinal Hayes safety Shawn Antoine, who is headed to Rhode Island, felt Kocis' attacks on the defense were the craftiest of the Long Island quarterbacks. Kennedy defensive tackle Mashawn Simmons added three tackles, including one for a loss of yardage.

"[Kocis] was looking the safeties off a little bit," said Antoine, who had two tackles and two for a loss of yardage. "It was just good plays. He was getting in the seams. He was making good reads."

Despite the loss, the players

were happy with how they represented New York City after the city team had fallen by combined score of 71-15 the previous two years. Victory was there for the taking, but the winning play escaped New York City this year.

Fieldston continued its dominance this year for the second-straight softball season. Behind star Temma Levis and a veteran core group of players, the Eagles took home an undefeated Ivy League title and a second consecutive NY-SAISAA softball crown.

Preston was still the borough's best squad, but its dreams of its first CHSAA archdiocesan championship were once again halted with a third-straight loss to Staten Island's St. Joseph by the Sea in the title game. The Panthers are expected to be one of the favorites next year with much of its team returning.

DeWitt Clinton, which reached PSAL 'A" semifinals a year ago, still took home a division title in a rebuilding season. And Riverdale, Bronx Science and John F. Kennedy all turned in strong campaigns.

All-Bronx Player of the Year Temma Levis, Fieldston

Levis certainly avoided the sophomore slump. The second-year pitcher remained one of the city's most dominant players at the plate and in the circle. Her ability to change pitches' speeds and locate the ball made her a nightmare for opposing hitters and helped Fieldston to feel comfortable with any lead. Levis allowed five hits, struck out five and walked just one in the final against Long Island Lutheran.

All-Bronx Coach of the Year Keith Mansfield, John F. Kennedy

The Knights completed a five-year climb from their rank as cellar dwellers to one of the elite teams in the PSAL Class B division. Kennedy had gone 0-13 in Mansfield's first season in 2010. This year it won an undefeated division title and was the only team not from Queens to reach the semifinals, where it lost to Goddard. Hours of hard work from Mansfield have JFK coming close to a title.

CF Grace Dzina, Bronx Science

The athletic centerfielder was one of the main reasons the Wolverines won 12 games this season. Dzina batted .421 in league play, drove in 33 runs and scored 26 times. The senior also

stole nine bases. SS Madeline Giannini, Preston

The junior remained one of the top run producers and more accurate fielding players in the borough. Giannini was often the catalyst for the Panthers' powerful attack. She helped Preston again reach the Archdiocesan final.

P Madison Kahn, Riverdale

Former RKA star Sofer enjoying time with Israeli national soccer team

The millions of people watching the World Cup this summer can only dream of what it is like to be an international soccer player. Summer Sofer no longer has to.

The former Riverdale/ Kingsbridge star spent the last 10 months away from home training as a member of the newly former Israeli Under-19 women's soccer team. She will head back to Israel in July as the team continues to prepare to host and compete in the European Championships in the summer of 2015.

"It's an amazing opportunity," Sofer said. "I'm happy to be a part of it."

She learned about the team from a family friend after her junior season with the Tigers and went to a tryout with Israeli national team Coach Guy Azuri. Once selected, Sofer said it wasn't easy to leave her family and friends behind. She chose to follow her dream and Riverdale/ Kingsbridge allowed her finish the final three classes for her high school diploma via online courses.

Both of Sofer's parents are of Israeli decent, and this isn't Sofer's first time competing internationally. She helped lead her Rye Celtic travel team to the 15U division title at the Dana Cup Youth Tournament in Denmark in 2011. Azui saw more than just technical skill from the midfielder who scored 82 goals and dished out 23 assists in her three seasons with RKA.

"I saw the passion for the game and going to Israel," Azuri said. "It shows a lot of courage to do something like this, to leave the family, to leave everything here, a comfortable life and come to Israel."

There Sofer, who has not decided where she will play college soccer after the European championships, joined the 19 other players at the Wingate Institute for Physical Education and Sports, just south of Netanya on the northwest coast of Israel. She is just one of four players from the United States on the team. Their demanding schedules include nine practices per week. It was something that took getting used to for Sofer, but was ultimately beneficial.

"It was a lot of fun, but you don't feel like it was really long because everyone there was like a really close family," she said. "The team was amazing."

Other Bronx soccer players are hoping to gain the same opportunity Sofer is enjoying. Former Bronx Science midfielder Alex Scheman and Riverdale goalie Jennifer Kronish were at a recent clinic, working alongside Sofer with Azuri. Kronish made the team last year, but

"Commander William G. Clancy Lane," in a street salute proposed by Councilman Jimmy Vacca (D-Throggs Neck).

Clancy was a life-long resident of City Island and a carpenter by trade, but he was best known for his work on behalf of veterans with the American Legion, although he served his area as a whole.

"William Clancy served his country and his community with distinction for over five decades, and I am proud to give him this honor that he so rightfully deserves," said Vacca. "No one did more for veterans than Commander Clancy, so it is only fitting that every veteran who comes to the Leonard Hawkins American Legion Post 156 will see his name on the street sign and be re-

minded of him." The Clancys were moved by the tribute.

"The Clancy family is deeply touched by this honor bestowed upon our father and the greater American Legion family by Councilman Vacca," said William Clancy, Jr. "Our dad would likely say that this honor is one that acknowledges all people who volunteer for organizations that serve the greater good. We agree with that sentiment and thank all of those that helped make this happen."

William Clancy, Sr., served in the U.S. Army from 1961 to 1963, when he joined the Hawkins Post. He held many roles there, including at least two periods as post commander, as well as post vice commander for activities and post secretary.

During his time as commander, Clancy oversaw the expansion of the City Island American Legion building to its current capacity, and he was awarded the Legion's "Good Guy" award in 1978 in recognition of his years of service.

In 1993, Clancy ascended to the rank of Bronx county commander on the boroughwide arm of the legion. Later, when he again served as commander for the Hawkins Post in 1996, he became involved in the New York State American Legion. It was during that time that Clancy spearheaded a national effort to recognize Prisoners of War and soldiers Missing in Action (POW/MIA). As a result, the U.S. Department of Defense declassified documents to better inform bereft families, and flew POW/MIA flags from many government flagpoles. Clancy later became district American Legion commander and statewide vice commander, both positions covering the Bronx and other nearby counties. He was a candidate for New York state commander before his passing, and will be remembered as a mentor to members and for helping the legion to advance and grow, said Hawkins Post Commander John Muhlfeld.

"He was a father-figure for many," he said. "He nurtured them to continue in the legion and make it better."
