

#### No. 6 line rehab jams Pelham Bay strip

#### BY BEN KOCHMAN

Pelham Bay's parking squeeze has reached a fever pitch.

Businesses near the Buhre Avenue No.6 train station — where the MTA started seven months of construction on July 5 — are seething over lost parking spaces in a shopping strip already starved for spots even before the work started.

"I could literally go around the block 20 times without finding a spot," said John Marxuach, store manager at Florsheim Shoes on Westchester Avenue.

The city closed down the Buhre Avenue and Zerega Avenue stations on both sides until February 2015 as part of a \$109-million renewal project.

Yonkers Contracting is repairing the mezzanines, renovating windscreens, installing a pigeon-deterrent system, and fixing up the platform stairs.

Until the work is finished, local businesses will have to grit and bear the loss of precious parking — but they are not happy about it.

Contractors are using the space on Westchester Avenue between Pilgrim and Hobart Avenues to hold equipment. They've also set up so-called "staging stations" on adjacent streets.

#### That's my spot!

Most of the spots lost are necessary sacrifices, admitted local business owners, and eventually will lead to an improved station.


But other spots, they charge, are unfairly being swiped.

A tan car that Marxuach said was owned by one of the workers, for example, has been parking in front of his Florsheim Shoes store since the construction started.

# Vacca bill would track park projects

A local elected official has proposed legislation that may lead to greater transparency in the implementation of Parks Department building and repair projects.

Councilman Jimmy Vacca (D-Throggs Neck) has introduced a bill that requires the Parks Department provide 30 days notice to councilmembers who allocate money for projects if changes are made in the original plans.

'Right now there is no obligation on the part of the city to advise the council person if there are changes in contracts that are funded by the member." said Vacca.

Vacca cited the reconstruction of Pelham Bay Little League's Naclerio Field as an example of the need for a law like the one he's proposed. The final result of the project, according to league leaders, was quite different from what was first proposed when Vacca allocated \$200,000 in

"I think the Pelham Bay Little League was the classic example," he said. "I had allocated the money and

the league and I were not advised that changes had been made."

Had the law been in place. Vacca said that he could have consulted with the league to see if the new plans would be an appropriate use of the money.

"When I allocate money," the councilman explained, "it is not limitless."

Legal action also resulted from the project, with the league getting a \$9,500 settlement from the contractor's insurance after a sprinkler system was damaged during the construction. Local attorney Steve Kaufman won the settlement for free.

#### Changes were made<sup>\*</sup>

Pelham Bay Little League president Vinny Prestopino said that originally the money allocated was supposed to fund a complete restoration of the both the outfield and infield, but that only the infield was reconstructed, and the league even had to pay to replace the pitcher's mound.

"What they originally told us they were going to do and what they did were two different things," said

Prestopino, who said that an \$82,000 backstop ate up much of the money that could have gone other re-

He would support a law that would have allowed the councilman some greater oversight.

"If there was a law like that it would have been a million times better," said Prestopino, who added that had the league been given the \$200,000 directly, it could have fixed all three fields.

#### Parks welcomes input

When asked about Vacca's legislation, a Parks Department spokesman said that the agency actively seeks input from all stakeholders.

"Parks maintains regular communication with community stakeholders throughout the capital process," said Philip Abramson. "Additionally, we are working on a mechanism that will provide additional transparency throughout the capital process. We look forward to sharing this information with the councilmember.

The St. Theresa's Summer Feast will be held this month, with rides, games, and good food up and down St. Theresa Avenue in Pelham Bay.

"The streets will be abuzz with rides being set up and decorations going up," said Lou Aurrichio, head of the St. Theresa Feast Committee. This year's feast is scheduled to run from Wednesday, July 23, to Sunday, July 27.

This year's Feast will be bittersweet for many parishioners. Father Robert Grippo, who has served as pastor at St. Theresa of the Infant Jesus Catholic church for the past 23 years, will be transferred to the Church of the Annunciation in Crestwood, New York in early July.

Father Grippo began the tradition of the St. Theresa Summer Feast in 1996, the year of the 100th anniversary of the church's patroness, St. Theresa of Lisieux. Fr. Grippo thought that a community celebration would be appropriate.

"The first Feast was so effective in bringing the community together we decided to continue it," said Fr. Grippo,

Every Feast has had a certain theme that the church focuses on for the week. This year, the theme of the Feast is "Come Home to Jesus."

Louis Masi, a seminarian who has had an active role in St. Theresa Parish, said that there will be a focus on evangelization and bringing the Good News to the people of the community at this year's Feast.

"We want to reach out to the people of the community, those who were Catholic or are Catholic who don't come to church that often, and encourage them to come home," Masi said.

The parish's youth group, which Masi organized, will be in front of the church handing out informational cards about the church's spiritual services. Curious Feast visitors may also enter St. Theresa Church for daily

mass and confession, and can watch videos explaining the basics of the Catholic faith.

"God has been working in the lives of the people in this community," said Fr. Grippo, who hopes that the Feast may be a way of providing people with a chance to re-connect with their faith.

Despite the imminent departure of Father Grippo, parishioners are confident that they will be able to continue the spirit of the Feast.

"Father Grippo has been our inspiration, and we will follow his example," said Antonia Bruno, a member of the St. Theresa Feast Committee who was recently honored for her long-time service to the Summer Feast.

The Feast has always hosted a variety of attractions for both locals and visitors from across the Bronx. Carnival-style rides and games are a constant at the Feast, along with classic Italian food. However, as with every endeavor, timing is ev-

erything; for example, ordering ride tickets in advance for a 50 percent discount.

"This year, the advance tickets are a huge savings," said Aurrichio. "You can get 40 tickets for \$20."

Advance tickets are sold in the parish rectory on weekdays between 9 am and 4:30 pm or on the parish website at http://sttheresaschoolbronx.org until July 22.

The St. Theresa Feast

will also hold a Grand Raffle, which will be drawn on July 27. The grand-prize winner will have the choice between either a 2014 Mercedez Benz CLA 250 or \$30,000 cash. The second-prize winner will receive \$1,000, and the third-place winner will receive \$500. Raffle tickets are also available for purchase on the parish website.

The Feast will also host a variety of local bands to

entertain the community each night. There will be two bandstands this year: one on Mayflower Avenue, and one on the Hutchison River Parkway. Featured bands and artists this year will include Bazooka Joe, A Moment's Worth, DJ Inappropriate, Blue Collar, JAMZ Entertainment, Control Z, Gino & Gina, and Dennis Dell.





# **Auto mirror thefts** spike in Indian Village

Car mirror swiping bandits have struck once again in a section of Morris Park, say angry neighbors — but according to local police nearly nothing happened.

Locals in Indian Village — the cozy network of streets in the shadow of Jacobi Medical Center and Albert Einstein College of Medicine — say that thieves stripped side-view mirrors off of at least a dozen vehicles parked on side streets during the last month, including Seminole Road and Narragansett and Rheinlander avenues.

But many of the alleged victims are not fed up enough, it appears, to file a report at the local stationhouse. Cops at the 49th

Precinct said that only a handful of mirror thefts have been reported during the last month.

Over the July 4 weekend, no reports of mirror thefts were filed anywhere in the precinct, said crime prevention officer Tyrone Mederos.

Without reports, he added, the police cannot allocate any resources to combat a possible mirror theft spree.

"No manpower will be allocated unless it is on file," said Mederos. "As far as the NYPD is concerned, nothing happened."

Locals have long griped that car break-ins are an unfortunate part of life in the neighborhood. Police have urged locals in both the 49th and neighboring 45th precincts to lock their car doors to protect themselves from bandits.

But this summer, say locals, the mirror thefts have come in bunches.

At least 10 vehicles were stripped of their side-view mirrors in Indian Village during the night of Saturday, April 26 and early morning Sunday, April 27, said locals Peter Enea and Joe Reda, the public safety chair of the local community board.

Some locals do not bother filing a police report because the cost of the mirrors is below the amount that their insurance covers, said Steve De-Martis, an Indian Village local who has been tallying the damage.


"People aren't filing be-

cause they are paying no matter what," said DeMartis. "The stats simply are not there for the crimes that are happening.'

said DeMartis counted at least a dozen vehicles in late June whose mirrors were stolen in his neighborhood.

One area car owner, who lives on Narragansett Avenue but asked not be named, had an even rougher time of it than most. Two days after bandits swiped one mirror of his Acura MDX parked in front of his house, he received a \$45 dollar ticket from traffic police for having "missing equipment."

"I was so aggravated," he said. "This is just crazy! I'm getting hit from both sides."

Dr. Hasan Ademaj, a renowned dentist and surgeon who practices in Belmont, is now creating a museum and memorial in the Kosova town where his brother Vezir Ademaj organized resistance to a Serbian invasion and paid for it with his life in July, 1998. He was part of the Kosova Liberation Army.

Vezir was a kick-boxing champion of Europe before returning to Kosova from Switzerland to fight the invading Serbian forces of Slobodan Milosevi, said Dr. Ademaj.

Milosevi was charged with war crimes related to genocide and convicted after he died. His army was invading Kosova, a country whose population is mostly Albanian.

The museum is to be lo-

# St. Benedict Parish Playhouse closes

#### BY PATRICK ROCCHIO

The Throggs Neck community and St. Benedict's Parish is losing an enduring program for children.

The St. Benedict's Playhouse, a wonderful, facilitated play group and learning program for toddlers run by local educators Bailey Provetto and Therese Cojocaru, will shut its doors after nine years of teaching hundreds of toddlers and getting them ready for school.

Provetto cited a lot of different factors, including the ongoing economic slump that makes even a modest \$65 a month for the program tough for families, a decline in enrollment, and complications arising from the regionalization of schools in the New York Archdiocese. All were factors that led to their decision to quit while they were ahead and go out on top, she said.

#### **Pastor Responds**

Father Stephen Norton, the pastor of St. Benedict's Parish, said that the loss of the playhouse would be shared by the entire parish community, but struck a note of optimism in saying that when God closes one door he opens another.

"Bailey and Therese were looking to retire out, and they tried to see if there would be someone else to take over the program," said Norton. "But we just didn't get anyone interested in doing that."

"It is a loss for us, there is no question about that," he added. "But trumping that loss is what Bailey and Therese need in their lives and with their families — we are supporting them, and we are grateful for the nine years during which they worked extremely hard."

Norton said there may not be the same exact program continuing at the church and its school, but he is confident that the parish community will continue to thrive.

#### A necessary program

The program served over 783 families, who often had several children each, said Provetto. The idea of a facilitated play group was fairly new at the time it was started under Monsignor Edmund Whalen, then-pastor of St. Benedict's.

"It was a very new type of a idea, it was not 'a mommy and me,' program, it was a facilitated play group which is like a preschool only with the caretakers being there," she said.

The playhouse was a comprehensive program that offered actual lessons, craft-time, circletime, and speakers for the mothers and other caretakers involved in the children's upbringing.

"We were getting the children ready for school," she said.

"Every pre-k and kindergarten teacher knew our kids because they were the ones who knew how to transition, to lineup, and share and care."

Many similar programs in the area are also struggling and closing, and despite efforts to keep

costs down, many local moms in the area couldn't afford to send their children, she said.

# 'Delta' force! New public school in Throggs Neck

#### BY JAIME WILLIAMS

This fall, the Bronx Delta School in Throggs Neck will open its doors to students for the first time.

The new public elementary school is the brain child of Principal Daniel Racic, who was recently a part of the founding team at PS 531 in the Bronx.

Racic, who taught technology, coached teachers and held other leadership positions in the school, said that being part of a new school was a turning point for him as an educator. The experience showed him how a team could create a positive school culture from the ground up,

"It was really exciting to me to be able to do something like that from scratch, to help an entirely new set of students," said Racic.

The Bronx Delta School, which will offer classes to just pre-K and kindergarten students this year, has been in the works since March 2013.

The school is founded on the values of being purposeful, being joyous learners, and being kind, said Racic, and he's spent the past year working to connect those ideals to specific teaching and administrative prac-

"Every step since then has been about flushing it out and making it real," said Racic.

A key part of the school's plan is to have students set goals each week or so, Racic said, in order for them to continually feel successful when meeting those goals. He feels that having students drive their own improvement is important.

"What I think makes a student succeed is that they get to take ownership of their learning," said Racic.

The school will also emphasize an effective use of technology to empower students and allow them to be successful in the upper grades and beyond.

In addition to fostering academic improvement, Racic said the school will also encourage social and emotional development. Time will be set aside for teachers to specifically teach those skills, and students will set specific goals in those areas too.

"In order for students to be successful they need to strive to make improvements in social and emotional learning as well," said Racic.

The name "Delta" comes from the delta symbol, a triangle. The three sides represent academics, social, and emotional learning, said Racic. The mathematical symbol also indicates change, which he said conveys the school's mission.

The school itself is located in the IS 192 building on Hollywood Avenue, co-located with three other schools.

The first year, the school will comprise of one pre-K and two kindergarten classes, Racic said, which are already full, although parents may place their kids on a wait list. The school will remain small, he said, with just two classes per grade. The school will be fully enrolled with pre-K

through fifth grade in Fall 2015, with a projected enrollment of 290 to 350.

The public school is non-zoned, which means students from all neighborhoods can apply, although Racic said the majority of enrolled students are from nearby neighborhoods.

# College of New Rochelle sells Mott Haven site

#### BY BEN KOCHMAN

The College of New Rochelle has sold its piece of prime South Bronx real estate for a hefty sum — but not to worry, Bronx book-

A down-scaled version of the school's adult education School of New Resources will remain onsite in Mott Haven for at least the next decade.

Property investment firm Chestnut Holdings snapped up the 60,000-square-foot, eight-story building at E. 149th Street and Courtland Avenue — steps from the heavily trafficked Hub — in

June for the asking price of \$10.5 million.

As part of the sale agreement, the college's John Cardinal O'Connor Campus will lease back four floors of the building for the next 10 years, with an option to push that lease to 15 years after five years.

#### Less space, no problem

The school put the towering Mott Haven building on the block in February. College leadership said the school would pump the money from the sale into improving existing facilities and programming.

Overall growth from the school, said college president Judith Huntington, would overshadow the space squeeze.

"All of our classes and offerings will be the same," said Huntington in an interview. "We are keeping the space that we really need, and continuing to grow."

The School for New Resources, which has doled out adult education degrees to more than 5,000 men and women in the community for more than 35 years, will soon consolidate its classroom and office

operations between the third and sixth floors of the E. 149th street building. Chestnut Holdings is now targeting retail tenants for the ground and second floors, and other commercial tenants for the seventh and eighth floors.

#### Boom by the Hub

The family-run real estate firm has been bullish on the Bronx since it purchased its first building in the borough in 1997. And it's not the only real estate company crowing about the area around the Hub, where Mott Haven's three main streets intersect.

In September 2013, city officials broke ground on an 88,000-square foot \$35 million mixed-use facility in the Hub that will replace a vacant parking lot. The so-called Triangle Plaza Hub will soon host a Fine Fare Supermarket and campus for Metropolitan College of New York, among other ten-

#### Staying long term

The College of New Rochelle, which serves mostly local students who walk or take a quick public transportation to class, has every intention of staying put amid the surrounding real estate


"This is not an exit strategy whatsoever," stressed Huntington. "We are firmly committed to serving the Bronx community for the long haul."

Councilmember Jimmy Vacca has allocated money to install adult exercise equipment in the park that will be ready for use in the Summer of 2016, giving residents a different way to use parks to get in shape.

The plan was initially presented to some members of the board by a Parks Department representative at a chairpersons meeting in June, where a few members had concerns about the safety and maintenance of the equipment, said Parks Committee Chair Joanne Rubino.

Those members' initial resistance may have also stemmed from the fact that the Parks' representative was unable to answer specific questions, said Board 11 chairman Tony Vitaliano.

But both Rubino and Vitaliano said they felt the plan for equipment was a positive one, because it encourages people to get outside and active.

The exercise equipment is a great alternative for people who can't afford or don't want to join a gym, said Vitaliano, and the equipment is seniorfriendly.

# Women's club starts Bronx chapter

# Montefiore to scale back Riverdale ambulatory plan

#### BY BEN KOCHMAN

Montefiore Medical Center says it is prepared to take a scalpel to its controversial plans to build an ambulatory center in Riverdale.

But locals are still left guessing to what degree the borough's medical giant will shrink its design — or whether or not it will be subject to a new Bronx law aimed to force such projects to go through unprecedented levels of red tape.

Hospital staff is expected to meet with the land use committee of Community Board 8 on July 22 to discuss a scaled-down complex at the proposed site on Riverdale Avenue and West 238th Street.

Montefiore had originally proposed an 11-story, 95,000-square-foot outpatient center there that caused an outcry from neighbors who thought such a building would conflict with the area's residential character and cause traffic jams, among other gripes.

The community out-

rage prompted state Sen. Jeff Klein (D-Morris Park) and Assemblyman Jeffrey Dinowitz (D-Riverdale) to push through a law in March creating a new review process for outpatient health care centers over three stories tall or 30,000 square feet planned for the Bronx.

Such projects must now go through a series of mandatory community forums before the state Department of Health has a chance to approve them.

Klein vowed in March that construction on the Riverdale site could not start for at least two years.

It remains unclear whether the Montefiore Riverdale site will become the new law's guinea pig, or if it will be downsized enough to get around the legislation.

An assistant vice president at the health care chain, Kate Rose, told Community Board 8's land use committee in June that Montefiore was considering an "approximately three-story health facility with on-site parking," ac-

cording to a report in the Riverdale Press.

Such a plan would be exempt from going through Klein's law, if it was also less than 30,000 square feet

But a hospital spokeswoman backtracked a bit this week in an e-mail to the Times-Reporter, saying only that Montefiore plans to "significantly reduce the project," and wouldn't specify whether the new plans were less than three stories tall, or smaller than 30,000 square feet.

"We will be sharing the new plans with the public in the coming weeks," wrote Tracy Gurrisi.

Until then, Riverdale is keeping its fingers crossed — and elected officials will be watching.

"I have stood with the Riverdale community every step of the way in fighting against this health facility," said Sen. Klein, "And I will continue to stand with them with respect to Montefiore's newest iteration of its proposed Riverdale development."

awarded \$25,000 in seed funding from the New York City Economic Development Corporation (EDC) as one of five finalists in Round I of the third annual Competition To Help Reach Immigrant Ventures and Entrepreneurs (THRIVE), designed to address practical struggles faced by immigrant entrepreneurs in starting, operating and expanding their businesses in New York City.

SoBRO is launching the United Business Cooperative, representing a group of 31 immigrant restaurant owners who have come together to centralize their purchasing, storage, and delivery operations to realize cost savings and provide healthier options to Bronx residents and visitors. After the six-month pilot period, one finalist will be selected to receive \$100,000 and promotional services to scale the winning project.

SoBRO proposes to offer the following technical assistance services to the Coop: formalizing cooperative entity and related legal assistance, financial projections estimating the cost savings arising from collective bargaining, business financial literacy services, credit analysis and repair, establishment of a bank account, branding and marketing support, technology support, and assistance with identification of warehouse space.

The proposed initiative has a great potential both for expansion and replication. As the cost-savings and service improvements are realized, SoBRO will work closely with the Coop members to recruit new businesses and expand into other areas where members will benefit from collaboration and economies of scale. SoBRO believes that the cooperative model can be replicated in other sectors as well as other neighborhoods where similar sized and scoped immigrant businesses exist, in New York City, and nationally.

# Money wise: Bank program trains students

Capital One Bank is encouraging financial literacy among Bronx youth.

It has been another successful year for Capital One's Student Banker Program at the Theodore Roosevelt Education Campus in Fordham.

As part of the ongoing program that began in 2007, 11 high-school seniors are selected to run a functional bank branch in the school building for those who go to school and work there.

The youth people train in Capital One bank branches in their communities in the summer, and have the fall semester to learn more, before spending the spring teaching their peers about financial literacy, said La-Kia Williams, part of the bank's Community Development Banker Team.

"We believe in the peerto-peer education model when it comes to financial literacy for student banking," she said. "So our stu-

dents in turn teach their peer through a Jeopardylike game that covers basic concepts like budget, credit, and identity theft."

One of the students who participated in the Roosevelt program this past school year, said that she learned about the importance of saving and how to prioritize her time.

"I had to learn to prioritize my time so in benefits me in the long run," said Alexandria Fearon of Williamsbridge, who added that the student bankers must keep up in their classes while they are running the bank branch inside the school building.

She also learned tools she can use to set and reach her own goals.

"My goal is to go to college, so I will be able to see what should I save in order to reach my goal in the next year," she said.

The graduating senior plans to attend the College of New Rochelle, where she

hopes to major in Environmental Science with a minor in Sociology.

The bank wishes to share five tips that can help young people achieve financial goals:

· Set financial goals: Identify and write down your short-term and long-term financial goals. Financial goals can include saving for college, buying a car or saving a certain amount for any expenses during your senior year (such as prom, graduation or a senior trip with your friends).

•Develop a realistic budget: Think through how much income you have (from a part-time job, allowance or babysitting pay) and how much you've normally been spending. Map out your expenses and income and determine your spending priorities, such as the difference between your wants and your needs.

Each month, put away the amount you plan to save first, before you have any other expenses, so it becomes a part of your monthly budget.

·Track your spending: Keep track of any money you spend, especially on non-essentials. Once you take a look at everything you purchase in a month's time, you may find there are certain costs you can cut back on to save money. For example, packing a lunch at least twice a week instead of eating out could save you almost \$20 a week!

•Prepare for the unexpected: Make sure to set aside money for emergency situations or unexpected fees (like car problems or an unexpected school expense).




The Jolly Tinker and the Bronx County Historical Society will present a chronological slideshow of the Bronx community over the 45 year span.

## Bronx resident, Lt. Colonel Floyd Carter, Tuskagee Airman

John Scuoppo was at an affair some time ago and was fascinated to meet a Tuskegee Airman by the name of Lt. Colonel Floyd Carter there.

He mentioned my name and obtained the colonel's home address and phone number for me. I was ill at the time and couldn't drive so I asked Nick DiBrino to stop by to see him and get some preliminary information for me

The colonel is quite a busy man so finding a mutually convenient time to get together with me proved challenging and then he had to postpone a couple of meetings when his wife was hospitalized. In the interim, we had any number of very pleasant chats and I got to know the colonel quite well. The Tuskegee Airmen, for those who don't know, were a unit of African-American pilots established in Tuskegee, Alabama in 1941. Prior there to, Af-

rican Americans were banned from flying in the military service which was still segregated.

The Tuskegee Airmen proved that not only that they were excellent pilots, but also that they were fearless in combat.

They were credited with shooting down over 100 German airplanes and destroying an even larger number on the ground. They also sunk one destroyer and bombed almost a thousand war vehicles including railroad cars.

They received several Unit Citations and numerous medals, including eight Purple Hearts, and about 150 Distinguished Flying Crosses for their valiant efforts.

There weren't all tough times as they occa-

One comical story he is fond of relating concerns the governor of Alabama, who was a well-known bigot.


One very dark and starless night, Colonel Carter was on a training flight in a very noisy B-25 when on the spur of the moment he decided to play a trick on the governor whom he knew was giving an important speech at the Capitol Building in Montgomery, which was only about a half hour flight away. He knew it was dark enough that his identification markings could not be seen from the ground. When he was directly over the building, he turned the props up as high as he could creating a racket

that could be heard for miles around and then he quickly disappeared into the night chuckling all the way home at disturbing the governor's solemn speech.

Floyd J. Carter was born in historic Norfolk, Virginia and joined the U.S. Army Air Corps in 1943. He graduated from the Tuskegee Flight School on March 23, 1946 as a flight officer in class 46-A-TE.

It was at the school where he met his wife, Artherine, who worked there repairing airplanes. The couple moved to the Bronx in 1953 where they still reside.

The colonel would later join the Air Force Reserve where he flew missions during the Berlin Airlift. He also served as the first African American commander of the 732nd Airlift Squadron from 1971 to 1974. His service to his country spans several decades and three

wars: World War II, the Korean War and Vietnam. He was awarded the Congressional Medal of Honor in 2007 by President George W. Bush.

# Teacher convicted in rape of 5th grader

District Attorney Robert T. Johnson announced that a 41-yearold former elementary school teacher was sentenced to 14 years behind bars, with an additional 18 years post-release supervision, for raping one of his fifth-grade students.

Anthony Criscuolo, of 833 Kinsella Street, pled guilty to one count of Rape in the 1st Degree, a Class B violent felony offense.

The rape of the 10-year-old female victim occurred June 17, 2013 in Criscuolo's car, evidence of which was uncovered when her mother discovered explicit emails he sent to the child.

In order to not further traumatize this young victim, it was determined that this plea agreement was in her best interest. This determination became heartbreakingly clear when the victim impact statement written by this child's mother was read at sentencing:

"My daughter used to love going to school. She cries every time I try to take her to therapy. She walks with her head down because she feels like everyone knows who she is... she asks me to buy her sunglasses and hoodies to hide her face from others.

"My daughter is taking her anger and frustrations out on her younger sister. They used to be so close but now it's like she doesn't trust anybody.

"Her therapist [says] when she becomes a teenager it will be a bigger issue because I don't know how she will...perceive the opposite sex when it's time for her to start dating. She doesn't even want to interact with her dad...I'm scared about the quality of life she is going to have if she can't trust in herself or family."

As part of his plea, Criscuolo will have to relinquish his teaching license, and he will also have to register as a sex offender once he is released from incarceration.

Criscuolo was sentenced by State Supreme Court Acting Justice Judith Lieb in Part H 73.

The case was prosecuted by Assistant District Attorney Gina Torres of the Child Abuse / Sex Crimes Bureau.

## Mother's Day murder

District Attorney Robert T. Johnson announced guilty verdicts in a triple shooting that took place following a toddler's birth-day party on Mother's Day, 2010.

The Bronx Supreme Court jury found Robert Mitchell guilty of two counts of Murder in the 2nd Degree for the killings of Marvin Wiggins, Jr., age 15, and Quanisha Wright, who had just turned 16 the day before.

After a month-long trial, Mitchell was also found guilty of one count of Attempted Murder in the 2nd Degree for the shooting of Latisha Eleazer, age 20 at the time, who suffered a non-fatal injury when Mitchell, age 24 at the time, fired a .45-caliber semi-automatic pistol into a crowd of partygoers at 1776 Weeks Avenue in the Mount Hope section of the Bronx.

The wild shootings took place on May 9th, 2010, at

a party among teenagers that followed a 1-year-old's birthday party. After getting bested in a dispute with several people who attended the after-party, Dexter Green, Jr. left, but then returned and got into a confrontation with Latisha Eleazer, whereupon Mitchell pulled a gun provided to him by his friend's father, Dexter Green, Sr.

Robert Mitchell opened fire at the teens who were gathered in the hallway of the apartment building, shooting Marvin Wiggins, Jr. in the back, and Quanisha Wright, who was struck by a bullet that went through her arm and abdomen. WIGGINS and WRIGHT were both transported to St. Barnabas Hospital, where they succumbed to their injuries. LATISHA ELEAZER was hit in the arm; she was treated and released from St. Barnabas within hours.

Dexter Green, Jr. pled

guilty to a charge of Manslaughter in the 1st Degree for his role in the incident and will be sentenced on July 7th to a prison term of 20 years with five years' post-release supervision. Dexter Green, Sr. pled guilty to Criminal Possession of a Weapon in the 2nd Degree with an Intent to Use Unlawfully and has received a sentence of 10 years behind bars with four years' post-release supervision.

Robert Mitchell will be sentenced on July 21st, 2014, to a potential 25 years to life for each of the Murder charges, and 5-to-25 years behind bars for the Attempted Murder charge, by Justice Dominic Massaro, in Part 14, Bronx County Supreme Court, Hall of Justice Room 430.

The case was prosecuted by Senior Trial Assistant District Attorney David Greenfield of Trial Bureau 20/50

## Sentenced for tax fraud

Preet Bharara, the United States Attorney for the Southern District of New York, announced that Mark Goldberg, a Bronxbased tax preparer, was sentenced in Manhattan federal court to 57 months in prison for his participation in a scheme to file fraudulent tax returns on behalf of thousands of clients, falsely claiming more than \$7 million in bogus deductions. including false school tuition credits and expenses. Goldberg pled guilty in August 2013 before Chief U.S. District Judge Loretta A. Preska, who also imposed today's sentence.

Bharara said: "Mark Goldberg prepared thousands of fraudulent tax returns that resulted in over \$2.5 million in fraudulent refunds for his clients. Now he has to surrender the illgotten gains and his liberty."

Manhattan federal court:

Goldberg ran a tax preparation and multi-service business named E&M Multi-Services, Inc. ("E&M") out of a storefront building in the Bronx.

Through that business, he prepared, and oversaw the preparation of, thousands of federal and New York State tax returns that claimed false deductions, expenses, and credits, including tuition credits and expenses, unreimbursed business employee penses, medical and dental expenses, charitable gifts, and earned income tax credits.

Between 2005 and 2012, Goldberg caused the preparation and filing of tax returns for his clients that included over \$7 million of fabricated and fraudulently-inflated deductions, resulting in over \$2.5 million in refunds being paid to his clients to which they were not lawfully entitled. Goldberg also failed to report any of the income derived

from his tax preparation activities, and further submitted fraudulent personal returns claiming bogus refunds and tax credits.


In addition to the prison term, Chief Judge Preska ordered Goldberg, 40, of the Bronx, to pay restitution in the amount of \$2,597,419 to the United States and the State of New York for the losses caused as a result of his scheme, and to forfeit \$500,000 in fees generated by Goldberg as part of his tax fraud scheme. Chief Judge Preska also sentenced Goldberg to three years of supervised release, and ordered him to pay a special assessment of \$300.

Bharara praised the investigative efforts of the Internal Revenue Service-Criminal Investigation and the New York State Department of Taxation and Finance.

Bharara also thanked the U.S. Department of Justice's Tax Division and the Bronx District Attorney's Office for their assistance.

If you're like the rest of us, chances are you have participated in a gambling activity in recent weeks or months. Have you bought a lottery ticket or scratch-off? Have you gone to the racetrack? Joined the office betting pool for Super Bowl? Played poker or other card games with your buddies for small change or bigger stakes? Participated in a 50/50 raffle?

Gambling has become a normal, socially sanctioned part of our lives. We don't even think of the word "gamble" as we pick up our Bingo card on the cruise ship or at Casino Night, or as we tuck those scratch-off games into a birthday card or gift bag. It's a fun and often exciting thing to do and our kids are picking up this message loud and clear. Approximately 60 % of the adult population gambled in the past year. By far, the majority are "social gamblers", that is, they gamble in a social context and their gambling poses no problem for them with home, work, finances, or other obligations. They can "take it or leave it" when it comes to gambling and thoughts of gambling do not monopolize their minds. But if gambling does become a problem or even an obsession,, gambling addictions can have the same types of negative consequences as addictions to substances like alcohol and other drugs.

As with alcohol, teenagers are more apt to develop a problem with gambling than adults are. The teenage mind-set, with its impulsivity, feelings of invincibility, susceptibility to peer influence and advertising, propensity to thrill-seeking and risk-taking, makes adolescents and young adults high-risk candidates for a gambling problem. Gambling activities most popular among youth include playing cards or dice for money; playing pool, basketball, and other games of skill for money; sports betting; and playing Lottery and scratchoff games. If this sounds innocent enough, consider that approximately 4 to 8 % of kids between the ages of 12 and 17 meet the criteria for problem gambling, and another 10 to

15 % are at risk of developing a problem2.. Teenagers who gamble are also more likely to drink, use marijuana or other drugs, steal or shoplift, or get in trouble with the police1.

A major warning sign that someone is developing a problem with gambling is that they continue to gamble even though they are experiencing negative consequences. For a teenager, this could include falling grades, loss of interest in other activities that don't involve gambling, problematic relationships with family or friends, borrowing money and falling into debt. For an adult, this could include deteriorating relationships with spouse and other family members, poor job performance, financial difficulties, anxiety and/ or depression, loss of home or other possessions.

It is important to remember that while most adults

can gamble with no problem, some will go on to find themselves in over their heads. Fortunately, there is help available through Gamblers Anonymous (a 12 Step program like Alcoholics Anonymous)at www.gamblersanonymous.org, and the New York Council on Problem Gambling at www. nyproblemgambling.org. How to help a problem gambler? First, become informed yourself about the issue. Second, confront the gambler in a firm but loving way about how his/her gambling activities are hurting him/herself, the family and the community. Third, have helpful resources at hand to direct the gambler toward immediate assistance. Fourth, get help for yourself as needed, because living with this situation is extremely stressful.

We were watching the news this morning and saw that there was a huge dust storm in Arizona. never learn, do we?", said my husband and I had to agree. The Dust Bowl in the 1930's has receded so far from the public consciousness, it's as forgotten as events like the Irish Potato Famine. But we should never forget these ecological disasters because of the valuable lessons we can learn from them. From the Irish Potato Famine, we learned the dangers of the monoculture, or growing massive amounts of one variety of a vegetable. From the Dust Bowl, we learned the importance of soil health. Or I should sav. we "should have" learned.

How did the Dust Bowl happen? It was a series of events; a drought combined with the results of a man made change in the natural landscape. The central plains had been grasslands for hundreds, thousands of years. As America pushed west, the grasses were plowed under to make way for agriculture. Along came a prolonged drought, and lack of soil structure due to this depleted soil led to dust storms that at one point barreled across the country and descended on Washington DC. This of course got the attention of the federal government and ultimately it was a soil scientist. Henry Howard Finnell, who helped the farmers get their land back to good health and the Dust Bowl receded into forgotten American history.

To turn a phrase, "Forgotten but not gone", apparently. Good soil health is one of the "simple" solutions to some of the very complex problems we are dealing with today. For example,

using sustainable practices and good soil management can help farmers eliminate the use of chemicals on their fields. This results in less chemicals in our food, our soil and our ground water. While one can find arguments for and against using chemicals to grow food and how it affects yield, what can I tell you, you can manipulate numbers however you want to prove your point depending on your motive.

Although, what I can tell you from my own experience is that I don't have a problem with yield, disease or quality in the produce I get from my garden.

Yes, I have weeds, but I spend an hour or two on the weekends pulling them - at most! I have manipulated my landscape to allow some weeds to flourish, things like purslane, wild plantain and Queen Anne's Lace, and they do a decent job of crowding out the crabgrass. Most of my gardening in the summer months is simply watering on dry days. So the argument that not using chemicals is a lot of work. I guess that's a matter of perspective. Sure, it's work, but it's not an unpleasant task to be out in the garden.

On a larger scale, farming at every level can benefit from using organic practices, it's only the chemical companies and food conglomerates that will suffer when people stop buying their products. Studies have shown that using sustainable practices in farming have in some cases increased yields. Healthy soil absorbs and retains water which makes farms that are chemical free are better equipped to handle drought conditions. Combined with a substantial rainwater collection system, many farms

can arm themselves with irrigation systems that can be utilized during dry times.

Hurricane season has begun and Arthur just skirted by us in time to shoot off Fourth of July fireworks. Hurricanes are driven by warm water and one of the things that is causing the water to get warm is the storm water run off: freshwater combining with saltwater, which have different densities and are a big factor in how the jetstream controls the weather. Consider that a lot of this runoff comes from conventional agriculture, so that the water is loaded with those chemicals such as pesticides, herbicides and chemical fertilizers.

Rainwater flowing from impervious surfaces such as sidewalks and roadways also are filled with toxins from the chemicals in fuel, automobiles, trucks, garbage and the chemicals used to make our roadways themselves.

Smart entrepreneurs would do well to keep in mind how to tap into the potential of sustainable businesses. I recently saw something on TV about the Asian Carp, and invasive species that is destroying habitats of native fish populations and the problem we seem to be having with controlling this population. I wondered, humans are very good at hunting or fishing a species into extinction, what's stopping us from doing that to the Asian Carp? The problem with the Asian Carp is that it is a boney

and not very tasty fish and so the potential for making

huge profits on sales doesn't justify the expense of creating an industry which could efficiently and effectively harvest this type of fish. I recalled how the Native Americans showed the Pilgrims how to grow corn in the sandy Northeastern soils on the shores of Plymouth, MA. They dug rows and dropped dead fish into the hole before sowing the seeds, allowing the decomposing fish to act as a fertilizer. Wouldn't vou think we could figure out how to overfish the Asian Carp, use it to manufacture a natural fertilizer and eventually eradicate this invasive species and save our native fisheries?

And so while we need to employ tactics such as beach replenishment, breakwaters and seawall improvements, other options such as green roofs, pervious walkways, rainwater collection on a massive scale and bioswales around parking lots must also be part of the plan. Soil management on a personal level (that which we practice at home in our own backyards) must be combined with large projects completed by corporations and municipalities must be put into action soon. For example, we need to demand that the large distribution centers and shopping malls sprouting up in our community must install stormwater management systems. It is one thing to be an defensive player, we must also utilize our offensive maneuvers.

Every morning when I let the dogs out to run around in the backyard, I find another small miracle, another flower in bloom, a butterfly or a bird I haven't seen before or a plant growing on its own, a welcome volunteer. Last vear. I must have thrown a bunch of cucumbers in the compost pile because aside from the volunteer tomatoes, arugula and wild lettuces, this year I had something new sprouting in the soil. While I train the vines around my tomato plants, I waited to see what kind of vegetable it will turn out to be. Yesterday morning I noticed a nodule at the base of one of the vine's blossoms. I snipped it off and took a bite. My suspicion had been that this vine would be a cucumber, but the tiny little veggie I tasted was a squash, but not the Zucchini Fiore that I usually grow. This tasted like the Courgette, which I tried growing two years ago. The fact that this is now sprouting in my garden (thank you compost) is truly amazing to me.

While I wait for that, I have been doing research on a new edible plant that has been sprouting up borage. We planted seeds a few years ago and from one or two successful plants. we now have 6 or 8 flowering in a shady spot. The whole plant is edible, the flowers for example can be sprinkled on a salad. I cut off the multi-blossomed stalk, dipped it in a tempura type batter and deep fried it.

At the same time, I fried a bunch of arugula, also growing rampant in the garden. The borage had a nice spinach like taste. The batter covered arugula leaves turned into a sort of nest on top of the frying oil and when we tasted it, we found that the act of frying cut some of the sharpness from the leaves.

A sprinkle of grated Pecorino Romano and we had an awesome appetizer with dinner.

When I make a "Frito Misto", I use a batter of 1 cup of flour mixed with 1 3/4 cup of water, salt and pepper and that's it. Dip in zucchini blossoms, string beans or whatever and toss them into vegetable oil that's been heated to 325 degrees. For the borage blossoms, I used 3 inches of oil in a deep saucepan. I fried the arugula in the same oil, but next time I plan to do it in a frying pan with about a 1/2 inch of oil. Use your discretion. 3 to 4 minutes on each side, keep an eye on the temperature, make sure that the amount of oil in the pan is sufficient and will not spill over the sides when you drop in the battered veggies. Set up a plate with a paper towel for draining afterward. If you have a cooling rack, you can use that too, just put some paper towels under it. And don't forget to throw the oil stained paper towels in your organics composting bin.

While I can have supreme confidence in the health of the soil in my own personal domain, it is just a small hedge against a bet my garden vs. all the other pieces of land on the planet. At least that's how I see it! And so, as we go into the upcoming process of working together to create a plan for storm preparedness, I intend on pushing the idea of soil health. If our concerns are storm surges and storm water management, practicing good soil management has to be a large part of this.

In the meantime, be the change you want to see in the world and for goodness sake, see the goodness in the world while you're at it. Peace out.

## Shootings up 10% from last year by Tom Allon

A savvy political friend recently described to me in a simple, glib way why shootings generally go up in the summer and stay low in the winter.

hang-"People start ing out outside when the weather gets warm, they have a couple of drinks and then if someone pisses someone off, it can lead to a shooting in certain neighborhoods," he said. "In the winter, everyone's inside, so this kind of thing rarely happens." Well, it is not quite that simple, but shootings generally spike during the summer, and this summer so far they are up more than 10 percent from last year.

This past weekend there were 12 shootings in the city. This alarming trend has led some to question whether this is because of the new administration and the steep decrease in stop-and-frisks. This line of thinking was inevitable, but it seems too early to discern a trend, and we should all take a deep breath and calm down.

Stop-and-frisk was an extremely controversial policy used frequently during the Bloomberg administration. Then-Police Commissioner Ray Kelly faced a lot of criticism during the mayoral campaign of 2013 that his department was unfairly profiling young black and Latino men, who made up the vast majority of those stopped-and-frisked.

There was even a controversial court case that was decided last summer - right near the end of the campaign - that sought to limit the Police Department's ability to use stop-and-frisk as a crime tool.

While this was going on, the number of stop-and-frisks dropped quite precipitously anyway and still the rate of major crimes continued its steep decline in 2013 as the waning days of the Bloomberg administration came to a close.

Mayor Bill de Blasio made a wise choice when he picked Bill Bratton to be police commissioner because of Bratton's strong track record in not only reducing crime, but in smoothing relations between the Police Department and the community. He did this most famously in Los Angeles, and now Bratton has been working

quietly and effectively to bring the NYPD into the post-stop-and-frisk era.

There has been much debate of late about whether we have enough police on the streets to keep New York the safest large city in America When Mike Bloomberg took office in 2002, there were more than 35,000 police in the city, a number that dwindled to 31,000 by the end of his years in office. It is a testament to Bloomberg and Kelly that they were able to keep reducing crime and terrorists at bay with fewer resources.

But during the mayoral campaign a few candidates vowed to increase the police force again.

In the recent budget negotiations, the City Council, led by Melissa Mark-Viverito, pushed for adding 1,000 more police to the force, but surprisingly de Blasio and Bratton opposed this. The final compromise called for adding just 200 more police, a fiscally prudent move by de Blasio, but perhaps one that will look short-sighted if crime and shootings continue to spike once summer ends.

Last week, Bratton an-

nounced that he was moving 400 senior desk personnel to patrol the streets for the summer as part of an "all hands on deck" initiative, which was perhaps prompted by the recent rounds of high weekend violence.

Crime fighting in New York has become much more sophisticated in recent years, with even units created that use social media to infiltrate gangs to reduce gang violence, which accounts for a high percentage of violent crime in the city. That example may largely explain why crime fighting has become so much more efficient and thus not as labor intensive as it was in the 1980s and '90s.

No matter what, de Blasio and Bratton were wise to commission a study to see if the recent rise in shootings had any correlation to the drop in stop-andfrisks. Those who lived in New York 20 and 30 years ago sometimes worry the city could sink back to the days of the Wild West when more than 2,000 murders a year were the norm (vs. less than 400 last year).

educating our children are the most important jobs the mayor has, and these two are related. But now that school's out, the weather's getting much hotter and people are spending more time outside drinking and partying, we need to make sure the Thin Blue Wall is sufficiently manned to keep us safe.

Adding 200 police and getting 400 more out of the office and onto the streets is a good start.

Stay tuned during the

next two months to find out if this is enough to keep the impressive drop in crime of the past two decades on its steady descent downward or whether it is time to rethink some policing levels and methods.

## Data shows braces are not longer just for children

Data shows that between 2010 and 2012, the number of adult orthodontic patients increased by 14 percent in the U.S. Today, there are an estimated 1.2 million adults undergoing treatment - or, according to the American Association of Orthodontists, about one in five of all orthodontic patients are over the age of 18. And, it is nearly as many men as women, whereas not too long ago adult women were about four times more likely to wear braces on their teeth.

"We have seen a dramatic increase in the number of adult patients in our practice," said Ariel Bales-Kogan, DMD, MSD, Orthodontics Director at Union Community Health Center in the Bronx. "Although childhood is the ideal time

to make changes in the positioning of one's teeth, many individuals are only able to get braces later in life. As long as you and your teeth are healthy, it can be done successfully at almost any age."

According to Dr. Bales-Kogan, aesthetics are not the only reason for braces.

"Crowded or overlapping teeth can make it hard to brush effectively, increasing the chance of plaque buildup, which in turn can make one more prone to cavities and gum inflammation," he said. "Malocclusion, or teeth that do not come together properly when you close your mouth, can cause chewing and swallowing problems that can result in temporomandibular joint, or TMJ, and facial pain."

Braces and wires gently place pressure on the teeth to change their position over time. Most adults will need to wear braces anywhere from a few months to about one and a half years. In most cases, it takes a single appointment for the orthodontist to place braces, with most patients feeling mild, if any, discomfort for less than a week afterwards.

"The science of orthodontics has evolved a great deal in recent years," said Dr. Bales-Kogan. "In general, the appliances we use today are less obtrusive, lighter weight, and more comfortable than the braces that were used in the past."

There are a number of different options available with pros and cons for each. This includes tooth-colored ceramic braces that are worn in the front of the teeth like traditional braces, but are barely noticeable since they blend in. These braces work equally well, but tend to be more expensive, they feel a bit larger in the mouth, and can sometimes stain during treatment.

"Invisible" braces, or aligners, which are removable, and get changed every couple of weeks, are very popular. However, they are an ideal option for only certain bite issues. They work very well for most crowding problems, and make it easier for adult patients to brush and floss during treatment, and keep the gums and teeth healthy.

Lingual (or concealed) brackets attach to the back of the teeth, and so are hidden from view. They work well for correcting teeth rotations, changing the heights of teeth, and closing spaces. However, having braces next to the tongue can take some getting used to and can affect one's speech. They are also more difficult to keep clean.

The more traditional metal braces, while visually more noticeable, are sturdier and work better for patients with significant bite problems or severely crooked teeth.

As a Federally Qualified Health Center Look-Alike, which is committed to making healthcare accessible to all individuals regardless of whether someone has health insurance, Union Community Health Center's costs are much more affordable than at a private practice, especially since

orthodontics is not typically covered by insurance for adults.

"The adults we see, as could be expected, are very motivated," said Dr. Bales-Kogan. "Unlike with children, who have little choice, they are coming to us to get their teeth straightened or their bite fixed because it is really important to them."

Any number starting with 900, 540, 595 or 871 charges a fee beyond a local call. In some instances, ads initially advertise calls to a local number, but then direct callers to a second number starting with one of the paid exchanges. "Consumers must also question the legitimacy of vague classifieds because they too could be a scam. Before responding to an ad, consumers should verify the source of all information & always be wary about sending money or signing a contract with an unknown party."

Jack Finarelli, the SC, sent along a post while on his National Park road trip saying that a lot of super-star athletes don't have success trying to manage: "My hypothesis, which is not testable, is that great players are great because of their instincts or because of their physical prowess. Neither of those things is "coachable." Therefore, the great player has difficulty explaining to his young wards how to do what he had been so good at doing. Consider a few examples:

"Ted Williams: He was the single best hitter I ever saw play baseball. Anyone who doubts he was a great player is an ignoramus. As a manager for three seasons, the closest his team came to winning the AL was 23 games; cumulatively, his teams were 41 games below .500.

"Alan Trammel: His first season managing the Tigers produced 119 losses for the season. He lasted two more years and those years combined to have his teams, 38 games below .500.

'Wilt Chamberlain: He actually coached an ABA team for a year. The San Diego Conquistadors - usually referred to as "the Q's" in headlines – finished 37-47.

"Bill Russell: Russell's initial success as a coach probably had a lot to do with the fact that Bill



White said. "Offensively the moves that she has, you won't see a lot of female basketball players do."

The missing piece in Augustus' mind is being able to hit 3-pointers consistently. It's especially important with her being projected to play on the perimeter as a small forward in college. She's taken the task seriously and is going to the gym with St. Francis Prep head Coach and Heat Assistant Kerri White two

to three days a week to take as many shots as possible. Augustus is happy with her progress so far.

"I feel like I will be unguardable once I add that to my game," she said

Augustus has already visited Georgia Tech and has checked out St. John's and Rutgers unofficially. She expects to take more trips after the travel ball season. She isn't in a rush to make a decision, but would like to have picked a school before her senior season starts at St. Mary's. She doesn't anticipate a new program being added to her list of possibilities. Augustus wants to be loyal to the schools that have been loyal to her.

She is coming off the best season of her career after helping to lead St. Mary's to the CHSAA Nassau/Suffolk title and a trip to the CHSAA Class AA state semifinals. She understands the team's goals will be set even higher

this year with much of the squad's main players returning to the roster.

It's nothing new to Augustus, who has learned to deal with high expectations. White has seen Augustus play harder more consistently this summer

"To have all those expectations on you when you're a young kid, it takes a while for you to grasp it and understand it," White said. "I just think it is part of the whole development as a adult."

Until November, Augustus' focus will be on developing her game further and being better prepared to help St. Mary's make a push at a CHSAA state title. She wants to leave little doubt in people's minds about her talent.

"It's just a respect factor," Augustus said. "I want to go out this summer and let everyone know that I'm the best."



# Hoops in the Sun tournament marks 15 years at Orchard Beach

The courts were repaved, the backboards improved and bleachers added, but the essence of the Hoops in the Sun streetball tournament remains the same as when it started 15 years ago.

New York City's lone beach-side tournament feeds off the vibe of its Orchard Beach home each summer on Saturday and Sunday afternoons. It has its own soundtrack — a beautiful mix of balls bouncing on the blacktop, the beats of DJ Unique blaring through the speakers and the clicking of chairs opening on the nearby sand.

"What makes it special is when it is a beautiful day and the sky is blue. You can count on Hoops in the Sun to be where you can bring your family and come to the beach and also watch great basketball," said Joe Cruz Jr., one of the league's two CEOs

It is what the Cruz brothers' father, Joe "Pops" Cruz Sr., envisioned when he started the tournament. His inspiration came from experiencing similar leagues during a trip to Venice Beach in Los Angeles. Joe Cruz Jr. and his younger brother, Randy, took over after their dad died of liver

cancer in 2004.

The courts are named after him and this year — the 15th anniversary of the league's founding — hit Joe Cruz Jr. hard emotionally. He felt a sense of pride after shepherding their father's

dream this far.

"If you would have told me 10 years ago when my dad passed away that I would have made it to 15 years I probably would have said, 'No,'" he said.

The league was in financial trouble back in 2009 when sponsors pulled out due to the poor economy. The Cruz brothers paid for almost half of the tournament's cost out of their own pockets. A year later Nike rejoined Mountain Dew, the Yankees and others as sponsors and Hoops in the Sun began to thrive again.

"Other sponsors have been tough because the money is not there and sometimes they don't see the investment into street basketball," Joe Cruz Jr. said.

Those who take the time to check out the tournament get to see some of the top players in the area in a safe and laid back environment.

Hoops in the Sun has 50 teams within its various di-

visions. There is no fighting to get into an overcrowded park like a spectator may encounter at Manhattanbased night tournaments such as Dyckman, EBC Rucker Park and Tri-State.

Longtime commentators Bobby "C" Cey and John "Uncle G-Stacks" Rowe don't spend games screaming catch phrases and nicknames into microphones. They call the players by their real names, speak about their backgrounds and provide humorous and insightful game analysis.

"It plays to the fans," Rowe said. "They look up. They are more interested when you find out where these guys are from."

Hoops in the Sun has come a long way from its humble beginnings. It included just two divisions, worn-out courts, double rims and a flip scoreboard at its start. Passers-by weren't sure what to make of it

"People didn't know what was going on," Randy Cruz said. "Was it a full summer tournament or a weekend thing? There was a lot of getting used to for the fans to understand what we were doing."

Hoops in the Sun has grown exponentially since then. Improvements to the court and a visit in 2002 from then-NBA All-Star Tracy McGrady put its professional-amateur and youth tournaments on the map and attracted a higher level of talent. NBA players like Metta World Peace, Ben Gordon and Jimmer Fredette have all suited up at Orchard Beach along with hundreds of other overseas pros and former college

"It's a lot tougher to play

outside in the heat, but it's always good because once you get inside, it makes it easier," said former Bishop Ford and UMass guard Chaz Williams.

The Cruzes understand the challenges of promoting a streetball tournament that is not in a residential area. Many people don't know where Orchard Beach is and there is \$9 parking fee because it's a city park.

Hoops in the Sun had an early and active presence on social media and shows its games live on Ustream to raise its visibility.

"For us, people have to travel," Joe Cruz Jr. said. "They got to pay to get here. It's a commitment."

It is one people continue to make. A consistent crowd, with many going from the beach to the court and back again, fills the stands and park benches each week. Some even bring their own chairs. Former Fordham Road resident Victor Goita remains a regular at the tournament despite moving to Cyprus Hills, Brooklyn. The hour and a half drive is well worth it in his mind.

"Anywhere you sit, you feel comfortable," Goita said. "There is good security, good music. You can't ask for more from a free game."

Despite their success, the Cruz brothers are still trying to come up with ways to give people more. It's what their dad would have wanted and what they've always strived to do.

"We think about him every day, every time you walk here and you see the plaque with the name on it," Randy Cruz said. "I just know if he was here, he'd be proud of what we were doing."



"If you need the space," said Al Neira, owner of Lehigh Wines and Liquors. "But if you don't need it, don't take it!"

#### Ticket blitz?

Both Neira and Kaid said that the local police have not helped the situation, giving out tickets to shoppers who double-park for a couple minutes to grab groceries.

"They are going around, giving tickets to everyone they see," said Kaid.

Leaders at Community Board 10 say one idea that could alleviate the parking squeeze would be to turn free parking spaces on residential Pilgrim Avenue a block away into one-hour spots, claiming that any new spaces would help the businesses that say they are already suffering a loss of revenue due to the parking woes.

"The store is usually packed this time of day," said Kaid when a reporter stopped by his supermarket just after noon on Tuesday, July 8. "Right now, it's not."

#### Commuters feel it, too

Local business aren't the only ones affected by the work. Commuters who normally take the Buhre Avenue subway now can take the Bx8 or Bx24 bus to Middletown Road and connect with a free MetroCard transfers.

The Metropolitan Transportation Authority says it is running added bus service between the Castle Hill Avenue and Buhre Avenue stations during morning and evening rush hours.

lion renovation to update the ward.

Torres, whose adjacent district is served by the hospital, has put pressure on the NYC Health and Hospitals Corporation since the unit closed last August, and led the effort to secure the funds in the City Council budget.

But Torres is just one of many who have worked to bring the services back to North Central Bronx.

"Above all I want to thank the community, the labor unions, the community activists, the mothers who were served here at NCBH who have worked hard to reopen it," he said. "It was your righteous outcry, it was your grassroots organizing that made this happen."

After NCBH abruptly suspended labor and delivery services in 2013 due to staffing shortages, community advocates pressed hospital officials to reopen, and

to involve the community in the process. In the past several months, the hospital has help public forums and met with the activists to assure them of plans to reopen in the fall.

"I want to thank HHC for seriously engaging the community, listening to the community, and putting together a serious plan to not only reopen the center, but staff it with senior-level professionals who will offer a higher level of care than we had before," said Torres.

At the last public forum in June, officials announced a target date of Sept. 22 for a state inspection.

So far, progress is on schedule to meet that goal, said Hannah Nelson, a spokesperson for NCBH.

All of the nurses for the ward have been hired, she said, and they're in the process of being trained at a higher level than before. Almost all of the doctors have been hired as well, and she said the head of the department is confident the unit

will have the staff it needs to open in the fall.

The \$2 million renovations will be also executed on a tight schedule to meet the goal, Nelson said, and they include an upgraded nurses' station, a patient-nurse communication system, and new operational lights for the older ward.


"Systems and technology have all changed a lot over the years," she said.

The flooring, lights, and paint-work are also being redone, among other improvements.

"It'll have a new look, and it'll give it a really nice feeling," said Nelson.
