# FRESH DIRECT BREAKS GROUND

## 5000,000 sq. ft. complex to open in Mott Haven

Online grocer and delivery service FreshDirect is relocating to the Bronx, but the move is not without its detractors.

A groundbreaking ceremony and program was held for the new 500,000 square foot production facility and office complex in Mott Haven on Monday, December 22, even as protesters outside of the gates on East 132nd Street could be heard chanting slogans in opposition to the project.

Most of the borough's political establishment supports the relocation of the grocer to the vacant, waterfront parcel of land on Bronx Kill, across from Randalls Island, arguing that the company's move from Long Island City will bring more jobs to a borough in desperate need of them, while and CEO Jason Ackerman in a allowing the 600 Bronxites

already employed at FreshDi- ment in the community. rect to work nearer to their homes.

But grassroots community groups, most notably South Bronx Unite, continue their protests of \$128 million in government tax credits for the company, as well as concerns about asthma in their community.

They claim the facility will add an additional 1,000 trucks a day to the area.

The mood inside the property at the groundbreaking was festive, with officials including Borough President Ruben Diaz Jr., Senator Ruben Diaz Sr., Assemblyman Marcos Crespo, Assemblyman Carl Heastie, and Assemblyman Jeff Dinowitz joining with FreshDirect co-founder show of support for the invest-

"I am grateful for the widespread support we have received for our relocation and am looking forward to continuing our record of creating local jobs and strengthening our local community," said Ackerman, adding "this is an important milestone for our company, allowing us to process orders more efficiently, expand our fresh food options, and make online grocery shopping more convenient for our customers."

In a meeting with the press after his remarks, Ackerman said there was no pending litigation about the site, and that all suits filed by groups in protest to the siting of the new facility had been defeated in court.

# School name up for grabs

Locals have started plaving the name game with a new public elementary school set to open in Van Nest.

Slated to open in fall 2015 in the former St. Dominic School building on White Plains Road, P.S. 311 is already garnering attention from those who would like to christen it, although the local Community Education Council has not yet begun the naming process.

Councilman James Vacca sent a letter dated December 15 to the CEC asking that the school be named after his predecessor, recently deceased Councilwoman Madeline Provezano.

"Madeline was a pillar of the community," the letter reads. "She successfully allocated millions of dollars to local schools and youth programs and dedicated her life to public service."

Soon after, a letter was sent to the councilman arguing that the Van Nest Neighborhood Alliance had already voted in November to propose naming the school after late Van Nest resident Benjamin Nolan, and alleged that the

councilwoman had neglected the neighborhood during her tenure.

Nolan was at one time president of the Van Nest Community Association, commander of the Van Nest branch of the American Legion and founder and president of the Van Nest Little League, in addition to serving neighborhood churches with pro-bono legal representation.

But Nolan's son, Robert, said that the inflammatory letter was written by one per-

# Bronx GPO to have retail, restaurants

Bronxites may soon have the opportunity to shop and dine at a landmarked building.

The developer who recently purchased the iconic Bronx General Post Office building at 149th Street and the Grand Concourse recently filed for a permit with the Department of Buildings which discloses construction plans for the site.

According to the permit application filed on December 10, Youngwoo & Associates has plans to put retail space and restaurants on the lower floors, as well as a restaurant and a roof-top terrace on upper floors. In between will be three floors of office space.

A spokesman for Youngwoo & Associates declined to comment on the subject, but said that more specific plans for the property would be revealed in January.

The developers are known for innovative projects including Delkab Market in Brooklyn and the in-progress SuperPier in Manhattan.

The spokesman told the Bronx Times in September that the developer intends to build upon the property's legacy as a trophy of the Bronx and as an iconic gateway to the borough, supported by the site's accessi-

bility to Manhattan.

"Ripe with immediate potential, our plans include providing new amenities for the surrounding communities and continuing our core business of developing ground-breaking projects that will improve the quality of life and economic productivity of the borough," he said.

The developers did bring their preliminary plans to the Community Board 4 office before filing for the permits, said district manager Jose Rodriguez.

Rodriguez said he was told that the developer wants to bring in boutique retailers, and that they plan to put an incubator for start-ups in part of the office space. He hopes further details will be discussed at a full board meeting in January, to which he has invited representatives from the firm.

Board members are very much looking forward to the developer bringing quality retailers and restaurants to the area, said Rodriguez. "It will enhance quality of life in

the district," he said. They were also happy to hear that

the plans include space for a post office within the building.

And although Rodriguez suspects some locals are still upset about the post office being sold without com-

# Toy drive helps children enjoy Christmas

A heartwarming toy drive combined the generous efforts of two charitable organizations once again this year to spread holiday cheer to children.

The Rotary Club of the Bronx and the Uguaglianza North East Bronx Sons of Italy Lodge #83, bought and distributed toys to children at five schools for special needs kids and a hospital's pediatric ward before Christmas Day, Thursday, December 25.

Children at P.S. 811 in Hunts Point, the New York Institute of Special Education in Pelham Parkway, Lavelle School for the Blind in Williamsbridge, St. Joseph School for the Deaf in Throggs Neck, Bronx Organization for the Learning Disabled in Pelham Bay, and at Jacobi Medical Center were all benefactors of the generosity, which had the support of local elected officials.

"We put on fundraisers throughout the year," said Sal Borgia, immediate past president of the Uguanlianza Lodge, explaining how the group raises money to buy toys and clothes. He added: "We try to give as many gifts as we can."

In addition to the toys, funds were also collected by his organization to take 10 needy families to dinner, said Borgia.

From the Rotary Club, Lilyanna Pekic, one of the organizers of the toy drive and holiday cheer effort, said that the effort started about six years ago when the owner of a Waterbury-LaSalle floral shop began it.

Gradually, Pekic said both clubs took over the giveaway and expanded it, and this year about 3,000 toys and forty \$50 gift cards for groceries would find a home with young people in need and their families.

Pekic said that the two clubs are responsible for the effort, but they are happy to have the support of local elected officials like Assemblyman Mark Gjonaj, who was on hand to meet with children and with Santa Claus at a giftgiveaway that benefited 120 children at St. Joseph on Friday, December 19.





When visiting with the children at Gjonaj said of the coordinators: "these are two originations that understand the meaning of generosity."

Pekic stressed that it is especially important to help special needs children because they are often marginalized.

"Different organizations have plans and for all of the other children, but these children are sometimes forgotten," said Pekic. "Because of this, we want to bring awareness."

Debra Arles, executive director of St. Joseph School for the Deaf which services children with hearing impairments from infancy to 14-years-old, said that the gifts make the holiday more enjoyable for the children, some of whom do not receive many gifts at home.





A new initiative at Bronx Community College will allow student mechanics to jump start their careers.

BCC, the Bronx Chamber of Commerce and BRAM Auto Group announced a partnership at a press conference at the college on Friday, December 19.

BRAM Auto Group, which operates 18 car dealerships in the region, will place students from BCC's automotive technology program into paid internships at five of their locations.

Martí said the arrangement would provide important opportunities for students while creating a skilled workforce in the borough. He praised the collaboration as an excellent example of private-public partnerships.

# Harlem River waterfront property sold

The sale of a south Bronx waterfront site is continuing a new development trend.

According to published reports, 101 Lincoln Avenue, located between Bruckner Boulevard and East 132nd Street, right next to the Third Avenue Bridge, was recently purchased

The 133,000 square-foot property, currently the location of a one-story warehouse and a large parking lot currently used by Oz Moving, was purchased by Manhattan-based real estate firm The Chetrit Group for \$32 million.

Haven Heights Group was the selling agent.

According to published reports, The Chetrit Group can build up to 800,000 square feet on the mixed-use lot.

Located within two blocks of the Clock Tower building, 101 Lincoln Avenue's waterfront location is just one subway stop away from Manhattan on the IRT 6 train, with other means of transportation in the area also available.

The property is in an R-8 zone, which means that there are no height restrictions, although it must contain adequate open space,


The sale of the property, which includes over 500 feet of water frontage along the Harlem River, follows another recent south Bronx deal - the reported purchase of an eight-story, 175,000 square-foot office building at 2417 Third Avenue by Horniq Capital Partners.

"The great view of Manhattan and the proximity to Manhattan without Manhattan's high priced rent is what makes this location special," said Sid Miller, owner of the Haven Heights Group, a real estate company that has specialized in south Bronx real estate for 25 years. "This site's location can stand as an example that people do not have to live in Manhattan to get a great view of it."

Miller also believes that the land currently being developed, as well as neighboring parcels, will be way more valuable in the near future stating that the "south Bronx will soon blossom."

"I believe that this was a win win for both sides," said Sid Miller. "Both the buyer and the seller are happy, and that has always been Haven Heights Group's primary goal."

The Chetrit Group and Community Board 1 were not available for comment.

# New date set on CI pocket park

City Islanders are hoping that a capital project at the southernmost tip of the seaside island will get underway sooner, rather than later.

A long-planned pocket park at Belden Point, where City Island Avenue meets the Long Island Sound, still has not started eventhough NYC Parks Department told the City Island Civic Association that construction was to begin by early summer, assoiciation officials claim.

The CICA wrote a letter to Department of Parks and Recreation commissioner Mitchell Silver dated Wednesday, December 17 expressing dismay about "many false starts" despite the efforts of the civic, the City Island Chamber of Commerce, the borough president's office, and Senator Jeff Klein.

"We were told this project would start early June and nothing materialized," stated the CICA in the letter to Parks. "Since that time there has been no new start date for mo-

"The design will define a vehicular turn around with an 18-inch-wide curb with bollards (vertical posts)," stated a

Parks spokeswoman. "A planting bed will be added to provide shade and enhance the waterfront views. The design will provide a decorative pavement, a landscaped area, street trees, benches, decorative trash cans, and a bicycle rack. A new sea rail will replace the existing chain link fence."

The Parks spokeswoman said that "the street-end plaza will address the need for public visual and pedestrian access to the southern point of City Island by improving the end of City Island Avenue."

The area where the park is planned currently has a dilapidated dock structure, and has also seen graffiti vandalism and dumping of trash in the past.


A park at Belden Point, with a seaside promenade, would complement one on the northern end of the island near the City Island Bridge, state Dolensek.

Klein said he shares the concerns of the islanders.

"We share in the frustration with City Island residents on the setbacks of this project," he said.

"Construction and groundbreaking on Belden Point Park is long overdue. To expedite this effort, I have written a letter to the Parks and Recreation Department, urging them to make this project a priority and to begin construction early this spring. It's my hope that under a new administration, Belden Point will become a valued destination for residents and their families, local visitors and tourists alike."

# Soundview has 'street light issue'

A scenario in neighborhoods of Community Board 9 has generated complaints regarding the safety of drivers and pedestrians.

According to residents from CB 9 neighborhoods, many street lights are not working in the neighborhood, particularly in Soundview.

Apparently, street lights along the Cross Bronx Expressway to the Cross Bronx Service Road North, just off of Rosedale Avenue, are out of order, creating a potentially unsafe condition for drivers who are forced to exit the expressway and merge onto the service road with little visibility

A Soundview resident posted a complaint online on Saturday, December 6, stating that "many street lights are out, especially where some traffic exits from the Cross Bronx Expressway - which generates a very dangerous situation at night, especially when it's raining."

Drivers aren't the only ones who are potential victims in this situation. Reportedly, the lack of many working lights on stretches of Bruckner Boulevard from Soundview Avenue to Castle Hill Avenue, has created a dangerous environment for pedestrians as well, who find themselves vulnerable once night falls and the street is dark.

Another Soundview resident expressed her opinions regarding the situation at a 43rd Precinct meeting at Kips Bay Boys & Girls Club, 1930 Randall Avenue, on Thursday, December 4, claiming that the dark stretch along Bruckner Boulevard "almost encourages acts of robbery and violence."

Soundview isn't the only neighborhood trying to deal with out of service street lights in recent weeks.

A majority of the street lights in Pelham Parkway, particular on the Pelham Parkway Service Road South from Williamsbridge Road to White Plains Road and on Pelham Parkway

Service Road North from Bronxwood Avenue to White Plains Road, have also not been working properly.

CB 9 district manager Francisco Gonzalez, who was not informed of the situation, stated that residents need to report instances such as these in order to generate more awareness among the community and its leaders.

"There have been no reports from community residents of street lights not working," said Gonzalez. "When situations like this are reported, we call 311, the DOT and local liaisons, as well as Borough DOT Commissioner Constance Moran to inform them and keep them updated. We deeply encourage residents to get in touch with Community Board 9 so we can address this situation and come to a solution sooner."



# Larry Allison, radio host, dies

A man who was an advocate for the disabled, who served in both Democratic and Republican mayoral administrations, and was a well-known radio personality from the local area, has died.

Larry Allison, of Spencer Estate, who served in three departments in city government from the Koch to Bloomberg administrations. rising to the level of assistant commissioner of Department of Information Technology & Telecommunications, succumbed to leukemia and other illness on Tuesday, December 16.

Allison was the co-host of the Vernuccio/Allison Report radio program in recent years, a show which began on WVOX in Westchester County, but went into national syndication reaching six radio markets from Lancaster, PA to Las Vegas, NV, as well as online at amfm247.com.

The radio program deals with national affairs and policy, and is affiliated with New York Analysis of Policy & Government, which publishes a review of issues affecting the United States.

His co-host Frank Vernuccio said that doctors determined that Allison died from complications of a longterm illness he developed working at Ground Zero after the September 11th, 2001 attacks.

A bio released at the time of his passing recalled "his unquenchable curiosity, his diligent research, and a fearless devotion to intellectual honesty."

show, it was the joy of his life," said Vernuccio, who added that Allison was a great talker who loved to have conversations and to communicate.

"He became deeply troubled by the course government had taken on the city, state, and federal levels, and diligently sought to restore common sense, integrity and Constitutional adherence," stated an obituary emailed to listeners of the Vernuccio/Allison Report.

He was a passionate advocate for the disabled, said Vernuccio, working on the issues related to the disabled as a young man in upstate New York, according to a bio, and later for the New York City Mayor's office, where he was employed from 1985 to 1991.

He worked at the city Board of Elections 1991 to 1995, and from DoITT from 1995 to 2001, according a spokeswoman.

Steven Kaufman, former assemblyman, remembers that Allison worked on a number of his election campaigns, and said he had a great sense of humor.

"The man was absolutely brilliant and had a phenomenal sense of humor," said Kaufman. "It was always a pleasure talking to him because he was very knowledgeable about every subject you could think of and he always laughed."

Allison is survived by his wife Jocelyn and daughters Amanda and Alynda.

Vernuccio said that Allison grew up in upstate New York, and came to the NYC for good when he was a student at New York University.





# food for thought

As one season comes to an end, another begins. Another year is ending, but a new one awaits on the horizon. As I look forward to what 2015 will bring, I can't help but ponder what 2014 has taken. In recent months, our community at large has lost some well known friends, people who have touched many of our lives through their friendship and service to our community. It is so important to keep them in our thoughts as we move through these changes. Let's try to keep their memories alive by supporting the many local community organizations that they supported.

Food and the sharing of food is the best part of the holiday season. Christmas is a few days away and we're going to my brother's for Christmas Eve. My sister-in-law is Swiss, so the traditional Italian 'Seven Fishes' meal is not on the menu. We're alone on Christmas, just us and the two pups, so we'll celebrate with our own version of this seafood feast.

Originally, I ordered a goose from Lewis Waite Farm and our plan was to share it with another couple on Christmas Day, but our friends ended up being unexpectedly out of town. The goose will stay in the freezer for a midwinter feast once they are back home. I froze some fish stock that I made this summer and will thaw it out for a nice seafood risotto. Beyond that, I'm winging it, trying to keep it simple. Keep it simple?

If you know me, you know that's not my modus operandi. In recent months, I have been trying to get the clutter out of my life, which of course starts with moving and getting rid of actual physical things. The other part is the clutter in my head, which is filled with ideas for projects that I want to do.

For example, last year I made my first attempt at pierogi. I did pretty good, but making 48 pierogi by myself was kind of lonely. Not to say that it wasn't satisfying, they were pretty tasty, but doing this kind of cooking has traditionally been something that would be done by a group of women, together. For example, this past August we spent a Saturday morning at the Locust Point civic making tomato sauce together. It was just four of us, but it was the best time I've had making sauce since the first time I did it which was with my mother in law, my mom and one of my sister in laws about 15 years ago.

Our stock making workshop back in April was a similar experience, with all of us going home with jars of stock and soup to enjoy. It was with that in mind that I decided to create a Pierogi Party and scheduled it for the Tuesday between Christmas and New Year's, when

a lot of us are on vacation. Since I have only made them once before, I'm doing a trial run two days before Christmas (might as well take advantage of the fact that I'm not cooking a big family holiday meal).

If they turn out good, and I'm pretty sure they will, I'll box up a couple of dozen and bring them as a gift for my sister in law. The pierogi's freeze really well, you just take out however many you need, boil or steam them for a few minutes and then brown them in butter. This will also give me the chance to have at least a dozen on hand for the party.

The test batch will be plain potato with some cheddar cheese, but the plan for the party is to have a number of vegetables on hand for a variety of fillings. We'll have the traditional potatoes, but also beets, turnips, celeriac and cabbage, plus some assorted cheeses and seasonings inspire everyone's inner chef.

That's tomorrow's plan. Today, I write this column at my kitchen table with the sound of boiling bottles on the stove as my background music. The plan is to sterilize bottles and then pasteurize the pear vinegar that I have been making. I started this process in the fall with the trimmings from the pears we harvested this season. A very interesting project that included a number of simple steps: fermentation, acidification and finally pasteurization. Once the bottles are corked, I'll label and wrap them up for distribution as gifts to friends and family. And of course, keep some for us too!

My hopes for 2015 are a continuation of my plan to rule the world, or at least to inspire you get in the kitchen and cook, start a garden or simply create your own kitchen traditions. Be the change you want to see in the world.

The New York City Health and Hospitals Corporation (HHC) is urging all New Yorkers to get vaccinated against the flu this year to protect themselves and their families before peak flu season kicks in around January and February. The flu is serious, contagious, and potentially fatal, especially for those with underlying health conditions such as asthma, diabetes and heart disease. Last year close to 2,000 New Yorkers died from influenza and pneumonia, which can develop as a complication of flu. It is recommended that everyone six months and older should be vaccinated for the flu annually. HHC hospitals and health centers offer flu vaccine for children and adults at little or no cost. New Yorkers can find an HHC facility in any borough to get vaccinated.

According to health experts across HHC, including Elizabeth Jenny-Avital, MD, Infectious Disease Specialist, HHC North Central Bronx Hospital, flu is dangerous for both adults and children, and it's unpredictable. "The flu is an incredibly contagious respiratory infection that comes on quick and hits a person like a ton of bricks. When the illness infects a community it spreads like wildfire, making vaccination so important," said Dr. Jenny-Avital.

"Flu is highly contagious and easily transmitted, so making sure that as many people are vaccinated as possible will help cut down on its spread," said Machelle Allen, MD, HHC's Deputy Chief Medical Officer.

HHC and Dr. Jenny-Avital of North Central Bronx Hospital shares five things patients need to know this flu season:

1. Who should get vaccinated? The flu vaccine is strongly recommended for anyone 6 months of age and older, and is proven safe for pregnant women.

2. When does the flu season start? The timing, length, and severity of the flu season can vary widely from year to year. In the U.S., flu often peaks around January-February, but flu activity can begin as early as October and continue into May.

3. Can I get flu from the vaccine? No, you cannot get the flu from the flu vaccine. If vaccinated individuals do become ill with flu-like symptoms, it is likely because they already contracted flu before vaccination, or have contracted some other type of contagious illness, such as a common cold.

4. Does the vaccine protect me from flu right away? No. It takes 1-2 weeks after getting vaccinated before you're protected from the flu strains in the vaccine. That is why HHC encourages New Yorkers to get vaccinated as soon as possible.

5. If I was vaccinated last year, do I need another flu vaccine this year? Yes. The vaccine offered in any given year is only good for that flu season, and is specifically developed to prevent the influenza viruses that are expected to be most prevalent that year. Each year the vaccine changes.

He remained in contact with many from that period in his life, and took pride in their achievements.

Larry was one of the most brilliant and loving individuals around, and truly passionate about his devotion to America's founding ideals. His convictions were the result of a life spent in public service, his unquenchable curiosity, his diligent research, and a fearless devotion to intellectual honesty.

He became deeply troubled by the course government had taken on the city, state, and federal levels, and diligently sought to restore common sense, integrity and Constitutional adherence.

## **Community** *Con Ed's gas safety patrol*

Con Edison said today the company is taking several steps to further enhance the safety of its natural gas distribution system in parts of New York City and Westchester County. These steps include significantly increasing patrols of the company's 4,300 miles of gas mains; working with outside experts to quantify methane emissions, and providing greater transparency over gas leak monitoring and repair. To help identify gas leaks sooner and prevent major incidents, the company said it has dramatically increased its system-wide patrols of gas mains from once per year to 13 times per year, an average of at least one per month.

"Delivering safe, reliable energy and protecting the environment are always our top concerns," said Con Edison President Craig Ivey. "By significantly increasing the rate of our gas leak patrols, we can spot potential problems sooner and better protect the public. A pilot program we began this past summer to increase gas patrols has led to this new commitment that we think will be one of the most aggressive detection programs in the country. We are enhancing public safety, working with outside experts to better manage methane emissions, and offering the public more information about how gas leaks are repaired or monitored."

"Transparency is always the best policy, whether you're talking about public safety or the environment, and Con Ed is to be commended for taking a national leadership position here," said Mark Brownstein, associate vice president of the Environmental Defense Fund. "Natural gas leaks are an important source of methane, a powerful greenhouse gas pollutant, and steps to reduce these leaks are not only good for safety, they are an important step in the fight against climate change. Finding and fixing gas leaks is not only a priority for Con Ed, it must be a state and a national priority."

Con Edison is working with EDF (www.edf.org/), gas measurement experts and other utilities to develop new strategies to quantify methane emissions from non-hazardous gas leaks. The purpose of this initiative is to prioritize the repair of such leaks, with the goal of accelerating a reduction in the rate of methane emissions from Con Edison's gas distribution system.

Methane emissions from natural gas distribution systems such as Con Edison's represent a small portion of the total amount of methane lost in the production and distribution of natural gas nationwide. Methane, however, is a significant greenhouse gas pollutant, and Con Edison is committed to reducing methane emissions from its gas delivery system as much as possible.

Con Edison also is working with the City of New York on an initiative to coordinate the replacement of leak-prone gas pipe when the city replaces sections of its water and sewer systems. The initiative will help Con Edison exceed its already planned commitment to replace an average of 65 miles of gas mains per year through 2016.

To promote greater education about gas leaks and how the company addresses them, Con Edison has created an online gas map (www.coned. com/gasmap) that provides the location of current gas leaks on its system, along with data indicating the severity of the leaks.

The map will be updated every 24 hours and is intended to provide greater transparency on current gas system leaks, as well as information about how citizens should report gas odors. More gas leaks tend to occur in the cold winter months than in other times of year due to the freeze and thaw cycle underground.

Any areas experiencing natural gas leaks found during Con Edison's patrols, or reported by the public calling in a gas odor, are made safe by field crews, and the location is documented and categorized based on the leak's severity and other conditions. This process applies to every confirmed leak, whether discovered by Con Edison's patrols, other emergency services personnel, or the public.

Leaks classified as Type 1 or 2 on the map are considered priority leaks, which the company immediately makes safe and repairs as soon as possible. The vast majority of gas leaks are Type 3, which are not considered hazardous but are monitored at least once per year. As conditions permit, such as during planned street excavations, Type 3 leaks can be scheduled for permanent repair.

Gas leaks can occur for a number of reasons, including pipe corrosion or accidents during street excavations. All leak repairs and leak-prone pipe replacement helps reduce methane emissions.

Con Edison reminds customers to call 911 or 1-800-75CONED immediately if they smell gas, and to call from a safe location away from the gas odor. Click here to learn what to do if you smell gas: http://bit. ly/1vnBqtN.

## Visit the dentist at Union Community

Tooth decay is the most common caries." childhood disease in America - five times more so than asthma – and the biggest reason for school absenteeism. While 5% of all children have uncontrolled dental problems, that number grows dramatically among poor minority children and the offspring of recent immigrants who combined have five times as many untreated cavities.

Yet, contrary to popular belief, the barrier is not economic. Most people in the Bronx know that insurance, including Medicaid, will cover the cost of their children's visits to the dentist.

"The problem is a lack of knowledge – many people think that since these are baby teeth that will fall out, caring for them is a low priority," said Dr. Paul Chu, a pediatric dentist with Union Community Health Center in the Bronx. "The focus of our energy is on educating both patients and pediatricians on the importance of pediatric dental health. Most people, for example, don't even realize that caries [cavities] is a communicable disease or that frequent snacking may cause environment where caries flourish,"

It's not uncommon, said Dr. Chu, to see children of elementary school age who have never visited the dentist.

"What people don't realize is that even if baby teeth fall out, not caring properly for them can set a child up for lifelong problems in terms of function - including chewing and eating - and, because of the pain, sleeping at night and performing in school," said Dr. Chu. "Early tooth loss or infections may cause cosmetic changes to the face and create serious, even life-threatening problems like cellulitis."

Cellulitis is a swelling of the soft tissue that may compromise one's swallowing and breathing. It can stem from an infection or an abscess in the bone surrounding the roots of the teeth due to poor oral health. It can be life threatening if not treated quickly and properly.

"We tell parents that they need to start taking care of their children's baby teeth, which means brushing and flossing, and being aware of certain medications that may create an

said Dr. Chu.

This includes always brushing with fluoride toothpaste, weaning babies off bottles by age one, and only giving children water before bedtime, reducing their juice intake, and replacing junk food, soda and candy with healthy snacks.

Pediatricians, he said, need to be vigilant in following guidelines set by the American Academy of Pediatrics when it comes to their patients' oral health and do a better job in coordinating care between doctors and dentists.

This includes understanding that disease can progress more rapidly in primary teeth causing severe dental disease and identifying early symptoms of tooth decay and risk factors. Dr. Chu and his team of attending and resident pediatric dentists make regular visits to pediatricians to reinforce the importance of oral health education.

This would also mean educating families on such things as the importance of not sharing utensils because bacteria can be transmitted through saliva, avoiding breast feedings at night once teeth erupt, uchcbronx.org.

introducing a cup as soon as the infant can sit unsupported (around six months) and trying to eliminate the bottle by the child's first birthday.

"In some cases, we've seen threeyear-olds with as many as 20 cavities," said Dr. Chu. "We're investigating alternative therapies, such as the use of pediatrician applied fluoride varnish or silver nitrate to managing cavities among such young children.

Yet, however you look at it, managing a young child whose mouth is full of cavities is never going to be easy. It needs to start with doing a better job of educating both the public and the medical professional on the importance of good pediatric dental health."



## St. Philip's Parish House on Boston Road

Much like Pudding Rock was a haven for Native Americans and the Huguenots traveling to and from New Rochelle, the nearby building at 1119 Boston Road was a haven for blacks. It was that way when the area was largely Jewish and again when it was a mixed community. That's the way it was as far back as the memories of those familiar with the neighborhood can conjure. It was a constant in an otherwise mobile community.

It was, therefore, quite a shock when I stopped by with Nick DiBrino and Tom Casey on December 3rd to look for someone to speak with that we found that the building had been razed. We had passed it only the week before but now the bulldozer was piling up the rubble of the ancient wooden structure. We were a day late. Another slice of Bronx history was obliterated but at least I was able to get a photograph of the bulldozer piling up the remnants of the old building.

The ancient one and a half story wood frame structure



and 167th Streets that was once the village schoolhouse would have many tales to tell if buildings could speak. It was old and dilapidated as far back as memories go and an 1893 report on the structure reads: "The mosses of a century seem to have gathered on the long slope of the roof and it appears in every part to be slowly withering to decay."

The writer continued saying that it still supported life and love under its mosses. The report then continued: "It was a desolate sort of blot on a new and dressy city landscape when I last saw it in the chill light of a November sun on a Sunday morning after-noon, but its desolation was far more eloquent than the sermon of a famous preacher which I heard that day.'

The old school house and on Boston Road between 166th church hall was taken over by


St. Philip's Parish House for the Aged and Colored in 1896 and the official dedication took place on May 1, 1897. The house was in the front and the chapel was in the rear. The Right Rev. H. C. Potter led the ceremony assisted by Rev. Dr. Victor Smith, Rev. H. C. Bishop, and Rev. Dr. Clifford. The chapel at the rear was built in memory of Cornelia Anna Guignon by her brother Peter W. Ray, M. D. It was supported by voluntary contributions and annual donation day events were held.

The home was actually founded in 1872 on Mulberry Street in lower Manhattan and soon moved to 127 West 30th Street. Its function was to provide a comfortable home for the aged, infirm and destitute members of St. Philip's Protestant Episcopal Church (colored). They seemed to find their niche in life when they

moved to 1119 Boston Road here in the Bronx in 1896 and just up until very recent times, people recall the old black men resting comfortably on their porch which occupied the entire length of the front of the building. They'll be missed as they had become an integral part of the community and the old parish house now remains only in our memories.

### The mayor's freshman-year report card by Tom Allon

Like manv Mayor Bill de Blasio had some moments of glory and some rookie stumbles in his first year in office. Now, as we head into the holiday season of good cheer (and school break), here is a brief report card on his performance in some difficult subjects:

PUBLIC SAFETY: It's hard to believe that major crime went down once again this year, continuing a remarkable two-decade-plus slide in a city many thought was ungovernable a in the early 1990s. Murders dropped once again and all major crimes were down about five percent from last year. Even more remarkably, all this was accomplished with a huge decrease in the use of "stop and frisk," one of the key crime-fighting techniques of the previous administration. The mayor and Police Commissioner Bill Bratton deserve huge kudos for keeping the city safe while also reforming "stop and frisk." Grade: A

EDUCATION: Getting universal pre-K approved in his first few months in office and then launching what is essentially a whole new grade by September definitely stands out as

the de Blasio administration's maiden year. There's no doubt that getting kids in school a year earlier will pay long-term dividends. On the other side of the ledger. however, the mayor still seems to have an aversion to charter schools, but is grudgingly allowing them to expand because they have a strong ally in Albany in Gov. Cuomo. Now de Blasio has to tackle the black hole of middle-school education, raise the overall highschool graduation rate, work on teacher development and retention and, of course, make sure the Common Core curriculum succeeds. There is lots of homework and tests ahead for the mayor and his chancellor, Carmen Farina. Grade: A-

POLICE-COMMUNITY **RELATIONS**: Some may say that the mayor is not to blame for the Eric Garner incident, lack of indictment and the chaos that has ensued with mass protests and the recent assassination of two cops. They may be right, but one of the downsides of being the boss is that along with the kudos, comes the blame when things don't go well. The mayor has tried very hard to skate be-

freshmen, the singular achievement of tween qualified support for the precedent with his hardball men in blue and feeling empathy for the family of Garner and the thousands of protesters who have hit the streets after the no-indictment grand jury. Gone are the days of a mayor who is absolutely, positively always siding with the cops; Giuliani and Bloomberg made an art of that and it invariably bruised the city's minority community at times. Now, with Al Sharpton back in the racial mix (where was he during the Bloomberg era?) and with city's tabloids fanning the flames of cop vs. citizen conflagration, we are witnessing a brush fire that may become a four-alarm blaze. The Mayor needs to become the "Uniter-in-Chief" and make both heads of the Patrolmen's and Sergeant's unions his besties, or this issue could engulf his next few years. Did someone say "Dinkins Redux?" Grade: D

AFFORDABLE HOUS-**ING:** The mayor hired a great team of people, including Alicia Glen and Carl Weisbrod, to spearhead his ambitious attempt to build more than 200,000 affordable units in the next decade. His first year, he definitely set a strong tone and

negotiation with the owners of the Domino Sugar Factory in Brooklyn. But the actual number of new units getting off the ground in the first year is not on pace with the mayor's ambitious long-term plan, so he may have to hit the remedial room in 2015 to make up lost ground. He also didn't help the affordable housing cause by hamhandedly campaigning for state Senate Democrats who lost badly in the recent election; with rent regulations up for renewal in 2015 in Albany, he does not have many allies in the state Senate's Republican majority. If a large chunk of rent-regulated apartments go to market rate in the next few years, the mayor will feel like Sisyphus as the net number of affordable units actually goes down during his first term. Stay tuned and watch how the mayor plays ball with Albany and the governor in early 2015. Grade: B

LEARNING FROM MIS-**TAKES:** The mayor probably needs to have more than a better alarm clock to make sure he shows up when he says he will; he needs a person he trusts to pull him out of bed, end meet-

ings or cancel unnecessary appointments so he can shake his reputation for tardiness. And in personnel matters, he probably needs to be more decisive in getting rid of non-essential staffers such as Rachel Noerdlingder when their alleged misdeeds start dominating the tabloid headlines. The mayor probably also needs to hit the reset button in his relations with the police unions; their antipathy was one of the things that sunk David Dinkins in 1993 -- and since the mayor had a front-row seat at that slow motion debacle he should be especially aware of the perils of upsetting the city's "thin blue line." Grade: D

He also stressed that about 80% of the funding for the project was private money, and that the tax abatements granted to FreshDirect were as of right because they were developing vacant land. He said that the tax abatements the company receives will occur over 40 years.

Manhattan got off to a slow start against Fordham, but it used its experience to bounce back.


