

PB SWEATS OUT REPAIRS

Tenants endure an elevator-less summer

It's been a long hot and frustrating summer for the 50 families living in a Pelham Bay building.

With the thermometer hitting near-record breaking temperatures, the residents of 1650 Hutchinson River Parkway have had to endure a non-working elevator for the past two months.

The situation is not new for this six-story building and continues a trend of elevator issues that have plagued the tenants for years.

The building's lone elevator has been experiencing problems for easily over a decade, according to the building's residents.

To make matters worse,

residents were told by the landlord that it won't be working again until the middle of September.

"This has been a consistent problem for at least ten years," said resident Ann Colucci, who has lived in the building for 37 years. "Sometimes the elevator is out for a day, sometimes a week and now its not working at all. This has left many residents feeling helpless and making us wonder what we can do about it."

This scenario has been especially difficult for Mel Fishman, who has lived in the building with his wife, Linda, for almost 20 years.

On June 19, Mel returned from the hospital after undergoing open heart and triple bi-


pass surgery as well as a heart valve replacement.

When he arrived home, he was approached by an elevator repair service employee who told him there was an elevator problem.

Mel had to endure a five-hour wait before the elevator was ready to manually take him to his fifth floor apartment.

"That situation was a true horror," said Mel's wife, Linda. "My husband needs to see his doctor, cardiologist and heart surgeon, and he can't leave the apartment unless the elevator is working again. In reality, the landlord needs to stop repairing the elevator and replace it with a new elevator altogether."

Mall at Bay Plaza's anniversary

The Mall at Bay Plaza celebrated its first birthday last week.

Prestige Properties, elected officials and shoppers gathered on Friday, August 14 to mark the anniversary of the mall's opening.

The 780,000 square foot mall opened to great fanfare last year, and is now home to over a hundred stores and numerous restaurants.

"It's a big day for us and the Bronx," said Sam Shalem, chairman and CEO of Prestige Properties and Development Co. Inc., the mall's owner and

developer.

Elected officials touted the mall, which was the first enclosed shopping center built in the city in about 40 years, as a major achievement for the Bronx.

"Where they said it couldn't be done, it was done, and it was done in spades," said Assemblyman Michael Benedetto. "It's wonderful when a dream comes through."

The mall has created about 1,700 permanent jobs, said Bronx Overall Economic Development Corporation president Marlene Cintron, many of whom were hired at the De-

partment of Labor's job fair at the site, which was attended by more than 3,000 people.

"It's projects like this that make such a difference for Bronx residents," said Cintron.

The mall has also brought the state \$12 million in tax revenue so far, which more than covered what the state invested in associated highway improvements, she said.

Attendees at the ceremony also applauded the arrival of a convenient shopping center with a multitude of upscale

Housing boom in Pelham Bay

A building trend that many leaders in Pelham Bay and other Bronx neighborhoods found troublesome looks like it is back.

The rapid development of multiple-family dwellings in east Bronx areas where there is currently a mix of apartment buildings and private homes seems to be increasing dramatically after the 2008-09 recession brought many of these projects to a standstill.

Councilman James Vacca has noticed a massive uptick in Department of Buildings filings for new construction of multiple-family dwellings in Pelham Bay and Pelham Parkway, recently.

The councilman has recently located DOB documents pertaining to new projects at 3066 Buhre Avenue, 1701 Parkview Avenue and 3109 Buhre Avenue, among others in community boards 10 and 11.

Another building was recently completed at 3064 Buhre Avenue.

"The building boom is back," said Vacca. "People are going to be seeing a lot of new construction and it is going to be significant."

In some cases, smaller homes are being torn down to make way for 18- to 25-unit buildings in locations where the zoning permits it, like Pelham Bay, which has a stock of older apartment buildings constructed before World War II.

This is a problematic end when it comes to parking and infrastructure, said the councilman, adding that much of the downzoning in last decade does not apply to areas where larger buildings already exist.

"Most people who live in the immediate vicinity of this new construction are not happy," the councilman said. "People are saying we don't have the infrastructure and parking, and that overdevelopment is a quality-of-life issue."

Many of the new and proposed Pelham Bay projects have plans that comply with parking rules calling for spaces for 50% of the units, said Vacca.

For example, the building proposed at 1701 Parkview has 22 units with 11 on-site parking spaces, and the one at 3109 Buhre has 18 units and nine spots.

Community leaders and one local

real estate broker seemed to concur with Vacca.

"I feel that Pelham Bay is starting to be overrun by these large developments," stated Michele Torrioni, Pelham Bay Taxpayers president. "I'd like to see some sort of law implemented (stating) that if you purchase a one- or two-family home, you have to build the same back."

Irene Guanill, owner of Meet the Sellers realty on Middletown Road in the community, said that many of the new apartments could be rented to social service providers, but also that it is not clear who the investors who build each project are targeting as prospective tenants.

"I have noticed the same trend, and it is still not clear who the units are going to be rented to," said Guanill, who added that tax abatements like the 421-a program and others are encouraging developers to demolish one-and two-family homes and replacing them with larger dwellings.

She believes this trend could have negative implications for the area.

Waterbury LaSalle Community Association board member Andrew Chirico added that local schools like P.S. 71 and P.S. 14 are already fully utilized and that more classroom space needs to be built before more housing is developed.

"We are going to need more than 50% parking; we are going to need 100%," said Chirico. "This is just ridiculous; I cannot say this enough times."

The developer of the recently completed building at Buhre and Jarvis avenues, Pualin Lumaj, said that the building is fully rented and was receiving the rents that he expected.

His latest project, next door at 3066 Buhre Avenue, should be completed in a year, he added.

Patty Justiniano, a local Pelham Bay activist, said that in the case of 1701 Parkview Avenue, the rest of this block, running from the corner lot where the project is, contains small homes and she feels that what is proposed does not fit with this surrounding context.

This is the same concern expressed when the project was first proposed, as the Bronx Times reported in 2009.

Documenting 311 complaints can be difficult

What started with great fanfare and expectations is today a mere shadow of its earlier self, claim many disgruntled users.

New York City's 311 complaint line has residents frustrated on how to properly file a report.

The phone operator's insistence of an exact address location when reporting a pothole or requesting a street light repair has many caring citizens wondering why isn't the agency being more user-friendly.

Other complaints made by resi-

dents, noted Community Board 11 district manager Jeremy Warneke, include the lack of follow up on their complaints..

According to Bronx residents, attempts to file a complaint using cross streets or street corners instead of an actual address number are rejected by the service.

However, there are many properties in the Bronx that don't post an address such as 2443 Poplar Street, 1750 Melville Street, 843 and 845 Morris Park Avenue as well as 1665 Yates Avenue, said Warneke.

This makes it difficult to identify the exact location, he pointed out.

As a result, 311 has refused to file these complaints.

"I stopped calling 311 after a while because it was becoming such a waste of time," said Linda Fishman, who has been without elevator service in her building for over two months, and has filed multiple complaints with the 311 and the Department of Buildings with an address number but, still, has not yet been responded to.

"The service was great when it was first started, but now they transfer you around the department and nothing ever results from it. Something needs to be done - especially regarding local complaints that aren't connected to the number of a building - because an address can't always be found."

In other cases, when residents call 311 to place a complaint, the 311 operator refers the call to the Department of Buildings.

However, according a 311 caller who wished to remain anonymous, DOB will not respond to the complaints because they have not been issued a 311 complaint number.

that usually can't be documented or filed with 311 due to the lack of address information.

Warneke advised residents to document their complaints with 311 again and again and obtain a 311 complaint number so it can be tracked.

If not responded to, Warneke encourages residents to call Bronx Customer Service at (718) 960-4710.



More funding ends BCA headquarters delay

The total renovation of the future Bronx Council on the Arts headquarters in Westchester Square has been on hold for the past four years due to inadequate city funding.

The process began back in 2011, when Chase donated the former Washington Mutual Branch at 2700 E. Tremont Avenue to the BCA.

Councilman James Vacca, who has twice allocated money for the project along with Borough President Diaz, said the project is now expected to be completed over the next 18 to 24 months.

"This whole process has taken much too long," said Vacca.

The long wait time has been very disappointing for the neighborhood, said Lisa Sorin, director of the Westchester Square Business Improvement District.

The NYC Department of Design and Construction initially solicited bids for the project last year, but the bids came in above budget and an additional \$1.3 million had to be requested and allocated in the next fiscal year's budget, according to a spokeswoman for the department.

A total of \$5.1 million has now been earmarked towards the gut renovation.

That second round of bids opened on August 14 and the city is currently at the beginning of the pre-award process,

according to the DDC, and construction is estimated to begin in the spring of 2016.

Now that all the money is there, the city needs to move swiftly and spend it, said Vacca.

In the meantime, the Bronx Council on the Arts continues to offer programming in Westchester Square and at other locations.

"While we're waiting for the brick and mortar location, the relationship continues to grow," said Sorin.

But the BID is extremely eager for the addition of more arts and culture to the neighborhood that will come with the new headquarters.

"I know that once it's up and running in the district, it will shed a whole new light on the area," said Sorin.

BCA will be an important element of the overall revitalization of Westchester Square, said Vacca, which has included other projects he's funded like the renovation of Owen Dolen Park, and he's eager as well for its arrival.

"I'm looking forward to the city moving on this," said Vacca.

Demand for crackdown on synthetic marijuana



Bronx elected officials, community leaders and health officials are looking to finally 'snub out' synthetic marijuana sales.

At a Wednesday, August 12 press conference at Jacobi Hospital's Trauma Center, Senator Jeff Klein, Assemblyman Mark Gjonaj, Director of Behavioral Health Services at North Bronx Healthcare Network Dr. Maryann Popiel, Director of the Comprehensive Psychiatric Emergency Program at Jacobi Hospital Dr. Benjamin Raatjes, community leaders and health officials demanded a crackdown on synthetic marijuana sales.

Working with community leaders and health officials, Klein's office has identified 24 Bronx stores allegedly selling vibrant, cleverly named packets of synthetic marijuana and staff at the senator's office had purchased K2 at EZ-Pass Gourmet Deli and Hairth Deli Grocery Corp in the past week.

"Synthetic marijuana is dangerous and poses a very real public health threat to New Yorkers, their families

and children as at least ten patients a week are rushed through the emergency room at Jacobi Hospital displaying frightening, erratic behavior associated with K2 use," said Senator Klein.

To combat "spice" sales resulting in nearly 700 emergency room visits at three Bronx hospitals in recent months, the senator has introduced new legislation to

fortify criminal and civil penalties to keep ahead of the synthetic drug trade.

According to the National Institute on Drug Abuse, "spice" refers to a wide range of herbal mixtures producing similar effects as marijuana and are marketed as a 'safe,' legal alternative under such names as 'K2,' 'fake weed,' 'Yucatan Fire,' 'Skunk' and 'Moon Rocks'.

These products are labeled "not for human consumption" as they contain dried, shredded plant material and chemical additives resulting in their mind-altering effects.

Synthetic marijuana is known to cause 'Excited Delirium Syndrome,' a state of extreme mental and physiological excitement associated with violent behavior, seizures, high blood pressure and elevated body temperature among many other symptoms.

"The biggest misconception about synthetic marijuana is that it's anything like actual cannabis," said Dr. Raatjes. "These are dangerous chemicals sprayed onto plant matter that can be overwhelming to

those using these drugs."

The K2 epidemic is prolific due to how easy chemists are able to continually tweak their formulas to subvert existing laws and regulations.

In an undercover purchase made by member of Klein's staff, a Bronx bodega owner retrieved 'Smacked!' along with other K2 brands hidden beneath the counter when requested by the customer and only charged \$5 for each five

gram bag.

"These drugs are easily accessible and are being marketed to children right in our backyard," said Assemblyman Gjonaj. "We must prevent the sale of these dangerous and life-threatening products."

Senator Klein will introduce new legislation adding 'synthetic cannabinoids' to the pre-existing crimes of selling marijuana under New York State's penal law.

His legislation provides five degrees of criminal sale, ranging from class B misdemeanor to a class C felony dependent on the weight of synthetic cannabinoid sold.

Klein also introduced legislation banning the sale of synthetic marijuana under general business law and will increase penalties bringing the first violation to \$2,000, the second to \$5,000 and third violation resulting in the loss of a store owner's liquor, tobacco and lottery license.

The senator will host a Friday, October 9 summit on synthetic cannabinoids at Jacobi Hospital with legislators, law enforcement and the medical community.

Play to premiere at the Andrew Freedman Home

The historic Andrew Freedman Home on the Grand Concourse will play stage to a brand new play this fall.

'The Fall of the Kings,' written and directed by Mai Sennaar and produced by Walter Puryear from the Andrew Freedman Home, will run from September 5 through November 1.

The production is described as "A new American drama with Afro-Caribbean roots."

Set in the south end of Boston in the 1940s, the play tells the story of an African-American heiress and her Caribbean husband fighting to sustain their family in the midst of an economic disaster.

The chronicle of the family's struggle includes themes of culture and identity, said Sennaar, a Maryland native whose first play, *The Broken Window Theory*, was produced at the famed Nuyorican Poets' Cafe when she was 19.

"Her play speaks to finding your place within a society," said Puryear, who also produced *Black Wall Street* in

2014.

Sennaar was introduced to Puryear through one of the actors, and it turned out they both graduated from New York University's Tisch School of the Arts, although several years apart.

Puryear, who has been involved in transforming the Andrew Freedman Home into a cultural center for the past several years, brought the play to the landmark, which was built in the 1920s as a retirement home for elite elderly who had lost their fortunes.

The grand old mansion turned out to be the perfect fit for the story, and Sennaar was able to integrate the setting into the play.

"The production does its best to bring the audience into the King's home," said Sennaar.

The production is also immersive, she said, breaking down the fourth wall and inviting the audience to participate at key parts.

Sennaar describes the tone as serious but entertaining, and said it strikes both funny and sad notes.

She hopes that people will connect with the characters on an emotional level.

Puryear is confident that the work will resonate.

"Brilliant is the word," he said.

Bronxites in particular will identify with certain themes, he said, such as holding on to identity in face of losing property, which is relevant to impending gentrification in

the borough.

"I think this play will provoke people to think about their own situation," said Puryear.

He also hopes it will inspire young Bronxites to pursue their artistic goals.

Producing *The Fall of the Kings* at the Andrew Freedman Home fits into its mission of bringing artists to the Bronx to create art that im-

act the community, he said.

The home is run by the Mid-Bronx Senior Citizens Council, which has been doing social work in the neighborhood for more than 40 years, and providing cultural opportunities is an important element of that mission, said Puryear.

Annual Farmers' Market hosted at Bissel Gardens

Fresh produce - from the Bronx?

An urban garden in the borough recently collaborated with local youth to assist and better the community.

On Wednesday, August 12, Bissel Gardens, a garden located on Bissel Avenue between Barnes, Bruner and Baychester avenues, hosted their annual Farmers' Market event.

At the annual event, local teenagers and young adults from the Youth Stewardship Program, ages 14-15, and the Summer Youth Employment Program, ages 16 to 24, sold the garden's fresh produce to the community and presented their ideas and projects about environmental justice, health and gardening.

During the six-week summer period, these individuals were taught how to maintain the garden - learning how to weed and harvest, among other tasks.

The garden's projects, which were presented by the teenage group, included 'The Fresh Vegetables of Bissel Gardens', which compared and contrasted freshly grown crops at Bissel Gardens with vegetables sold at a local supermarket, 'Weeds - The Game', which revealed therapeutic and helpful ways to pick weeds, as well as 'Touring Bissel Gardens', a walking tour that shared the history of the neighborhood surrounding the Bissel Pathway, the people who maintain the garden and identifying different crops that grow in the garden.

In total, 21 ideas and projects were presented from members of the garden's Youth Stewardship Program in front of an audience that included Councilman Andy King, Councilman Andrew Cohen, executive vice-president of United Healthcare Workers Dan Johnson and Assemblyman Carl Heastie, among others.

After the presentations, King announced his commitment to allocate \$8,000 to the Youth Stewardship Program.

A barbecue was also held to celebrate the end of both summer program.

"In my opinion, the Farmer's Mar-

ket had a more successful year than when I first started here," said garden volunteer Hailey Cotto, who started volunteering three years ago with the Youth Stewardship Program and was given the position as project director for this summer's group.

Over the summer, the 2.2-acre urban farm produced vegetables such as tomatoes, peppers, onions, string beans, colored greens, cucumbers and spinach as well as herbs such as basil, oregano and sage.

The mission of the Farmers' Market at Bissel Gardens is, and has always been, connecting and strengthening the community's local food economy as well as providing an aesthetic green-gathering space for residents, while keeping the focus on education, involvement, community and growth.

Gardener and board member Heather Warren-Dombrowa believes that Bissel Gardens would not be what it is today without the assistance of the many helpers and volunteers that have contributed to it.

"Bissel Gardens is definitely evidence that people working together can result in bringing community ideas to fruition," said Warren-Dombrowa. "To see this garden now as compared to how it looked 20 years ago is a reminder as to how much can get done from just volunteering and non-profit work."

Bissel Avenue, which was originally an abandoned and unpaved road, was transformed into a garden when a local neighborhood block association began the beautification effort in 1993, and by 1994, the garden was officially named Bissel Gardens, Inc.

As the years went on, Bissel members and thousands of visiting volunteers worked to create the five areas that now make up Bissel Gardens - The Propagation Area, The Children's Garden, The Community Garden, The Food for Others Garden and the Farmers' Market Area - each area striving to create projects that will assist and better the community, the Bronx and New York as a whole.

City Island Civic prez co-writes crime novel

A local civic association president, who is a private sector security expert, has written a novel with a former journalist about two characters in search of justice in a world inhabited by corrupt politicians and police officials.

The fictional piece by past New York Magazine journalist Craig Horowitz and Bill Stanton, City Island Civic Association president, is called *Badge of Evil*.

The book's plot centers around two characters: an investigative reporter named A.J. Ross, and a freewheeling private investigator, Frank Bishop, as they try to bring down power hungry New York City Police Commissioner Lawrence Brock.

The story hinges on Brock's take down of an alleged terrorist cell.

The flamboyant Stanton and the more reserved Horowitz both believe that their decades

of knowledge of how the inner circle of New York City politics and policing works provides the novel a believable plot.

"The novel basically is a thriller that has international and hometown terrorism, corrupt out of control cops, rap stars, drug dealers, and this kind of inside look at the corridors of power that we are able to provide because of our experiences," said Horowitz.

Stanton was once a business partner with a NYPD assistant commissioner Jack Maple, who is credited with developing the CompStat crime tracking system.

Horowitz penned stories about major New York crime cases, including one of the worst cases of police brutality in NYPD history: Abner Louima in 1997.

The men met while Horowitz was working on story about the Louima torture controversy. He needed a police perspective and interviewed Stanton, a former cop in the south

Bronx.

The book is for adults, indicated Stanton, and it is not for the faint of heart.


A quick scan of the first few pages of a draft version of the book includes characters engaged in intravenous drug use, prostitution, stripping, sadism and masochism.

Stanton and Horowitz have a three-book deal with publisher Regan Arts.

The writing process is collaborative, said Stanton, with the former private investigator coming up with general ideas for the book and then collaborating with Horowitz, a professional writer, to flush out the details.

"Everyone who knows me can say they hear my voice," said Stanton. "The irony here is that I could not articulate that voice myself. I needed my partner to capture that."

Stanton says he is more of a visual-oriented thinker, having grown up watching televi-

sion.

He said that the book would not have been possible without the collaboration with Horowitz.

Stanton is also an acclaimed television producer and has appeared on several network spe-

cial regarding personal safety and security issues.

After 20 years in New York City's media, covering numerous mayoral administrations and police commissioners, Horowitz now has a corporate communications career.

Schools can breathe better in asthma battle

In the midst of the Legionnaires' disease outbreak, borough and state politicians recently held a press conference to discuss solutions to another important Bronx health risk.

On Wednesday, August 12, Senator Kirsten Gillibrand, along with Borough President Ruben Diaz, Jr., Senator Gustavo Rivera and Assemblyman Michael Blake, among other politicians, hosted a press conference at the Children's Aid Society to discuss the US senator's fight for new measures to ensure that New York public schools prepare for and prevent asthma attacks in the future.

During the press conference, Gillibrand introduced the School Asthma Management Plan Act, a bill to ensure that schools are equipped to prevent and respond to students' asthma attacks.

The bill would provide funding for schools to train staff so that they are able to identify these potentially dangerous scenario and properly respond.

Funding would also pur-

chase medication and equipment for schools to improve classroom air quality.

According to the New York State Department of Health, approximately 34,000 children in the state were hospitalized for asthma attacks between 2011-13.

In addition, asthma causes students across the country to miss a total of 10.5 million school days.

In the borough, an estimated 9,320 children were hospitalized between 2011-13 in an area that struggles with one of the highest asthma rates in the country.

Children in schools suffering from asthma attacks can pose as a burden for entire families, as parents are often forced to miss work and travel to accompany their children.

Asthmatic students face challenges such as staying current in classes amidst absences and participating in sport-related activities.

There have also been instances of students falling asleep in class due to having trouble breathing and sleeping the night before.

Gillibrand is now working to ensure that the bill, which was passed by state Senate last month, will be passed by the U.S. House of Representatives.

"As asthma rates across New York and the country rise due to pollutants and smog, we have to make sure our schools have the resources to prepare for and prevent asthma attacks," said Gillibrand, whose son, Theo, suffers from asthma.

"More than 30,000 Bronx children suffer from this chronic disease, so the place where they spend so much of their time, our schools, must be ready. This legislation will make sure our schools have the resources to meet our students' health needs."

"The Bronx is grateful to Senator Gillibrand for her ongoing commitment to the health of New Yorkers and to my borough as well as for her School Asthma Management Plan Act," said Diaz, Jr., whose wife is a chronic asthmatic. "This law will provide students suffering from asthma proper help by

improving the communication between their schools and physicians, and will help improve the quality of lives of those suffering, and their families, from asthma."

Jonathan Soto to guide CAC

Mayor de Blasio has appointed a community organizer who got his start working with clergy in the Bronx to lead a new citywide Clergy Advisory Council.

Jonathan Soto, 30, a senior community liaison in the mayor's Community Affairs Unit, will be guiding the new citywide clergy coalition.

This comes after working extensively in the borough as policy director with the Bronx Clergy Roundtable and as the leader of Bronx Long Term Recovery Group, an organization seeking to empower affected communities to recover from Hurricane Sandy.

The Civil Rights Movement and the philosophy of Martin Luther King Jr. informs his social justice philosophy, he said, adding that he believes this new position is an opportunity to address the specific needs of individual New Yorkers, as well as systemic issues through shaping public policy.

"I am honored to have the

opportunity to work with diverse faith leaders and communities, as well as partners citywide on crucial issues for our city," he said. "I look forward to working with the new Clergy Advisory Council to build an important and effective bridge between city government and residents."

Soto noted that CAC, comprised of 53 members from pretty much every faith and ethnic group that comprises the city, would seek to reach out to the outer boroughs.

"This administration has been very explicit about reaching out to the outer boroughs and traditionally underrepresented communities," he said. "So, that is going to be one of my main tasks; and my social justice theology really kind of frames that constituent driven approach we have taken."

The CAC seeks to establish a direct line of communication between local faith leaders in all boroughs and City Hall.

One of the first conditions the coalition will address is

that of homelessness, said Soto.

Soto spoke of the way he sees clergy help homeless people and those in need, providing a window into his ideas about the work of religious leaders.

"What has always caught my eye is when they approach somebody in need they don't just give them a solution for the afterlife," he said. "Their concern is (also) about their present circumstances: whether they are sick, hungry or in need of shelter."

All faith leaders address the spiritual and earthly needs of their congregations, he said. His parents were ministers and missionaries, he also said.

When he was at the Bronx Clergy Roundtable, he worked to establish a mentoring program for young people and improve community and police relations through programming, he said.

He assisted BCR on various organizing programs.

Soto said he discovered

the BCR while working for a healthcare company shortly after his graduation from Fordham University, when he attended a forum on police and community relations.

In a statement, Mayor de Blasio said that Soto had been brought on as senior liaison to facilitate the administration's engagement with religious communities.

"A seasoned and inspired community leader and activist, I'm confident that Jonathan will bring us closer to communities of faith to ensure that New Yorkers can provide essential feedback and benefit from what our city has to offer," stated the mayor.

Soto is expected to graduate from Brooklyn Law School in 2016.

Ghetto Film School in contention for award

One Bronx-based organization is being recognized for its work educating the next generation of filmmakers.

The Ghetto Film School was recently named a semifinalist in the 9th annual New York Community Trust Nonprofit Excellence Awards.

The film school is one of ten semifinalists across the five boroughs, Westchester and Long Island who are in the running to win \$60,000 in prizes as well as tuition scholarships for the Columbia Business School Executive Education Programs in Social Enterprise.

Six finalists and then three winners will be announced later this year.

The Ghetto Film School was founded by president Joe Hall and started as a summer program out of a store front in Hunts Point almost 15 years ago.

It transitioned into a full-time program in 2004 in Mott Haven and later opened the nation's first public film school with the Department of Education in 2009 called The Cinema School.

The idea rose out of Hall's experience at film school at University of Southern California, where he realized there was a lack of diversity in film making, said

GFS artistic director Derrick Cameron.

So he returned to the Bronx, where he had roots as a community organizer, and started teaching high school students film.

In addition to providing programming for The Cinema School's film curriculum, GFS also offers an intensive fellowship for a select group of the Cinema School's junior and seniors with after-school and Saturday programming. They also run the Digital Bodega, a professional production company that gives alumni paid opportunities to

grow their film reel and supports GFS with additional revenue.

GFS also provides instruction for students about professional skills like networking, and helps them establish contacts in the business, said Cameron, and a recently established outpost in L.A. will support students if they move west to pursue the craft.

"We're the Coppola family for students that don't have connections in the industry," said Cameron.

In addition to teaching teens how to write scripts, work a camera, and use editing programs, a filmmaking education also provides lessons about collaboration, problem solving, and empathy, said Cameron, which are valuable whether or not they decide to pursue careers in the field.

"Storytelling in general lends itself to transferable skills," said Cameron.

A recent graduate of the Cinema School and participant in the fellowship, Natalie Popoter, said GFS helped her grow and gave her real-world skills.

"This program really helps you see things, and not just from the filmmaker perspective," she said.

Popoter recently traveled with a small group of students to produce a film in Spain based on a script she wrote, which she called a life-changing experience, thanks to GFS.

Being part of the NYCT's ongoing awards process has given GFS a chance to evaluate the many things they're doing, said Cameron.

"It really allows you to reflect as an organization," he said.

The 10-month process involves application workshops and multiple rounds of interviews that act as a kind of group training and coaching for the more than 50 nonprofits who participate, said Michael Clark, president of the Nonprofit Coordinating Committee, which created the Nonprofit Excellence Awards in collaboration with NYCT and Philanthropy New York.

"It's a lot of work, but people keep coming back," said Clark. "It amounts to expert consulting."

The awards are sponsored by WNYC as well as supported by The Clark Foundation, Ford Foundation, McGladrey LLP, and Columbia Business School Executive Education Programs in Social Enterprise.

Furniture lottery held at Crawford Houses

A unique lottery drawing saw one lucky new tenant get \$5,000 in apartment furnishings for free.

MacQuesten Development, the developer and contractor of the new 84-unit, eight-story Mother Arnetta Crawford Houses in Crotona Park East, held the drawing on Tuesday, August 18 for a fully-furnished apartment decorated free-of-charge by the head of the company.

Rella Fogliano, MacQuesten president, sticking to a budget of about \$5,000, chose the apartment's furnishings to showcase what could be done in 800-square-feet. The apartment's furnishings had to be functional and attractive, she said.

The drawing in the furnished apartment brought together tenants and those who plan on moving into the 100% affordable housing building.

The winner, selected at random, was Gloria Velez, who will be living in the furnished-for-free digs with her daughter Nicole Fino.

Velez said she might have

had to buy all new furniture because of the configuration of her previous apartment, and that having a fully-furnished start in the building was a big help.

"I did not expect (to win)," she said. "It was God's plan."

Velez let out a large, jubilant cheer when she was announced the winner.

Fino said that she and her mother did not expect to win the drawing, held inside unit 3G.

"This year has been very rough for us," said Fino, citing financial difficulties, and adding that the win was a blessing.

The selection of the furniture was done over a weekend, said Fogliano, who added that even for the tenants who did not win, the new building pushes the envelope in terms of building materials that blur the line between luxury and affordable housing.

"We used extraordinary materials," said Fogliano, who went on to explain that the materials used are sustainable and may soon be LEED Silver-certified, a certification from the Green Building Council.

For tenants in the all-rental building, there will be bamboo flooring, anti-microbial Flexco® corridors and also Italian-made kitchen cabinets and fixtures with high quality wood and hardware like those that are usually found in more expensive, upscale apartments.

"We went a little bit above and beyond because I do believe in not only sustainability, but also beauty," she said.

Fogliano added: "My hope is that everyone who moves into our newest affordable housing building will find a happier life here."

According to MacQuesten,

80% of the building, located at 1500 Hoe Avenue, is already leased.

The 78,000 square-foot building includes two recreation areas, an outdoor play area, a ground-floor parking garage, and views of the Manhattan skyline.

Lenore reminds us of the smells of summer

Summer in New York is nothing if not pungent. So pungent that there are certain smells that conjure up a New York August the way the smell of crayons whisks you right back to first grade.

"I used to work in Flatbush and in the summer the fish store kept its door open," recalls Megan Perleshi, a mom of two who has since moved to Long Island. Every time she neared the shop she would literally sprint out into the street until she was past the miasma. The aroma? "Fish and garbage."

It is a city summer combo others remarked upon, too.

For marketing consultant Amanda Hass, it is the smell of dying flowers that she associates with the Upper East Side in August.

"Most residents are gone to their summer places," Hass says. So the bodega flowers wilt right along with the rest of us, giving off a sad scent. By contrast, Hass added, the open windows to hot laundry rooms give the air a fresh Clorox smell

that makes up for the funereal flora.

Rain in the city summer also has a special smell.

"Warm rain on hot asphalt in Brooklyn is a memory I've carried with me my whole life," says media strategist Liz Polay-Wettengel, who now lives in Massachusetts.

Business editor Patrick Rizzo, still here in Gotham, is specific in the type of rain that brings him back: the sudden sun shower.

And then there are all the foods smells on steroids the minute the mercury hits 90. Walk by a greengrocer and the peaches are positively seductive. They make you want to eat healthy.

There are also the smells that make you want to eat charred meat — lots of it, immediately, even if you are a vegan with a history of heart issues.

"Walking through the park on the West Side Highway in that huge multi-racial area of picnics, smelling delicious barbecue from all of the world..." That smell sends transit worker Mike Ecker into a tizzy.

The sticky sweet smell of

candied nuts does it for Tatum Barrows, a high-school grad from Long Island working in the city for the summer. For Martin Kleinman, author of *The Home Front*, it's "the wild scallions that grew along the fence to the V.A. Hospital in Kingsbridge."

He's right — neighborhoods have their own smells.

"The smell of anisette toast wafting from the Stella D'Oro Bakery as you whiz through Riverdale on the Major De-

gan Expressway" remains a local scent memory for Stacey Gordon and legions of Bronx dwellers.

At the other end of the city, lifelong New Yorker and clown entrepreneur (yup!) Michael Fandal recalls growing up in Coney Island, seven seconds from the beach.

"Summers included ocean air, rich and invigorating, and the smell of morning cold beach sand beneath the Boardwalk."

There were also Nathan's hot dogs and fries, overflowing litter cans, and stylish women in their summer dresses, all wafting their particular perfumes, which mingled with the whiff of coffee whenever anyone opened the door of a Dunkin' Donuts, and chlorine whenever you walked by a public pool.

Cut grass and freshly turned dirt send Michael Virgintino back to childhood in the Bronx, where he helped his dad tend their small yard and otherwise was constantly playing baseball on park fields.

Writer Nancy Mattia claims it is car exhaust that brings a smile. When she was growing

up in Bensonhurst, Brooklyn, Vito the Ice Cream Man would drive down her street on summer nights.

"Because I lived down the block, I would pass the back of his truck first with its engine running." Hence the association of associates exhaust fumes with joy.

And then there is the city scent that stands above — or really, below — them all. The one you smell without even descending the stairs. New Yorkers have likened it to "someone getting a perm in the sewer under a slaughterhouse," "the armpit of Satan" "inside the stomach of a sick animal" and perhaps most aptly, "a warm metallic smell with hints of urine."

Some day in some far off town you may catch a whiff of something similar and be instantly transported back to the New York City Subway on a sizzling summer day.

May that memory be sweet.

Or at least tolerable.

Don't tell Uber you can't fight City Hall

For more than a decade, I have experienced the very First World problem of not being able to find a yellow cab at 8 am on the Upper West Side of Manhattan or at 4 pm in Midtown.

In the morning, yellow cabs occupied by well-heeled New Yorkers pass me by as I fret over how I will make it on time to my 8:30 breakfast meeting. In short, supply never meet demand.

In the afternoon, I stand in front of my office building and wait ... and wait ... as hordes of cabs whistle by with their "Off Duty" light on heading back to their base at the end of their shift.

I brought up this issue with the Taxi and Limousine commissioner: Why can't there be more cabs on the street during rush hours? Why can't shifts be staggered so that fewer are "Off Duty" at a crucial time of the day?

Shrugs. "Sorry, there's nothing we can do," was the consistent reply. Frustrated and baffled, I vowed to leave

more time for my commute and to use public transportation during those tough taxi hours.

My bourgeois Manhattan-centric problem is much worse in the city's other boroughs, where yellow cab sightings are as rare as two-headed elephants.

And not surprisingly, in 2015, the once-monopolistic yellow cab industry is facing an existential threat from the so-called "sharing economy," as tech behemoths like Uber have rapidly and elegantly filled the breach of this transportation problem.

Uber is now in 400 cities worldwide, but make no mistake, New York is its largest and most important market.

That is why it recently launched a thermonuclear counterattack when Mayor Bill de Blasio tried to cap its number of drivers through a very ill-conceived piece of legislation.

Why would the mayor of the largest city in America try to limit customer choice and one of the biggest job-creating com-

panies in the city?

Well, the official stance was that the rapid expansion of Uber was causing congestion. Really? In a huge place like New York, a few thousand cars (which presumably would make citizens less likely to drive their own vehicle) was going to jam the already clogged transportation arteries of Manhattan?

No, actually something much more self-serving was at play here: the mayor has received hundreds of thousands of dollars of campaign donations from the taxi industry. Now, it was payback time.

But this attempted power play by the city's chief executive hit the buzz saw of lobbying, advertising, and good old-fashioned politicking of a multibillion dollar tech company that plays to win — and almost always does. Uber is here to stay — just like the apartment-rental tech company AirBnB — and any elected leader that decides to take it on, does so at their own risk.

What are the lessons from

this? First, monopolies — even those propped up by the government — are exposed to creative destruction just like media, music, retail, and many other industries have learned the hard way. Second, technology companies like Uber are just beginning to recognize their political power and this could also creatively disrupt politics as we know it.

If you're the mayor and you mess with Uber, you get an app that is seen by hundreds of thousands of voters that blames you for their wait times for a car.

But the most important les-

son is that the old-fashioned buying of candidates through huge campaign donations is not a sure bet to ensure success for your industry. Just ask the taxi medallion owners who are now seeing the value of their licensed assets plummet.

And the mayor, who let them down because he was pummeled by a company that wasn't afraid to fight City Hall.

Bronx Zoo storks foster abandoned eggs

A pair of lesser adjutant storks (*Leptoptilos javanicus*) at the Bronx Zoo have successfully hatched two chicks – one of which was from an egg produced by another adult pair. The surrogate parents are caring for both chicks as if they were their own.

In late May, Ornithology Department staff observed an abandoned egg left by a pair of adult storks that were inexperienced parents. A keeper moved the egg to an incubator where it was carefully monitored and determined to be fertile.

When hatching was imminent, the egg was marked for identification purposes and moved to a nest belonging to an experienced pair of storks already nesting. The female accepted the egg and completed incubating it alongside her own. The fostered egg hatched

on June 27 followed by the hatching of the pair's own egg on August 5. Both chicks have been accepted by the adults, and despite the size difference both are thriving.

"The successful hatching and rearing is a testament to well developed husbandry techniques developed as part of the Bronx Zoo's long-standing stork breeding program, said Jim Breheny, WCS executive vice president and Bronx Zoo director. "Working so closely with these birds at the Bronx Zoo gives us the opportunity to study and understand their behavior and reproductive biology. The information, knowledge and experience we gather here in NY is invaluable to the conservation of the species in the wild."

WCS has a long history breeding lesser adjutant storks

and the Bronx Zoo is one of only three zoos in North America to work with the species. Information learned about the growth and development of these birds has been shared with WCS researchers in Cambodia and helps inform their work with birds in the wild. Data on physical characteristics, growth rate and other important developmental traits help conservationists determine the ages of wild birds during census and monitoring.

Lesser adjutant storks are one of 19 stork species in the world. As adults, they stand between 43 and 48 inches tall and have a wingspan of nearly 7 feet. Their name, adjutant, is due to their military-looking posture and strut. Lesser adjutants can be found in mangroves, mudflats, coastal swamps, marshes, flooded grassland, lakes and

paddy fields. Their numbers have declined greatly throughout their range, mainly due to habitat destruction. WCS has worked to protect lesser adjutant storks in Nepal and has an active conservation program in Cambodia.

Early dirigible was constructed in Morris Park

I was looking through Nick DiBrino's book "The History of the Morris Park Racecourse and the Morris Family" when I came across this photograph of the Rice-Riggs Airship, "The American Eagle."

Joel Troutt Rice and John A. Riggs formed the Hot Springs Airship Company in Arkansas on February 24, 1908. Rice's first dirigible was dubbed "The Arkansas Traveler" and had a single engine and steel frame to support its frame which was in excess of 50 feet in length. Steering was achieved via three swiveling propellers.

It was not very successful, rising only about ten feet or so when Riggs suggested that they move to Morris Park which was already well-known for their work with experimental aircraft.

They came to New York and took part in the Hudson-Fulton Celebration which occurred between September

25th and October 9, 1909.

The celebration marked the 350th anniversary of Henry Hudson's discovery of the Hudson River and the centenary of Robert Fulton's first successful steam paddle wheeler.

The exhibition was titled "Flying Machines in the Big Garden" and featured about 50 exhibits of flying machines of every description, some tested and some untested.

"The American Eagle"

from Riggs and Rice was billed as "Seeing New York from Above." When it ascended from Madison Square Garden, it carried fourteen passengers affording them a marvelous view of New York City before a propeller snagged a rope and it was forced to descend.


Riggs and Rice developed quite a reputation and built the largest steel-framed dirigible in the world here in

the Bronx at Morris Park. It cost them over \$5,000 but, unfortunately was destroyed in a gale. Joel Rice was the mechanical genius that developed the dirigible while John Riggs was the capitalist who kept the funding coming in.

When Riggs asked for a greater controlling interest, Rice balked and a law suit evolved effectively breaking up the partnership. Riggs would later establish a newspaper which also proved successful.

Mentioning John A. Riggs (1867-1936) by the way, reminds me that he was a pioneer in woman's suffrage.

He was, in fact, called the father of women's suffrage in Arkansas. He was successful in almost every undertaking from ranching to patent medicine and politics. He served in the Arkansas House of Representatives and in 1917 introduced the bill granting women the right to vote which in turn led to that state's ratification of the Nineteenth Amendment to the Constitution.



The Rice Riggs Airship, the American Eagle, built at Morris Park in the old sheds. This was the biggest airship at the time to be built in America. John A. Riggs and Joel T. Rice, both from Hot Springs, Arkansas, came to Morris Park because of the talent that was assembled. The airship was 105 feet in length and weighed 1,040 lbs. (1909).

Even as the U.S. Coast Guard celebrates its 225th birthday, it endures the debilitating effects of budgetary neglect, with many vessels over half a century old.

The Coast Guard, which is now a part of the Department of Homeland Security, traces its history to August 4, 1790, when President George Washington approved a law authorizing construction of 10 revenue cutters.

The organization's \$8.1 billion dollar budget is inadequate to its worldwide mission, which has become far more difficult as aggressive actions by foreign powers strain its resources to the limit. Those actions range from Russia's militarization of the Arctic and countering the increasing amount of cyber attacks against the U. S., responsibilities which are in addition to the service's duties to rescue those in distress at sea and stopping the importation of il-

legal drugs. The Coast Guard is the only entity charged with both military duties as well as civilian law enforcement.

Retired Rear Admiral Terry McKnight, writing for the United States Naval Institute has called the Coast Guard the 'Forgotten Fleet.'

"No other service does more with less than the Coast Guard... For a service that has some of the most demanding missions to support our national security, the current departmental funding falls well short of the requirement... Even though the Coast Guard has taken on more requirements in the post Sept. 11, 2001 era the consequences of sequestration have started to directly affect some of the basic mission requirements. Like the Navy, the Coast Guard's fleet, will see a major reduction in the next few years and, if the trend is allowed to continue, this could jeopardize our national security. If the Coast Guard does not see an

increase in its shipbuilding account, the fleet of high and medium endurance cutters will suffer a major decrease in the next ten years..."

Speaking to the National Press Club last week, Coast Guard Commandant Admiral Paul Zukunft noted that his service played a key role in countering the cyber assault on defense personnel. He also pointed out that the Coast Guard, due its limited resources, is only capable of responding to 10% of the information it obtains regarding drug smuggling.

However, it is the extraordinary expansion of Russian military activity in the Arctic that poses the greatest challenge to the Coast Guard.

Ukrainian sources detailed Moscow's new and ongoing activities in that region:

"Russia has announced it is deploying new radar stations and fighter aircraft on islands in the Arctic Ocean as Russia increases its presence on the frozen continent amid a simmering territorial dispute over the energy-rich region. Moscow announced back in 2008 that it would use the Arctic zone as a "strategic resource base" for the development of Russia in the 21st century. Russia's territorial claims encompass an area of roughly 1.2m sqkm which Moscow hopes would secure the rights to billions of tons of oil and gas. But Denmark, Canada and the US all dispute this and also each claim huge swathes of the vast continent, which is predicted to become ice-free in the coming decades.

Ukraine Today reported in July that "The Russian Navy's Northern Fleet has started forming a new air force and

air defence system to protect the country's interests in the Arctic.

A major portion of Russia's increased presence is its fleet of icebreakers. A 2013 study by the U.S. Naval Institute noted that Russia had 37 icebreakers, plus four under construction. The U.S. totals was five, plus one under construction.

In his recent address to the National Press Club Admiral Zukunft stated that while the Coast Guard had seven ice breakers in 1977 when he entered the service, it currently has only two, "and only one of them, the 39-year-old Polar Star, is a 'heavy' breaker capable of cracking through ice that is 21 feet thick. Russia, which he said is "militarizing the Arctic," has some 20, with more under construction."

Both Fitz and Clare were respectively husband and grand-daughter of Bronx community advocate Myra Goggins-Squires; U.S. Army Specialist Joshua Phillip Fennell, 25, killed-in-action in Afghanistan; Bronx senior Morty Bruh, father of Bronx activist Mark Bruh; Bronx

senior Dennis Demers, 67 after a long illness, Dennis was husband of Bronx activist Marcy Guss Lewis-Demers; Edward Pollak, 80, father of former New York State Democratic chair David Pollak.

NY Giant super star and ABC sports commentator Frank Gifford, 84. Gifford was also husband to television hostess Kathy Lee Gifford on Today and Live with Regis and Kathy Lee; king of the one liners, comedian Jack Carter, 93; musician Chris Squire, 67, lead bassist with rock band Yes; television character actor George Coe. Coe appeared on the very first Saturday Night Live. He also has appeared on many TV shows including L.A. Law and Star Trek: The Next Generation. Last, but certainly not least, NAACP civil rights legend, the Honorable Julian Bond, 75. Bond was the charismatic and passionate chairman of the nation's oldest civil rights organization who worked with Dr. Martin Luther king, Jr. and Bayard Rustin in the 1960s. Bond distinguished himself in the fight for voting rights, the anti-Vietnam War campaigns and the War on Poverty. Bond also served in both houses of the Georgia State Legislature. Recently he led the fight for gay civil rights leading up to the new supreme court ruling on Marriage Equality. The streets of heaven is too crowded with angels. God Bless the memories of all of these honored dead...





Any number starting with 900, 540, 595 or 871 charges a fee beyond a local call. In some instances, ads initially advertise calls to a local number, but then direct callers to a second number starting with one of the paid exchanges. "Consumers must also question the legitimacy of vague classifieds because they too could be a scam. Before responding to an ad, consumers should verify the source of all information & always be wary about sending money or signing a contract with an unknown party."



Pelham Bay tenants forced to endure an elevator-less summer

"We have 80-year old residents and parents carrying strollers in this building - how are they supposed to get up and down the stairs safely?"

"Although the elevator has had a chronic break down history over the last 10-12 years, this particular situation is the worst that it has ever been since I've lived here," said Mel

"(The landlord) says that the elevator won't be fixed until mid-September, but after the elevator is repaired, it has to be inspected, which could take at least two to three more weeks, so (residents) will not see a working elevator until the end of September at the earliest. After all these issues, how does the landlord not understand that we need a new elevator?" he added.

Both Mel and Linda filed multiple complaints with 311 and the Department of Buildings throughout the summer but have not yet been responded to.

According to the DOB website, this building has received over a dozen elevator violations since 2002.

"There are residents in this building suffering without a working elevator while the landlord and superintendent are on vacation - they could care less," Mel added.

According to residents, landlord Amanda Jankovic of Rok Realty Corp has hired at least six different repair companies in the last decade.

Residents believe she switches re-

pair firms when she is told that she needs to replace the entire elevator - which she is not willing to do.

She then proceeds to hire a new elevator company altogether, someone that will comply to her wishes.

The elevator was previously out of order for nearly a month, along with the gas service, in 2012.

During the past year, residents claim the elevator has been out at least one day per week.

Senator Jeff Klein has been working with DOB to ensure timely completion of repairs, while also working with the Division of Housing & Community Renewal to receive rent reductions for tenants who have lacked elevator service in the past months.

Councilman James Vacca is also involved and currently has legislation pending that would make the landlord economically responsible for the installation of new elevators as well as entitle residents to rent reductions.

"A situation that has senior citizens and disabled individuals climbing steps with no option for an elevator is absolutely unacceptable," Vacca said.

Jankovic could not be reached for comment.

stores in one place.

The board has also been pleased that Prestige Properties has been receptive to concerns, especially about traffic, said Marano.


"Their doors are always open for us," he said.

For Clark winning his first Pro City title with Bingo is as good as it gets.

"There is no greater feeling," Clark said. "We won a lot of championships, but to win this tournament with Bingo in our first appearance with my brothers, it doesn't get any better than this. It's a great way to end the summer."

Clarke along with Anthony Glover started playing with Bingo when they were 12-13 years old at Riverside Church and they helped make the title special for the their longtime coach.

"These guys help me build Bingo's All-Stars and without them I wouldn't be who I am today," Cole said.

Bingo's All-Stars became the second team on three years to win Pro City in its first season. Sean Bell All-Stars, who Bingo beat in the semifinals, won in 2013.

Kerri Gallagher is preparing for the biggest race of her career. The Queens native and former Fordham University standout is racing in the 1500 meters for Team USA at the IAAF World Championships in Beijing on Aug. 22 and has herself ready to give her best.

"Training has been going really well," Gallagher said. "I had the opportunity to get some good workouts in after coming back from Europe. At this point it is all about maintaining fitness and staying confident which I think I am doing a good job with."

Gallagher, who runs for team Oiselle and NYAC throughout the year, and the rest of team USA are training for the meet in Narita, Japan. She is pretty calm and focused at the moment.

"It's a new experience making this type of time and cultural adjustment, but everyone here in Narita has been overwhelmingly welcoming," she said.

After qualifying for Worlds, Gallagher competed in the 1500 in the Diamond League race in Monaco. There she ran 4:06.07, one of her better times of the season, against some of the world's top runners. Gallagher took

gold in her final tune up before the worlds by winning the 800 at the Jentendo International running a 2:04.04. She is soaking up the experience she earned.

"Particularly in Monaco, it was very humbling and exciting to be able to line up in a field like that and really test my racing," she said. "It made me that more excited to keep pushing my boundaries and to compete at Worlds."

Following the Diamond League race, Gallagher took a break from competition and worked at the American Running camp. The camp helped add to her excitement of going to Worlds as he got a chance to interact with some great coaches and enthusiastic campers gearing up for their cross-country seasons.

"It made for a really special week before coming to Japan for final prep for Worlds," Gallagher said.

Gallagher is grateful for all the support she has received and he gets ready for the biggest race of her life. The event will be broadcast on the NBC family of networks.

"It is an incredible honor to be able to represent team USA," she said. "I am looking forward to the opportunity and am thankful for all the support from friends, family, coaches, Oiselle and NYAC for getting me here."

"You are not coming to strangers," Lincoln coach Kenny Pretlow said.



"It just gives us another versatile weapon to add to the way we played last year," the coach said. "We like to spread people out. That's a guy who can do it and finishes well. I'm looking forward to having him with us."

Brown is even more excited about who will be in the gym watching him. His family and friends will not have to travel far to see his final high school season unfold. He said many of them weren't always able to make it to games at St. Raymond. When asked how many people he expected at each home game this year, Brown didn't hesitate.

"Everybody," he said. "The whole of Coney Island is going to be there."

Motivated Clark caps stellar season with Pro City crown

It was personal for Keydren “Kee Kee” Clark this summer.

The former St. Peter’s College and Rice guard took his already stellar game to other level. He wanted to earn his first Pro City title with his long time coach Maxwell “Bingo” Cole and his Bingo’s All-Stars teammates for more than 10 years on the streetball circuit.

His 20 points, 12 assists and four rebounds in the championship game last Thursday ensured the Bronx native made good on his intensions.

“Mission accomplished,” Clark said. “It’s about time.”

Bingo’s All-Star held on to beat Big Apple Basketball 113-105 at Baruch College in the team’s first season in New York City’s top summerball tournament. Clark took home MVP honors to cap a stellar campaign. He was the league’s leading scorer at 28.6 points per game and second in assists with 8.1.

The 30-year-old Clark, who lead the nation in scoring twice at St. Peter’s, also dropped in 20 points, including a huge three late to lead Bingo past rival Sean Bell 94-81 in the semifinals. Longtime Bingo teammate and fellow Bronx native Anthony Glover called

Clarke the top point guard in the city and said this is the best he’s seen him play.

“He does more than two things,” Glover said. “He passes the ball, he rebounds the ball and everybody knows he can score. He does things off the basketball that makes him good. He’s definitely on another level this year.”

Cole said he is playing at the top right now and not all of it has to do with his prolific three-point shooting and slick passes. He understands how to get his teammates involved around his open scoring chances. Clark, who will play professionally in Turkey next season, is also more comfortable as a leader.

In the past he led by example. Cole joked that it took him five years just to get him to talk. Clark’s time overseas has taught him how important it is to be vocal, especially as a veteran.

“It’s something that grew on me,” he said. “It’s not something I like to do, but not it is just a part of me.”

The game itself has become easy for Clark at this stage of his career, but keeping it that way is not. In the past he would use his time on the streetball circuit as just a way to keep up his cardo up. This year he pushed

himself more, not just to ensure a championship, but to make certain younger players don’t pass him by when he heads back across the water.

“He’s really stretching out his pro career,” Cole said. “He understands what it takes”

Clark also knew it would take his

best to bring Bingo’s All-Stars at Pro City crown. The satisfaction of doing so was sweet.

“To finally get the money off my back and win it with no other team than Bingo’s All-Stars is amazing,” Clark said. “There is no greater feeling.”
