# **STREET CO-NAMED FOR** HISTORIAN. TWO

#### Bronx Times columnist honored

A longtime fixture in the Throggs Neck community who was one the neighborhood's historians was posthumously honored with a street co-naming.

Dill Place and Revere Avenue was co-named in Bill Twomey's memory and a sign was unveiled in his honor at a ceremony that brought together family and friends on Saturday, August 13.

Twomey, the Bronx Times Reporter's 'Do You Remember' columnist for three decades and a book author, was remembered for his analytical mind and for his being an inspiration and mentor to other people who wanted to know more about Throggs Neck and the borough's history.

The co-founders of the Bronx Times Reporter, John Collazzi and Michael Benedetto attributed the paper's early success to Bill's popular columns which first appeared in 1982.

was amazed that he had an endless number of snippets about local nostalgia at his fingertips, Collazzi said.

"He eagerly accepted an offer to write a column called 'Throggs Neck Memories'. That column endeared the upstart newspaper to thousands of readers. Bill almost singlehandedly insured the paper's success," the former publisher noted.

"Bill was a fixture in Throggs Neck," said Vacca. 'There were very few things in Throggs Neck that Bill was not connected to in a very positive way...by naming the street, I am putting Bill Twomey into the history books."

Twomey, along with the late John McNamara were Throggs Neck's historians.

In addition to history, Twomey was an activist, volunteering at local organizations, said Vacca.

These included Star of the Sea Cadets, Throggs Neck Home Owners Association and St. Frances de Chantal Church.

He also worked for the NY "Shortly after meeting Bill I Yankees as a tour guide at the old stadium.

# N. Bronx HIV facility nixed after public outcry

#### **BY ARTHUR CUSANO**

Plans to build a shelter for homeless New Yorkers with HIV were abandoned earlier this week after vocal opposition from neighbors and elected officials.

The renovation of an empty warehouse located at 4747 Bronx Boulevard would have created temporary housing for approximately 90 people at a time.

"From the board's perspective, we're very, very happy," said Community Board 12 district manager George Torres after the announcement was made Monday morning.

Torres credited the community for making its voice heard to both elected officials and City Hall.

A statement released by Councilman Andrew Cohen, Assemblyman Jeff Dinowitz and Congressman Eliot Engel Monday morning praised the mayor's office and city leadership for listening to residents.

"Now we must all work to ensure nothing inappropriate is ever brought to that site," Dinowitz stated.

In that same statement. Department of Social Services planned facility is Ana's

Commissioner Steve Banks explained the city had determined the location was not a viable location for a temporary residence or a shelter facility.

"We thank Speaker (Carl) Heastie, Council Member Cohen, Assembly Member Dinowitz, Congress Member Engel and their staffs for working collaboratively with the administration and we look forward to identifying alternative uses that will effectively meet the community's needs," Banks stated.

Banks could not be reached for further comment. Calls to the NYC Department of Social Services were directed to NYC Department of Human Resources Deputy Commissioner David Neustadt. A message left at Neustadt's office Monday was not immediately returned.

A public forum was held by Dinowitz and Cohen June 27 in which residents voiced concerns about what they saw as a proliferation of shelters and facilities aimed at high-risk populations in the northern part of the borough.

Four blocks from the

House, formerly known as the Project Renewal homeless shelter, which houses roughly 100 single men. The facility is named for Ana Charle, a facility director who was shot and killed by a former shelter resident in April 2015.

Another homeless shelter, Muller Center, is planned at a location just around the block that would house another 200 single men.

Torres said the availability

of cheap property in Wakefield makes it an attractive location to place special-needs facilities

"In my district, to say we're oversaturated would woefully underestimate the issue," he said.

Torres said the project was not only inappropriate for the location, but was in violation of the building's current manufacturing zoning designation.


The planned project was

a not-for-profit facility with a sleeping area component that would have been run by the non-profit Communilife. That would have required a residential zoning status, Torres argued.

"You cannot have a residential use in a manufacturing zone," he said.

Torres said the city needed to more evenly distribute such

# **MHHC celebrates \$2M renovation**

Morris Heights Health Center celebrated the completion of \$2 million in renovations that should help in its delivery of community-based health care.

The community-based health center had a lot to celebrate at a ceremony on Thursday, August 11.

Councilman Fernando Cabrera was on hand to cut the ribbon.

The renovations were funded by \$1.5 million in NYC Council Bronx delegation money and over \$500,000 from Cabrera in capital improvement funding, according to the councilman.

Gabriel Vonleh, MHHC president, said that Cabrera was instrumental in

securing funding from the city council, and said the councilman had come to the aid of the medical center when MHHC asked for help.

"What they have done is to change the entire look and feel of the atrium and some of our exam rooms, and Vonleh. "They have brought positive success to

this community, bringing (MHHC) to the level of any high end medical center."

In the ceremony celebrating the occasion, Cabrera said that MHHC was a beacon of hope in the community.

"It (now) looks like a very welcoming, inviting family health center right here on Burnside," said the councilman.

He added: "These upgrades greatly improve the quality of care provided to this community."

Among the improvements to MHHC was second and third floor upgrades to all patient exam rooms, renovations to an atrium, as well as new ceiling tiles, flooring and sinks.

They also include a new waiting area and fire alarm system, as well as improved air conditioning and ventilation, energy efficient lighting and asbestos abatement.

The celebration of the upgrades coincided with National Health Center Week, which was recognized at several points in the program.

As part of the week dedicated to recognizing the contributions of community based healthcare providers, Senator Gustavo Rivera presented a proclamation celebrating MHHC as part of the weeklong celebration.

The senator said that MHHC is a long-standing community center that is federally qualified to provide health care, and that the organization is "engrained in the community."

"The difference between (MHHC) and other types of organizations like hospitals, for example, is that they are based in the community, they are operated by people in the community, (and) they understand community issues," said Rivera, adding that people can get affordable and quality health care at MHHC.

Orlando Roboredo gave MHHC a proclamation from the mayor's office. Roboredo is Americorps program manager for the Community Health Care Association of New York State.

MHHC's LEAP Awards were presented to employees who exemplify the community health center movement.

Award winners were Merril Alexander, Jonelle Chang, Tommy Chen, Justine Flores, Heidi Kolman, Kay-Ann Lawrence, Kimberly Lopez, Dr. N'Gadie Kamara-Taylor, Johnny Urena and Amy Xu.

# Blaze displaces 8 families; 4 firefighters hurt

#### BY ROBERT WIRSING

A devastating blaze in Wakefield left eight families homeless and injured four firefighters last week.

According to a FDNY spokesman, on Tuesday, August 9 at 12:33 p.m., a fouralarm fire was raging at 636 E. 235th Street.

Fourty FDNY units and over 170 firefighters responded to the scene.

The second floor blaze started at the two-story home's rear wall and spread to four neighboring buildings before being brought under control two hours later.

No civilians were injured, however three firefighters were hurt combating the blaze. There were no fatalities.

Firefighter Patrick Morello, 34, with 11 years of service, suffered heat stroke after attempting to prevent the fire's spread on the roof. He was rushed to Jacobi Medical Center in critical, but stable condition.

Firefighter Joseph Brady, 51, with 17 years of service, suffered heat stroke and a

heart attack. He was taken to Jacobi in critical, but stable condition.

Lieutenant Joseph Martorell, 54, with 26 years of service, was treated at Jacobi for serious burn injuries.

The FDNY said a fourth firefighter was injured while traveling to the scene.

Responding firefighter Sean O'Rourke, 44, with 14 years of service, suffered a critical arm injury en route

from Queens to the Bronx.

At 3:44 p.m., O'Rourke's ladder truck struck a train pillar at Westchester Avenue and Waters Place, crushing his arm between the vehicle and the pillar.

He underwent surgery at Jacobi and is receiving continued treatment.

As of Tuesday, August 16, Brady and Martorell have been released from the hospital while Morello and

O'Rourke remain hospitalized, the FDNY said.

Fire marshals determined the blaze was caused by children playing with fire on a stovetop inside 636 E. 235th Street.

Michael de Vupillieres, American Red Cross New York Greater Region communications officer, said the American Red Cross provided eight displaced families consisting of 19 adults and

seven children with emergency funds to help them get through the next few days.

A NYC Department of Buildings spokesman said the agency issued a full vacate order to 636 and 634 E. 235th Street and a partial vacate order to 638 E. 235th Street for the second floor and backyard.



# **22 dogs found living with homeless veteran in SUV**

A Bronx rescue shelter is trying to place 11 dogs after they were discovered, as part of a larger group of 22 dogs, living in a car.

NYPD police officers recovered the dogs on Monday, August 8 in Pelham Bay from inside an old Mercedes Benz sports-utility vehicle.

The dogs belonged to a homeless veteran who has since been sent to a facility to determine her mental state.

Regina Galente, co-owner of the pet shelter Adore-a-Bullie Paws and Claws, discovered the dogs' living arrangement near the end of July.

She and her friend Monsie were coming out of a local shop when they spotted the dogs in the vehicle on a hot day.

Galente said her friend realized the woman was homeless and living in the car with the dogs.

Galente said they tried to help the woman but she was paranoid and refused their

help.

Instead, the shelter owner gave the woman her phone number and told her to call if she needed help.

By this time, she learned, the 45th Precinct was already aware of the situation but could not locate the woman because she was constantly moving the car.

According to Galente, a few days after her initial encounter with the woman, the woman called her because one of the dogs was really sick.

The dog, a small chihuahua, had some of its intestines hanging out of its rectum.

"Please let me take the dog, trust me," Galente recalled pleading with the woman.

Galente was able to get the dog to Petchester Vetinarians at which the chihuahua received surgery and fluids.

Despite, Galente's help the cd dog owner was still not willing to give up her dogs. m It wasn't until last Mon- b

it wasn't until last Mon-

day. that members of the community recognized the van and called the NYPD to save the dogs.

Galente said she received a call from Inspector Danielle Raia of the 45th Precinct to help with the recovery.

After the recovery, the dogs were bathed, checked by a vet and fed.

According to Galente, she took in 11 of the dogs and the others went to Bobbi and the Strays Animal Adoption Center in Long Island.

Galente said if anyone is interested in adopting a dog they should email the shelter at adoreabullie@gmail.com.

She said having a large amount of dogs can be "a burden on a small rescue facility" so the shelter is looking forward to hearing from interested parties.

The age of the dogs range from 1 to 3 years old and includes the chihuahua, a german shepard, chi/shitzu mixes, a cavalier mix and pitbulls.

# Critics decry unpopular road plan

It looks like a proposed roadway project that has stirred up a community is a fait d'comple.

One of the most fervent opponents of the 'road diet' plan that would reduce the number of travel lanes on East Tremont Avenue between Waterbury Avenue and Bruckner Boulevard advocated for quashing the plan at a town hall meeting with the mayor at Villa Barone Manor on Wednesday,

#### August 10.

Despite advocacy by merchant John Cerini, both the mayor and Councilman James Vacca, who hosted the meeting along with several community groups, said that they were in favor of the road diet plan. The plan would also create a dedicated left turn lane and new pedestrian markings at Whittemore Street.

DOT officials said at the meeting that they expect the lane change to be implemented

#### by September.

Community Board 10 rejected the plan developed by the NYC Department of Transportation in 2015, but Vacca moved the plan along after the fatality of a cyclist in June.

"We think this will save lives and protect people," said the mayor.

The councilman said that the group opposing the plan, by word-of mouth and robocalls, had spread misinformation.

"I thought that we handled it well by telling the truth about what it is," said Vacca, stressing that if for any reason the plan did not work, it could be reexamined.

"This is only paint (on the street)," said the councilman.

Cerini acknowledged that the 'road diet' protest comprised of members of the Throggs Neck Merchants, Throggs Neck Home Owners Association and Waterbury LaSalle Community Association, fell short.

"While I can appreciate and respect that they feel they are doing right by the community, part of doing what is right by the community is for them to listen to the constituents and have a discussion... instead of arbitrarily making a decision," said Cerini

during the dialogue on the 'road diet.'

Activist John Marano, who also opposes the DOT plan, said that the town hall did not offer much of a chance to share concerns regarding the lane reduction plan beyond an exchange between Cerini, the

councilman and the mayor.

"I think we are all in agreement that something definitely needs to be done along this part of East Tremont Avenue, and I just don't think the road diet is the way to go," said Marano.

"(It's) removing a needed lane from each side of the roadway away from us; it not only affects our businesses, but also our quality of life."



# Senior development slated at former church site

A new residential development, which will provide affordable senior housing, will soon be constructed at a former church site.

The price range of the rental units has yet to be determined, but it has been confirmed that the project will be financed by New York City Housing Preservation and Development.

The project will also cre-

The upcoming residence will replace the abandoned Home Street Presbyterian Church, which was constructed in the early 1910s and continued in operation until the late 2000s.

The Presbyterian church was abandoned after an electrical fire destroyed the furnace.

The church building will be demolished soon.

The developer, Bronx Pro Group, could not be reached for comment.

## Mayor: Rodman's Neck noise a legitimate concern

The mayor made statements in response to community questions at a recent Town Hall meeting about the city's plans to overhaul the NYPD facility at Rodman's Neck.

Mayor de Blasio was asked about sound abatement plans that are part of an overall upgrade to the NYPD's firearm training range and bomb squad on Eastchester Bay near City Island, Spencer Estate and Pelham Bay Park.

He said at the meeting at Villa Barone Manor on Wednesday, August 10 that city is committed to including the renovation in a 10-year Capital Budget in January 2017.

"I can tell you with assurance there will be an upgrade of Rodman's Neck and there will be soundproofing involved and included in that budget," vowed de Blasio.

As part of a complete overhaul of the range, costing between \$150 million to \$800 million according to Councilman James Vacca, sound baffling, a technique used at gun ranges to block gun-related sound from affecting nearby communities, will be included.

"Rodman's Neck is good news, but that still means that there is a process that we have to track," said Vacca, adding that he believes that the mayor has prioritized sound barriers.

Should the money be budgeted and the project designed, there would then have to be input from the community board, civic associations and neighbors before range rehabilitation plans were finalized and acted upon, said the councilman.

"It is not going to happen tomorrow," said Vacca of the Rodman's Neck renovations.

Barbara Dolensek, City Island Civic Association vice president, said that she has letters going back to the Dinkins' administration indicating that the NYPD was planning sound baffling at the facility, and expressed her frustration to the mayor about the lack of movement on the issue.

"We are still concerned about the timetable," said Dolensek after the meeting.



Only a handful of local community leaders have ever received permission to visit the NYPD facility at Rodman's Neck, but it remains a topic of concern. Noise from the waterfront range and detonation facility was discussed at a town hall with Mayor de Blasio.

She said that CICA would continue to advocate to get the sound barriers at Rodman's Neck constructed sooner rather than later.

"I am very happy that the mayor now recognizes that there is a problem," said Dolensek of the range noise.

"This is something that firing ranges all across the country do... there is no reason why they cannot speed up the timetable on it."

Another CICA board member, John Doyle, said that other mayors have made pledges on Rodman's Neck.

Mayor Bloomberg announced in 2007 that the range would move to a new police academy being constructed in College Point, Queens, only to have that plan ultimately abandoned because of lack of funding

In June 1993, Mayor Dinkins entered into a Memorandum of Understanding with the state legislature, he said, stating that the city would study sound barriers for the range.

"Until someone puts the shovel in the ground, it remains to be seen what will happen," said Doyle.

# Officials break ground on new fitness project

City and borough officials broke ground on Tuesday, August 16 on new upgrades to Pelham Bay Park, including new fitness equipment and a nature walk.

NYC Parks Commissioner Mitchell J. Silver, said the project "will improve the recreational space here in Pelham Bay Park" and added it will be beneficial to people of all ages.

The project will include a pushup and pullup bar, sit-up and dip benches, in addition to other equipment.

The equipment will be installed by the track near Rice Stadium.

Councilman James Vacca, who allocated money for the project in 2014, said "promoting exercise is especially important" to him because "people who want to exercise outside should have the opportunity."

He added that many people "do not have access to gyms or exercise centers."

He also said anytime he has a chance to improve Pelham Bay Park he seizes it.

Vacca also pointed to the Bronx's well-known health problem.

The Robert Wood Johnson Foundation and the University of Wisconsin's County Health Ranking & Roadmaps Report ranked the Bronx number 62 out of 62 New York counties when it comes to the health of its residents.

"The Bronx should not have an obesity problem," said Vacca, who allocated \$416,000

the for the project.

Borough President Ruben Diaz, Jr., who allocated \$200,000 for the project, pointed to his '#Not62' campaign which is an attempt to move up from the last place ranking.

He said borough parks are "critical to a healthier, happier Bronx" especially as the Bronx moves to complete it's health goal.

Diaz also said the upgrades

have "reinvigorated Pelham Bay Park" and provided a way for all types of people to "get fit and stay fit."

In addition to the fitness upgrades, the project also includes a nature walk - officially known as Pond Walk which was spearheaded by the Friends of Pelham Bay Park.

Judge Lizbeth Gonzalez, president of the organization, said the group wanted to "ensure that children of all abilities can experience nature upclose and in a playful way."

She added the group wanted the fitness equipment in the park to make sure people of all income levels can stay fit.

The councilman contributed \$100,000 to the nature walk and the Friends of Pelham Bay Park kicked-in another \$15,000.

Vacca echoed Gonzalez's sentiments saying it is "very important for our disabled community to have equal access to nature and the beauty that Pelham Bay Park represents."

"Many of our seniors and our disabled don't have that unless you provide accessiblity," said Vacca.

He added that women with baby carriages should also be able to use the handicap accessible facilities.

The nature walk will have viewing areas along an accessible path with additional viewing areas around a small vernal pond in the park's Playground for All Children.

The entire project is expected to be completed by summer 2017.

# Councilman Cohen calls for investigation of Bedford Park fire

Councilman Andy Cohen has called for an investigation into a fire on Thursday, August 11 at 267 E. 202nd Street.

Currently, the tenants and landlord 267 E 202 LLC - owned by Peter Fine, also the owner of Atlantic Development Group - are locked in a legal battle over the 160 violations on the brick building.

The fire heavily damaged the interior and exterior of the building. The NYC Department of Buildings issued a vacate order for the building.

Cohen said at a press conference the following day that the circumstances surrounding the fire were suspicious.

"I want to be sure there's no foul play here," said Cohen.

While not accusing the landlord of foul play, Cohen did note that the Bedford Park property suffered from "gross negligence at the very least."

According, to the FNDY press office the fire marshals are investigating the source of the fire.

So far, the fire marshals have determined the fire was electrical in nature and was caused by one of the building's air conditioners.

The investigation is ongoing and interviews with residents are still taking place.

Michael McKeon, a spokesperson for the Atlantic Development Group, was waiting to receive a report on the fire from the FDNY either today or yesterday.

"While we want and welcome a final determination of the fire's origin by FDNY, any implication of foul play is outrageous, reckless and not supported by any facts," said McKeon.

Andrew Darcy, an attorney from temporary housing.

MFY Legal Services which is representing the tenants, said the residents filed a lawsuit in March and currently have the landlord in Bronx Housing court.

According to Darcy the landlord wants to tear down the building to construct a highrise.

Currently, the six-unit building sits next to a parking lot which the residents believe the landlord wants to incorporate into a larger parcel.

According to Cohen, the landlord has used intimidation tactics against the residents.

Carlos Rosa, a resident of the building, said one day a worker arrived at the building claiming he was there to investigate some of the building's problems.

According to Rosa, the worker advised him to take the landlord's relocation offer.

Rosa's son, Carlos Rosa Jr, was seriously injured during the fire when he jumped out a window to escape the flames.

He is currently hospitalized.

McKeon said the landlord tried to help the residents and has made multiple settlement offers.

The current landlord purchased the property in March and - since buying the property - he has been addressing the violations, McKeon said.

Darcy said the residents want to be left alone in a violation-free apartment or to be given a fair settlement to relocate.

He said the previous settlement offers have not been enough.

The Red Cross and the NYC Housing Preservation Department have been helping residents with finding temporary housing.



# Jacobi trains doctors in rheumatoid ultrasound

Jacobi Medical Center has a training program in ultrahealth ailments related to ioints.

The hospital training program teaches rheumatologists, doctors that treat musculoskeletal diseases, to use ultrasound to obtain images of joints for patients who could be in suffering from conditions like torn rotator cuffs, gout and muscle tears.

Jacobi's program for patients and for training doctors. currently in its second year, is

called the Musculoskeletal Ultrasound Program.

The Ultrasound School of sound for doctors who treat North America Rheumatologists accredits it, and it recently trained four doctors, according to the hospital.

Dr. Beverly Johnson, a rheumatologist, lobbied the hospital's administration to purchase the equipment needed for the doctor training program which instructs fellows to use ultrasound and to better serve patients who are suffering from joint pain.

The Jacobi Auxiliary was able to donate approximately \$25,000 to purchase a refurbished machine, according to Johnson.

"We really wanted (ultrasound for rheumatology) in the hospital because it was something that we can offer both inpatients and outpatients," said Johnson, also adding "We are the only training program (of this kind for doctors) in the Bronx."

The program is very attractive to applicant doctors because ultrasound is one of the newest modalities for rheumatology, she said.

Using ultrasound to treat

joint conditions is something that can be convenient for patients and doctors alike because it can be done in the examining areas, according to the doctor and a spokesman.

The ultrasound machine can be transported around the inpatient floors, said Johnson.

This ultrasound technique for joint pain is not something that is particularly unusual in some higher-end medical cen-

ters, but it is fairly rare in a city hospital with a high-needs population, said a Jacobi spokesman.

Indeed, other borough hospitals sometimes have ultrasound machinery for rheumatology but Jacobi has the only training program, she said.

Using ultrasound is not as expensive as sending a patient to get an MRI and a CT scan,

said the doctor.

Being more cost-effective can be really important for needy patients who don't have insurance and must pay a fee for services provided by the hospital, explained the spokesman and doctor.

Johnson stated that having severe and constant joint pain has a profound effect on patients who need fast and longlasting relief.

"They can't climb stairs, they may not be able to walk and their ability to carry items is likely compromised," she stated.

Using ultrasound equipment for joint pain, doctors are able to target the painful areas and in many cases offer steroid injections that quickly provide relief.

"Without treatment, patients are disabled by pain," stated Dr. Tejas Sheth, a fellow in the training program. "These injections not only relieve pain, they increase patient satisfaction and provide increased functionality."



# WCS Archives project to process 13 collections

The **Wildlife Conservation Society** Archives has launched a project to process 13 important historical collections, making the materials better accessible to those who need them. The project is supported by a \$60,237 grant from the National Historical Publications and Records Commission

A total of 191.25 linear feet of archival material will be processed. Among the collections to be processed are:

Records of WCS president Fairfield Osborn: A leader in the modern conservation movement with a particular interest in the environmental effects of human overpopulation, Osborn served as WCS president from 1940 to 1968.

Records of Bronx Zoo general curator Lee S. Crandall: One of the most highly respected U.S. "zoo men" of his era and the author of Management of Wild Mammals in Captivity (1964), a foundational text of the zoo profession, Crandall began working in the Bronx Zoo's Ornithology Department in 1908 and served as general curator emeritus until his death in 1969.

Scientific illustrations done by the society's Department of Tropical Research, circa 1916-1956: Headed by famed naturalist William Beebe, the Department of Tropical Research led groundbreaking ecological studies in tropical regions from the 1910s to the 1960s; their observations were documented through scientific illustrations.

The collections document the mid-20th century American environmental and wildlife conservation movements. They reveal the evolution of exhibit design and animal care in zoos and aquariums, and provide exceptional glimpses into both zoo- and conservation-based activities in the United States.

The WCS Archives anticipates that this project will benefit its most frequent users: historians. Other common archives users—including WCS staff, genealogists, and those with fond memories of their own histories spent at WCS's zoos and aquarium—will also find great worth within these collections. The WCS Archives' collections are important because they record key events and aspects of the history of American zoos and aquariums, the history of New York cultural institutions, and the history of U.S.led wildlife conservation activities.

The project is scheduled for completion in June 2017.

#### 'Mommies Mingle' at **SBH Health System**

It's a scene reminiscent of a group sitting around a campfire. Only, instead of roasting marshmallows, the women are cradling newborns in their arms as they sit in an alcove of the maternity floor at SBH Health System (St. Barnabas Hospital), discussing such personally relevant topics as birthing and breastfeeding.

Welcome to "Mommies Mingle," a free program now being offered by the hospital to new moms every Monday, Wednesday and Friday morning.


"Many of the new mothers who deliver stay in their rooms the entire time until they are discharged, and never talk to each other," said Ann Hennessy, RN, director of Maternal Child Care at the hospital. "We thought encouraging them to meet outside their room where they could mingle with staff and with each other, would be invaluable."

Early reviews have been very positive. "Sometimes you don't feel comfortable asking a doctor or nurse something personal, but it's easy to ask that same question to someone who has just gone through the same experience you have," said one new mom. "I just came here from Puerto Rico and don't know anyone, so it was nice meeting other new moms I can be friends with once I leave the hospital," said another.

First-time moms get the chance to listen to sage advice offered by those who have just delivered their fourth or fifth child. Hennessy and other members of the clinical staff - including physicians, nurses and social workers - facilitate the discussion. A translator helps those women who have difficulty conversing in English.

The sessions are generally upbeat, but can get quite emotional. At one recent gathering, a new mom sobbed as she spoke about how nervous she was about her baby, whose delivery had been complicated when the umbilical cord wrapped around his neck. The problem was resolved and the nurses and other moms assured the woman that her baby was now doing fine in the hospital's Neonatal Intensive Care Unit (NICU).

"It seems to carry more weight when a mom hears something from another mom," said Hennessy. "For example, we are strong proponents of breastfeeding for the health of both the baby and the mom. When we encourage this, we sometimes get resistance. It seems to mean more coming from another mom who says she's going to breastfeed."



facilities in other parts of the city. "There really is no vision on what

to do with the homeless, and that's a shame," he said.

The Bronx Boulevard building is owned by Daniel Turkel, according to public records. A building permit was filed in April for his contracting firm, Liberty One Construction, to renovate and convert the existing structure into a transient hotel with accessory office space.

Torres said presenting the facility as a hotel was an attempt to circumvent the zoning regulations. Work seemed to be moving ahead at the site in spite of the recent decision, Torres said.

"Hopefully they're building a Hilton or a Marriott," he joked.

This past Tuesday a small bulldozer could be seen inside the building moving concrete debris out of the building.

Turkel declined to comment on the nature of the ongoing site work when asked.

"I don't know what you're talking about," Turkel said before hanging up.

Calls to Communilife spokesperson Illyse Kaplan and chief operating officer Michael O'Donnell for comment Monday were not returned by press time.

It has become disturbingly evident that there is a growing trend against free speech. The increased influence of international norms over U.S. standards bears a significant part of the responsibility, a pattern that will expand significantly when Obama's move to place the internet under international control becomes complete before he leaves office.

But the President's inappropriate internet divestment is only part of the problem. The number of excuses used to justify the disregard for America's greatest achievement—the First Amendment-continues to grow. Political correctness, college "safe spaces," campaign regulation, and other factors all play a role.

Of extraordinary importance is the desire of major communications companies to appease foreign dictatorships, in order to gain entry into their nations' marketplace. Disturbingly, U.S. internet giants have demonstrated their willingness to reject American free speech principles in return for access to foreign markets.

The Bloomberg News Service notes that: "In recent years, founder Mark Zuckerberg has made clear his intention to bring the platform to China. To win favor, much to the amusement of Chinese netizens, he's handed out copies of [General Secretary of the Communist Party of China] there was some room for non-

Xi's tome, The Governance of China, to Facebook employees: showed off his Mandarin skills; and posted photos of himself jogging through hazardous Beijing smog. It remains to be seen whether that multi-faceted courtship will be effective."

However, Bloomberg reports that Zennon Kapron, managing director of Shanghai-based consulting firm Kapronasia, believes that unless China's censorship rules are incorporated into Facebook's practices, the company will not succeed in its quest, noting that "All the kowtowing and meeting the leadership maybe won't matter so much if Facebook won't agree to allow some level of censorship, or allow the Chinese government access to data on the site, in exchange for market access," Bloomberg notes that 'Linkedin operates in China, but only by agreeing to abide by content restrictions."

China has moved to reduce its already limited tolerance for any semblance of free speech. TheFinancial Times notes that "Since Xi came to power, China's situation has become more and more worrisome,' says Murong Xuecun, a prominent author and commentator. 'Things that we could openly discuss before, such as the Cultural Revolution, are now considered sensitive or even forbidden. In the past



governmental organisations and rights lawyers. Now all of them have been suppressed.' In an internal document issued just a month after Mr Xi became president in March 2013 and later leaked, the Communist party identified the very notion of civil society as 'an attempt to dismantle the party's social foundation...That puts NGOs. journalists. activists. researchers at a much higher risk.....China's internet regulator moved to rein in original reporting by online news portals. in the latest setback for an already tightly muzzled media sector.'

Facebook has been increasingly criticized for its censorship activities, even outside of China.WND found that "Facebook...temporarily blocked talk-radio host Michael Savage from posting stories to his page after he put up a link to a story about a Muslim migrant killing a pregnant woman in Germany...In December, as WND reported, Facebook removed a post on Savage's site of photographs of a 2006 protest outside the Embassy of Denmark in London that featured signs warning of beheading and death for 'those who insult Islam.' At that time, Facebook

also 'determined that it violated Facebook community standards."

During the Cold War era, the influence of foreign information served to open up the closed societies behind the Communists' 'Iron Curtain.' Now, however, the reverse is occurring: the censorship proclivities of dictatorships of all kinds, Communist, Moslem extremists, or others, appear to be changing the free-speech culture of the West.

American cultural tolerance for the repression of free speech continues to grow. There has been little push back against U.S. Attorney General Loretta Lynch's comments regarding criminal prosecution of those that disagree with the White House's view on man-made climate change, or actions by state attorneys general to engage in legal harassment of think tanks with views counter to that of the President.

The trend is manifest on the streets, as well. The Gateway Pundit recently reported that "A young white man wearing one of Donald Trump's red 'Make America Great Again!' hats was violently forced out of New York City's City Hall Park by a screaming leftist racist mob of predominantly self-described 'black and brown' activists-all while police stood by and did nothing. The mob was gathered to protest police as part of a '#ShutDownCity-HallNYC' rally in the park".



# **Defeat of proposed shelter in Wakefield**

Councilman Andrew Cohen and Assemblyman Jeffrey Dinowitz announced that following their strong opposition, and the fierce advocacy by local community leaders, the plans for a proposed shelter on the northern end of Bronx Boulevard are dead.

The plans for the proposed shelter, which originally planned to house 90 individuals who are diagnosed with HIV, were proposed by the nonprofit organization Comunilife, and faced considerable opposition from members of the community. Dinowitz and Cohen held several meetings with both community leaders and Comunilife representatives over the last several months, to express their concerns regarding the oversaturation of shelters in the Wakefield community. Just four blocks from the proposed Comunilife shelter already stands the Project Renewal homeless shelter, which around the corner is the site of the proposed Muller Center homeless shelter, which plans to house over 200 single men.

On Monday, June 27, Dinowitz and Cohen held a town hall meeting at Community Board 12 where they voiced their strong opposition to Comunilife's plans, and were unanimously joined by community members and leaders from all over Wakefield. Following the town hall meeting, Mayor de Blasio's administration determined that the proposed location would not be appropriate.

"I am thrilled that I was able to help stop this plan for 4747 Bronx Boulevard by working together with Councilman Cohen, Assembly Speaker Carl Heastie, and Mayor de Blasio's administration," said Dinowitz. We stood together with our Wakefield community and listened to their concerns. The local elected officials, Commu-

houses 100 single men, and nity Board 12, and neighborhood leaders worked together and had a significant impact. I am grateful that Mayor de Blasio and Commissioner Banks heard our voices, and I thank Speaker Heastie for his leadership on this issue. Now we must all work to ensure nothing inappropriate is ever brought to that site."

> This news is a win for the Wakefield community. While we need to do more for the homeless, the Wakefield community is already oversaturated with numerous shelters currently operating in the neighborhood," said Cohen. "I am pleased that the Mayor listened to the local elected officials and community leaders and made the right determination that this facility is not appropriate for the community."

Department of Social Services Commissioner Steve Banks said, "After careful consideration, we have determined that 4747 Bronx Boulevard is not a viable location for a temporary residence or shelter facility. We thank Speaker Heastie, Councilman Cohen, Assemblyman Dinowitz, Congressman Engel and their staffs for working collaboratively with the administration and we look forward to identifying alternative uses that will effectively meet the community's needs."

"I am pleased City officials have listened to local elected officials and members of the community who said, in a unified voice, that this development was inappropriate for this location," said Engel. "Everyone agrees that the City must do more for homeless populations. However, it is unreasonable to expect one community to maintain this effort on its own. The people of Wakefield and the surrounding neighborhoods have done more than their fair share. It appears that DHS has come to realize that one more shelter within an area that already has been saturated with similar facilities just didn't make sense. I commend them for agreeing with the community and the elected officials to reach this point today."



# Vanilla Fudge lead singer came from the Bronx

I was recently reminded that most of my columns are oriented toward senior citizens.

Perhaps that's because I hear from them most often.

Someone suggested that I write about happenings in the 1960s and specifically mentioned the rock group Vanilla Fudge.

Since the lead singer of that group is a notable Bronxite, I could think of no reason not to comply with such a simple request.

Should I mention the name Vincent James Martemucci, it would mean very little to most readers. If, however, I shortened that to Vince Martell, those from the rock 'n roll era would immediately think of the rock legend who toured with Jimi Hendrix, the Doors, and other popular singers of that era. Martell was the lead guitarist and a vocalist with a couple of groups.

Vincent James Martemucci was born here in the Bronx on November 11, 1945 at 2537 Valentine Avenue just south of Poe Park and en-



listed in the U.S. Navy while by the Supremes, "My World still in his teens.

When his family moved to Florida in 1963, he began taking his guitar playing to another level and joined a rock group called Ricky T and the Satans. They played at the various

clubs throughout the Keys.

Then in 1966 he formed a group with Tim Bogert, Mark Stein and Joe Brennan called "The Pigeons."

Brennan was later replaced by Carmine Appice and the combo proved rather successful. They were offered a record deal and changed their name to Vanilla Fudge.

That group broke up in 1970 and Martell continued performing on his own. Vanilla Fudge re-united in 1984 to record their sixth album, "Mystery."

It was produced on the ATCO label and featured a hit is Empty Without You"

Martell recorded his first solo CD in 2000 on Spectra Records. It was titled Endless High" which included songs such as "All Your Lovin', "Bang, Bang" (My Baby Shot me Down), "Piece of My Heart."

His second solo CD was simply titled Vince Martell.

The following year, 2002, he released his third solo CD which was a tribute to his friend Jimi Hendrix.

The band re-formed in 2005 with the original members Tim Bogert, Carmine Appice, Mark Stein and Martell for a tour with Steppenwolf and The Doors.

The following year they recorded a 12-track tribute to Led Zeppelin titled "Out Through the Door" which was released in 2007.

It included the songs "Babe I'm Gonna Leave You"

and "All My Love" among others. He has since appeared at Radio City Music Hall and

numerous other venues and has now signed with Collectables Records. And the beat goes on ..

# WCS' 96 Elephants campaign looks to break Guinness World Records

The Wildlife Conservation Society's 96 Elephants campaign announced an ambitious effort to break the Guinness World Records<sup>™</sup> for the largest display of origami elephants to draw attention to the plight of Africa's elephants, which continue to be wiped out by ivory poachers.

From now until September 12, WCS's 96 Elephants campaign will urge individuals and organizations to make any of four different origami prototypes in an effort to break the current Guinness World Records<sup>™</sup> for the largest display of origami elephants currently held by the ZSL Whipsnade Zoo in Great Britain, which displayed 33,764 origami elephants in 2014.

The goal of 96 Elephants is to fold 35,000 of them - the number of African elephants killed each year for their tusks. To see templates and instructions visit 96 Elephants special webpage on the challenge.

The goal is to honor and generate awareness about the elephant crisis and the potential for this iconic species to go extinct within the decade due to illegal poaching for their ivory tusks. The campaign is partnering with other nonprofits, Origami USA, Origamido, 40 zoos around the country, the Children's Museum of Art and the Boy Scouts, Tommy Hilfiger and many more.

At WCS's zoos - including the Bronx Zoo, Central Park Zoo, Queens Zoo and Prospect Park Zoo - along with partners zoos, zoogoers can participate by creating their own origami elephants. Partners around the country are setting up folding stations and encouraging visitors and members to be part of this historic achievement by contributing to the 35,000 goal.

"96 Elephants and its partners are attempting to break the Guinness World Records<sup>™</sup> for the largest display of origami elephants to honor the 35,000 elephants that are lost each year," said John Calvelli, WCS executive vice president for Public Affairs and director of the 96 Elephants Campaign. "This simple gesture sends a powerful message to the world that we are taking a stand together to save these majestic animals."

This year has seen major victories for elephants around the world ranging from the final passage of the U.S. federal ban on the sale of ivory, to the world's largest ivory burn taking place in Kenya, to a state ban passing in Hawaii.

One of the secrets to living the CSA life is utilizing all of your produce and avoiding waste. Sometimes an abundance of something can be overwhelming because we are focused on using it now. Abundance is an opportunity to make something that you can freeze and use over the winter when CSA is over. One of my favorite recipes to share is my Roasted Tomato Sauce. It's really not a recipe, more a technique that you can use over and over again. Even if you are not in a CSA, this is a recipe you can utilize with the tomatoes in your garden and the ones at the farmer's market.

Preheat the oven to 425 degrees. Using a large glass baking dish, fill it up with whatever tomatoes you have on hand. Cherry tomatoes can go in whole, big beefsteaks need a rough chop to 2" cubes. Add any assortment of the following: whole garlic cloves. onion, sweet peppers, hot peppers, string beans, zucchini or small Japanese eggplant, fresh basil, fresh parslev. fresh cilantro or a dash of dried oregano.

Add a good dash of salt. pepper and a generous splash of olive oil. Toss to coat and spread out everything in an

even layer. Put it in the oven for 15 minutes, take it out to toss and turn and put it back in for another 10 or 15 minutes. It's done when the veggies are slightly browned and there is a ring of carmelization along the edges of the pan. Remove it from the oven and using a spatula, push the veggies to the outside of the pan so they can soak up and liquify the browned bits. Let it cool for a half hour and process the mixture through the medium or large setting of a food mill, depending on your preference for texture.

If you don't own a food mill, get yourself one. For \$25 or less, you'll have a kitchen tool that you can use for processing vegetables into soup and fruit into homemade preserves.

What's great about this sauce is its versatility. It's thick enough to use as a pizza topping and is ready to go over pasta. Add some chicken stock and you have an amazing tomato soup. You can use it as the base for a chili or a meat sauce or a chicken cacciatore. I made a batch with cherry and heirloom tomatoes, sweet green peppers, a zucchini, garlic and Thai basil. I used it for a lasagna I made that used thin sliced zucchini strips instead of noodles. We're serv-



ing it at the CSA distribution tonight.

Make some and use half of it now and the other half can go in the freezer. Just make sure you label it clearly with full ingredients! For me, every batch is different, some are spicy and some are not, so it's really important to know the flavor profile so that over the winter, you'll use your stash properly.

The hot dry weather has been great for tomatoes, peppers and eggplant. We seem to be getting a lot of eggplant in our CSA shares, so I thought I should share a recipe I tried recently. My usual first thought when confronted with eggplant is to fry it up and make an eggplant parm. I wanted to try something different and when Barb made babaganoush a couple of weeks ago for our CSA demo, one of our members gave it a try and posted on the Facebook page. One of her friends commented that she should try making an eggplant curry. Intrigued by the

idea, I searched a few recipes to get some ideas and created my own version here.

Roasted Eggplant and **Coconut** Milk

You need 2 pounds of eggplant (in case you needed a reason to buy a kitchen scale when you're at the store purchasing a food mill). I used the Japanese eggplant cut into 1 inch sections. If you choose to use the white or purple eggplant, just cut it up into 1 inch chunks. Do not peel the eggplant, just trim off the ends. Toss the eggplant with 3 tablespoons of olive oil and a  $\frac{1}{2}$ teaspoon of salt. Spread it out on two baking sheets in an even layer. Roast in a preheated 400 degree oven for 15 minutes, turn the eggplant pieces and roast for another 5 to 10 minutes. Remove from oven, set aside and let it cool.

While the roasted eggplant cools down, prep the following ingredients:

- 2 tablespoons butter
- 1 tablespoon avocado oil
- 3 garlic cloves, minced

1 banana pepper, seeded and diced

1 piece of fresh ginger, peeled and julienned

1 tablespoon of Garam Masala (I used Teeny Tiny Spice Company's Garam Masala which I purchased through our Lewis Waite Farm CSA Extras Program)

1 tablespoon ground turmeric

1 tablespoon ground coriander

### 1 can coconut milk

1/2 cup water

Heat the butter and oil in an enameled cast iron saucepan over medium heat. Add garlic, pepper and ginger and saute for two minutes. Add the spices, stir and heat for two more minutes until the spices are fragrant. Add eggplant, toss to coat and saute for one more minute. Add coconut milk and water, stir, bring to almost a boil, lower heat to a simmer and cook for 10 minutes

Serve over rice with a squeeze of lime and a sprinkle of chopped fresh cilantro. If you want to add a little protein, I added a cup of yellow lentils, but chickpeas would also be a nice addition.

And guess what - both of those recipes are vegetarian! With the CSA in full swing and our own garden pumping out tomatoes, peppers and artichokes, I've been sneaking in a lot of vegetarian meals. Quite honestly, with the heat and humidity, this is the perfect time of year to try a vegetarian diet.

In the meantime, be the change you want to see in the world!

# **Too much supervision leads to 'How to be adult' classes**

Kids will start leaving for college during the next few weeks, and it's nice - or maybe just weird — to know that at least one university is offering a new class this fall in "adulting."

The program at East Carolina University will attempt to teach incoming students how to be successful adults. Sadly, this does not involve tips on how to pick stocks, or useful friends. It is a class on how to roll with the punches.


Noting an increase of 1,800 counseling appointments over just two school years — which required the hiring of two new counselors - the university wondered if there was some way to make its students more resilient. The vice chancellor for student affairs, Virginia Hardy, conducted a study and came to realize the root of the problem: "Students don't have an opportunity as much these days to manage failure, they don't experience it in certain ways as much so they don't know how to manage it when it happens," as she told The Daily Reflector of Green-

ville.

Now, it is anybody's guess whether young people really can't handle distress or are simply more accustomed than earlier generations were with turning to mental health professionals. And there's something to be said for getting help rather than descending into darkness. There's even something to be said for learning how to turn off the "You are a loser" tape-loop in the brain, which is a stated goal of the class. As a college student, I wish I could have turned off mine.

But as Boston College psych professor Peter Gray has noted in his work on resilience: At least some college students seems to be seeking help for problems they could solve themselves. At his college, for instance, one student sought counseling after seeing a mouse in the dorm. Another came in after a spat with a roommate.

So the dark underbelly of being mature enough to seek help is being immature enough to find everyday ups and downs overwhelming. Thus the class at East Carolina U. will teach students that setbacks are a normal



part of life, as is frustration.

In other words: It hopes to teach young people at last — how to deal. Can't say I didn't see this coming

This is exactly the life lesson we have, in our love and worry, failed to give our kids. Instead, for the past generation or two we have been always at their side, overseeing them, monitoring them, making sure they're okay ... to the point where they aren't. This isn't the fault of neu-

rotic parents, the whole culture is complicit. My kids went to a variety of New York City public middle and high schools and all of these had tracking systems that allowed us to check how they did on homework, quizzes, and tests — daily!

That's a level of scrutiny no one expected of my own parents. It assumes that intense parental oversight is normal, even necessary. How intense? In some other cities, parents can log on and find out exactly which items their kids chose from the lunch line.

But worst of all this excess involvement is the way that adults have taken over play. Today's children grow up with their elders ever present to organize the game, settle the scores, and slice the snacks. These youngsters don't get a chance to improvise a wacky new move, because all the games count. They don't get a chance to throw the ball a little easier to the youngest kid, because all the kids are the same age. They never get a chance to problem-solve whether the ball was in or out, or even choose the teams (talk about a people skill!) because

adults do all that, too.

Then these well-loved, wellbehaved kids get to college and somethig as common as roommate troubles seem seismic because for the first time, there's no adult intermediary. Off they go to find one.

So now, even as it offers its adulting class, East Carolina intends to reach out to elementary, middle and high schools and try to restore some childhood resiliency.

With any luck, this will give schools the academic cover they need to simply intervene a little less, and trust kids a little more. Then maybe the parents will, too.

Childhoodwasnevermeant to be perfect. It has always had its lumps and bumps, physical and emotional. These prepare kids for adulthood. Humanhood. Even rooming-with-ajerk-at-college-hood.

A little more unsupervised time as kids can make unsupervised young adults a lot happier.

# The fallout of Commissioner Bratton's resignation

Last July. I asked NYPD Commissioner Bill Bratton a very benign question at a "Newsmakers Breakfast" my company produced: "Do you think you'll stick around for a second term after 2017?"

"Absolutely not," was Bratton's surprisingly candid response.

Instantly, two reporters scurried out of the room to report this breaking news. I sat there on the podium, feeling a mix of apprehension about the city's future without one of best police commissioners in our history and a journalistic concern that some other news outlet was going to break this story before my company could.

The next day, the daily newspapers had long stories about Bratton's surprising announcement. The secret was out and political observers began speculating about his successor while others began contemplating Mayor DeBlasio's prospects for re-election without his well-respected police commissioner.

This turn of events got me wondering about the state of policing in our country. It has probably never been a more perilous time to be a cop in America, with all-too-frequent assassinations happening as many cities becoming engulfed in protests over police misconduct.

There is no doubt that the crime legislation tougher passed two decades ago in Bill Clinton's administration as well as the ascendancy of the "Broken Windows" theory of policing has made our police more aggressive enforcing petty crimes like drug dealing fare-beating, and public urination.

At the same time, a few very disparate trends emerged that affected society profoundly guns became more plentiful and the homeless mentally ill began to fall through the cracks and were left to fend for themselves.

Police became much more concerned about preventing crime, aggressively stopping those suspected of carrying weapons and engaging in the controversial "stop, question, and frisk" method of policing.

In large cities like New

York, crime rates dropped steadily over two decades and today, our city is the safest large city in America. Bill Bratton and his erstwhile competitor and predecessor, Ray Kelly, started this impressive decline in crime in the early 1990s and now, a quarter century later. New Yorkers are the beneficiaries of a very impressive run of police commissioners.

After a huge spike in controversial "stop and frisks" in the last term of Bloomberg-Kelly, we now see crime rates holding steady while the use of "stops" has also dropped dramatically the past few years.

With Bratton's exit in September, it is the end of an era. What lies ahead?

NYPD officers seem to be going through a period of lower morale because they feel that the current mayor is not their ally and that he favors those who criticize police more than he stands up for them. There is some validity to this in the wake of two mayors - Giuliani and Bloomberg — who always backed their commissioners and the force despite the heat they sometimes re-

ceived. DeBlasio has always been lukewarm in his support of cops and allowed his very strong ally and Bratton to act as a buffer between the he and the NYPD.

Compounding this feeling is the ongoing heated contract negotiations that still have not been resolved. Mayor DeBlasio has settled with almost every other union in the city, but the police feel that the mayor has not offered them anything near what is fair. Last week's revelation that many members of the mayor's administration got generous raises only rubbed more salt in the wound for New York's finest.

What to do? Well, the mayor should try to figure out a way to make a grand gesture which shows how much he appreciates the men in blue and their good work in keeping our city safe (while other large cities like Chicago descend into violent chaos). If he can't do it through a more generous contract, then maybe he could offer merit bonuses? Or bonuses for police who live in the communities they serve?

Yes, there have been a num- com.

ber of disturbing events of police misconduct around the country that have been caught on tape and we must make sure these officers are properly disciplined. But we must not lose sight of the fact that every day, New York's police keep all of us safe and they continue to do so by breaking previous crime lows.



Twomey was a founder of the East Bronx History Forum, said the organization's president Richard Vitacco, stating that Twomey's newspaper column was an inspiration in his own research.

# Mayor Bill de Blasio holds Bronx Town Hall meeting

Lisa Soren, executive di- glers. rector of the Westchester Square Business Improvement District, asked Mayor de Blasio to address the influx of mentally ill homeless people into the shopping area

She wondered if there was a way to make sure patients coming from state mental health facilities were not left on the street.

She also accused the city of having a "hands off" approach when it comes to addressing homelessness in the Bronx.

De Blasio took issue with Soren's "hands off" comments and said the NYPD and the mayor's office are working on the Bronx' homeless issue.

The mayor pointed specifically to the NYPD's commitment to removing encampments in the Bronx.

Bronx Commander Larry W. Nikunen said as recently as April the NYPD removed an encampment in Pelham Bay Park.

He said 45th Precinct captain Danielle Raia led her officers as they they addressed a homeless encampment, offered them residence and substance abuse help, then dislodged them.

Nikunen said this is the process for every encampment the NYPD encounters.

In addition, once they clear an encampment, officers return to the location to

If people return, the NYPD will repeat the process.

Monique Johnson, president of the Throggs Neck Houses Residents Association, expressed concern about formally homeless families living in NYC Housing Authority apartments.

She said some of these families behave like they are still on the street.

Johnson said this causes problems for residents in adjoining apartments.

De Blasio said many homeless New Yorkers are stable people who just fell on hard times

He said sometimes it is difficult for them to adjust to life outside a shelter.

In addition, the mayor said if anyone "knows a homeless family ... that can't hack it" then they should reach out to the NYC Human Resources Association.

De Blasio also talked about Councilman Vacca's 'road diet' plan which appeared to be the most contentious part of the meeting.

The plan calls for the removal of a lane in each direction on East Tremont Avenue - from Waterbury Avenue to Bruckner Boulevard.

The idea is to slow down motorists on the main roadway that has claimed the lives of two pedestrians in hit and run accidents over the last three years.

In addition, he took issue with the fact the expansion of P.S. 14 was not discussed.

Vacca said after the meeting that he called on approximately 90 percent of the people present during the three-hour session.

In addition, he said he never saw Chirico raise his hand.

Vacca also pointed out that Cerini, who was against his traffic plan, was one of the first speakers called upon.

Vacca said overall he felt the residents took advantage of the opportunity to bring their concerns before the mayor and he thought the meeting was a success.

# **Bronx Sports BRONX NATIVE** TAKES SILVER

An Olympic medal is coming back to the Bronx and this one is historic.

Bronx native Daryl Homer clinched silver in the individual men's sabre in Rio on August 10, becoming just the fourth United States fencer to medal in the event and the first since 1984.

Team USA is still searching for another gold in the spot – a century-long quest - but Homer's accomplishment is not to be diminished.

Homer's victory in the semifinal was edge-of-your seat drama as he clinched a championship berth with a 15-14 victory over Iran's Mojtaba Abedini. Homer - who competed for St. John's University from 2008-2012 and entered the Olympic games ranked 10th in the world – battled back from an early 6-3 deficit to take a two-point lead at the break.

Homer jumped out to a 12-9 lead, but Mojtaba won the next three touches, tying the score at 14 and Homer did not back away from the pressure. Instead he attacked-lunging forward with determination and earned his final point.

Homer faced of against the reigning 2012 London Olympics gold medalist in men's individual saber Aron Szilagyi of Hungry in the championship and once again found himself down early.

Homer was able to cut in to Szilagyi's lead down the stretch, clawing back to make it 14-8, but that was as close as he would get.

Despite the final loss, it's difficult for Team USA to be too disappointed with Homer's silver. The Rio Games mark the first time the United States secured multiple medals in individuals fencing - along with Alex Massialas' silver in foil - since the 1904 St. Louis Games.

Homer has been front and center throughout the leadup to Rio, appearing in several TV spots as

well as modeling gigs with Vogue and Us Weekly.

His story has been dissected for weeks, while his less-thanusual introduction to fencing has captured the Olympic-watching world by storm.

Homer was born in the U.S. Virgin Islands, but moved to the Bronx with his mother at five years old and first discovered fencing when he saw a picture of it in a children's dictionary. It took a TV commercial, however, St. John's. His coach with Team his sights set on even more.

to cement Homer's interest.

"A commercial for AT&T that featured two black fencers came on. I pointed it out to my mom, and I think just the visual of seeing these black males fencing was enough to make her think this was something that was attainable," he told The Players' Tribune last September.

Homer went on to train the New York Fencer's Club and was a four-time All-American at USA, Yury Gelman, also served as Homer's coach with the Red Storm

Homer had plenty of confidence heading in to Rio, but now, with two Olympics under his belt and a medal around his neck, the fencing star isn't slowing down.

His career - for now - may be defined by one move and one moment, but Homer is got always ready for the next challenge. He'll savor this experience, but he's got

Jose Perez is ready to take flight – metaphorically.

The Wings Academy shooting guard isn't actually ready to start levitating anywhere – unless its a few inches off the court when he takes a jumpshot –but he is determined to leap into the high school hoops conversation.

Perez had a dominant summer and his confidence has never been higher. Now, as he turns his attention to his next season at Wings, Perez is ready to start building a reputation on the court.

"Everything has grown. Everything has improved," Perez said of his game over the last few weeks. "I've been in the gym 24-7. I swear, I barely even go home that much. I just stay in the gym."

Perez competed on the AAU circuit this summer with PSA Cardinals 17U and while he relished the chance to play at tournaments across the country, there was a different team that had an even bigger impact on the guard – the Dominican Republic national team. Perez played at the 2016 FIBA Americas U18 Championship for Men in Chile earlier in the summer, averaging 10.8 points, 5.6 rebounds and two assists per game. It was an experience that changed Perez basketballplaying life.

"It's been a big summer and that was the biggest part," Perez said. "It was a great experience, a fantastic experience. We got all the way out to Chile – an 11 hour flight –and I just

Texas, Maryland and Virginia. It's enough to boost Perez's confidence, but he isn't resting on his basketball laurels.

He still refuses to get out of the gym and Perez is quick to take on any on-court challenge – a trend he show-

cased at the sixth annual Big Strick Classic at Gauchos Gym earlier this month.

"It's great," Perez said. "I love going up against these guys because we're just going at it. We don't take it easy on each other."

As far as Perez is concerned, the key to his game rests solely on his ability to sink jumpers. And Perez is pretty good at sinking jumpers.

He averaged 16.5 points per game at Wings last season and Perez is well acquainted with the feeling of certainty whenever the ball leaves his hands.

It's a plan that Perez has focused on for years, but one that got a serious boost this summer.

"I want to win states and I want to up my recruitment," he said. "I'm ready to go through the roof here. I want to crack the top-50. This summer has really helped make all of that possible."

# One 'Mo' time: Rivera inducted into Monument Park

On a weekend that was chock-full of big-time Yankees moments. August 14 was particularly special as legend Mariano Rivera had his Monument Park plaque dedicated in a ceremony before the squad's 12-3 loss to Tampa Bay.

In an almost ironic twist, the Rays - who were witness to the entire weekend of historic Yankee moments didn't even exist when Rivera began his career.

"It's amazing because you're talking about the people there in Monument Park, especially starting with Babe Ruth, you have The Mick, and you have Mr. Joe DiMaggio, you have mr favorite, Yogi Berra and the list goes on and on," Rivera said. "And me, a humble guy from Puerto Caimito, Panama and being in that group of men means a lot."

The spotlight was once again on Rivera - who joined a jam-packed Monument Park - as the closer was honored by former teammates David Cone, Tino Martinez, Bernie Williams and Paul O'Neill. The biggest cheers, however, were reserved for Joe Torre, Rivera's manager from 1996-2007, and Derek Jeter, Rivera's longtime teammate and former Yankees captain.

Rivera played from 1995-2013 and accumulated a record 652 saves. The right-handed pitcher was a 13-time All-Star, and more importantly to Yankees fans, a five-time champion. Now, he joins the all-time Yankees greats in Monument Park.

"He mastered a craft," said Joe Girardi, Rivera's former catcher and manager. "And you can't say that very often about someone has a craft mastered in the game of baseball because it's so difficult. But he knew how to use one pitch and used it better than anyone ever did and I found it truly amazing."

Rivera used his devastating cut

fastball and that pitch will likely take him all the way to the Hall of Fame.

In his final season. Rivera notched 44 saves, was MVP of the All-Star Game and won AL Comeback Player of the Year. There are no regrets on retiring when he did, but he did speak of his passion for the Yankees-Red Sox rivalry.

"It's tremendous," Rivera said. "I think you look for those moments. I must be a masochist but I look for those moments."

As Rivera's manager, Girardi called his closer a "security blanket" at the end of games. Girardi won three titles as a player and one as a manager, with Rivera as a key contributor. A number of Yankees from the latest dynasty have been honored with retired numbers or monuments.

"I think you feel fortunate to have played with so many guys that have been honored there, and you realize what a prestigious honor it is, so to be able to say that I played with so many of these guys means that I was extremely fortunate, and it's the reason, in a sense, we have a lot of rings on our fingers," Girardi said.

Rivera's Monument Park moment was the climax of a once-in-a-lifetime kind of weekend for the Yankees and the squad's fans.

Alex Rodriguez played his final game in pinstripes on August 12, connecting on an RBI double in his first at bat of the night. Then, on August 13, the team honored the 1996 World Series squad - which also included Rivera - and showcased the future as Aaron Judge and Tyler Austin each homored in their first-ever Yankees at bats, becoming the first pair to do SO

Rivera's ceremony was a fitting finish to one of the best weekends in recent Yankee history as the legendary closer wrapped up a whirlwind celebration. Exit sandman.




# **Throgs Neck All Star Little League**
