# UNIONPORT TO BE REPLACED

# Bridge project goes to bid in June

As the start of construction nears for the new Unionport Drawbridge, residents have questions about how the work will affect them.

William Nyman, a senior project manager at Hardesty & Hanover - the development company overseeing the bridge's replacement, and some NYC Department of Transportation representatives addressed many of these issues during a Wednesday, January 11 presentation at Monsignor Scanlan High School.

Construction of the new bridge is scheduled to begin later this year and continue through 2021.

The current bridge, which runs across Westchester Creek at the Bruckner Interchange, will be replaced by two sideby-side one-leaf bridges, each having three lanes.

The westbound traffic will get a dedicated lane for vehicles existing onto Zerega Avenue and the east bound side will offer a lane turning onto Brush Avenue.

Nyman said the reason for implementing a one leaf bridge - meaning the bridge will only open one way - is so that all the machinery to open the bridge is on one side and it will be easier to fix any issues with the bridge.

In addition, there will be a 12-foot wide bike path on the new northern bridge and a five-foot wide pedestrian sidewalk on the new southern bridge.

Construction workers will begin building the southernmost bridge while the old bridge stays operational.



# St. Benedict completes \$15k brick campaign

St. Benedict's School has employed a creative method to raise money for the technology it needs to meet today's challengers.

The elementary and junior high school raised \$15,000 and hopes to clear at least \$10,000 in a recently completed ceremonial brick campaign that will commemorate the donors inside the main entrance to the school building.

The funding, mostly from alumni but also from teachers, will be used to purchase more Chromebook laptop computers for instructional purposes, said Ray Vitiello, St. Benedict's School principal.

The thirty-five carts and devices will be provided to teachers on each floor of the school as a result of the brick campaign, said the principal.

Vitiello said that Benjamin Piacquadio, a social studies teacher who pitched him the idea along with all of the junior high teachers at St. Benedict's, spearheaded the effort.

"We are always looking for innovative ways to raise money for our school with the hopes of bringing better technology or more advanced technology into this school," said Vitiello.


The computers will provide students with additional capabilities to link to various websites related to the topics they are learning about while they remain in their own classrooms, said the principal.

One aspect in using computers in teaching is that they allow for the collection of data via learning platforms that can show teachers how individual students are performing in terms of meeting predetermined standards, said Piacquadio.

Individual teachers can monitor, for example, which students were performing well or not up to standards in multiple areas of Common Core Standards, and teach based on the what the data is showing.


Piacquadio said that this allows for 'differentiated instruction,' where teaching can be tailored to individual student needs by providing different avenues to learning.

"We got to keep up with the everchanging world of technology," said the principal, explaining in previous

times the school had a computer lab, but that now, computers are in the classroom

Piacquadio wrote to alumni as part of the fundraiser, and worked creatively with Donna Miller, a graduate of the school who has helped create a database of alums with contact information.

"Ben contacted me and told me that he had organized this campaign," said Miller, adding "I emailed people and forwarded a letter from the principal about this campaign and added my own."

Miller said that in addition to emailing the St. Benedict graduates in her database, which includes some 1,200-school alums, she mailed written hard copy letters to about 100 selected alumni regarding the commemorative bricks.

"We are thankful for the generous support of the alumni," she said.

In addition to Miller's efforts, St. Benedict first grade teacher Jeanette Chin helped by calling alumni and answering their questions about the brick campaign, according to Piacquadio.

Two benches will also be installed below the wall near the bricks, said the principal.

One was donated by an alumni who now lives in Hawaii and another from St. Benedict faculty and staff members who provided \$2,000 in support, said Vitiello.

The principal is still looking for a craftsman to install the bricks, he said, which have names of students and their graduation dates, as well as other appropriate messages.

A dedication ceremony, featuring a reception for donors, may take place in late May, said the principal.



# **DOT** barriers bring Surf City to Co-op City

Tiny surfers on a sea blue background are painted on Jersey barriers that line the center median of Bartow Avenue as it runs into Hutchinson Parkway East, that would look better fitted for the Rockawavs.

However, those barriers are instead lining one of the main thoroughfares of Co-op City, in an area not known for its breaking waves.

To make matters worse, the long-awaited steel-reinforced replacement barriers appear to be as worn as the ones they replaced.

There is already evidence of chunks of crumbling concrete falling off the recently installed barriers.

The stretch of roadway, known as 'killer curve', due to its extreme serpentine bend, requires drivers to severely drop their speed or slam into the concrete dividers.

The deteriorating barriers have left Co-op City residents perplexed since the road was milled and repaved by NYC Department of Transportation late last year.

The Jersey barriers, also known as New Jersey walls, will be repainted in the coming months, according to the DOT, but area officials are demanding more.

Councilman Andy King, said the previous barriers were damaged to the point that he requested they be replaced. But King said the condition of the replacements is not much better.

"It looks like (DOT) took them from Coney Island," he said, making reference to the miss-matched beach-like motifs painted on the barriers.

King said he would be speaking with the DOT on Thursday, January 12 about the fate of the barriers.

Community Board chairman Martin Prince said the barriers, which were salvaged from parts of Queens significantly impacted by Superstorm Sandy in 2012, were actually a slight improvement from the barriers that were there previously.

"Th(e older barriers) were crumbling even worse,' Prince said.

Prince said he would dis-

# Chase Bank robber spills on Instagram

While 2017 is less than a month old, a Florida man is making an early run at the title of dumbest criminal of the year.

Some people will share anything on social media...

their breakfast, their cat, their children.

But the spoils of a robbery spree?

That's what Paul Lubin, 31, of Florida, did before he robbed the Chase bank at 3528 E. Tremont Avenue on Wednesday, January 4 at 1:24 p.m.

He made off with more than \$7,000 after slipping a note to a teller

Lubin had already hit six other Chase banks in Queens over the past three months starting Friday, September 30, including branches in Kew Gardens, Jamaica and Bayside and Glendale.

The brazen thief had absconded with almost \$25,000, according to police.

Lubin handed bank tellers at each bank he robbed a note that contained essentially the same message:

"DO NOT DO anything stupid. Put \$5,000 in an envelope. DO NOT PISS ME OFF! Everyone's safety depends all on you!"

Notes given to bank clerks on December 14 and 27 used similar wording. The underlining of certain words for emphasis further helped the FBI narrow down the cases to single suspect.

Lubin's fingerprints were lifted from the note written on a bank deposit slip, and were

quickly matched with Lubin in the law enforcement database.

Lubin was apprehended by United States Marshals just days after an affidavit calling for an arrest warrant was filed Thursday, December 29 in the Eastern District of New York United States District Court.

That affidavit was sealed

by the court to prevent Lubin from being able to check online if a warrant was issued, a practice the agent who authored the report said was increasingly common.

FBI agents were able to track Lubin down partly thanks to photos he shared to the social media photo sharing app Instagram.

A photo of Lubin wearing the same striped hooded sweat-shirt seen in bank surveillance video footage was posted on the site last week under the name Paullubin11 on Tuesday, December 13, which also showed a large stack of cash.

Lubin then commented on the picture, "#Thuumbin-thru."

Lubin's Instagram account was apparently fairly popular - the photo of his ill-gotten cash received 28 likes from other users.

"You're such an idiot, hahaha," commented one Instagram user, operating under the username 'Vladiruss.'

He'd probably be hard pressed to find anyone who disagreed.

### FATAL HIT AND RUN MULTI-CAR ACCIDENT

A 21-year-old man has been arrested following a fatal hit-and-run multi-car accident in Allerton. Police arrested and charged 21-year-old driver Tanbir Islam with manslaughter, driving while intoxicated, vehicular manslaughter and leaving the scene of an accident that left five people injured and resulted in one death. On Thursday, January 5 at 9 p.m., Islam alledgedly drove his 1997 Toyota Camry southbound on Boston Road near Wallace Avenue before crossing into the northbound lanes where he struck a 2010 Chrysler Town and Country minivan. The impact forced the vehicles into an unoccupied parked Mitsubishi Endeavor. The three passengers inside the Camry, two 21-year-old men and a 22-year-old man, and the 47-year-old minivan driver were extracted from the wreckage by Emergency Service Units. The victims were rushed to local hospitals with three listed in critical condition and one in serious, but stable condition. Christopher Hulse, 21, the backseat passenger inside the Camry, was pronounced dead at Jacobi Medical Center. A pedestrian also sustained minor injuries and was treated at the scene. Police said, Islam alledgedly fled the scene on foot, but was arrested the next morning at Jacobi Medical Center where he sought medical Photo by Edwin Soto

# Cheerleaders raise \$\$ to attend Nationals

After months of wondering whether they were going to Disney World, the James Monroe Eagles cheerleading team got the funding to realize its goal.



# Blaze shutters Lotus Flame restaurant

The embers have gone cold at Lotus Flame in Morris Park for the foreseeable future after an early morning fire caused major damage to the eatery.

On Friday, January 6, the fire severely damaged the apartments above the popular Indian restaurant at 866 Morris Park Avenue and left the fate of the restaurant in limbo as the FDNY investigation into the blaze continued.

The first FDNY unit arrived at the fire four minutes after it was called into 911 just after 2 a.m.

It started in the basement, according to the FDNY, and then spread to the second and third floors, as well as the roof.

The fire quickly escalated to a third alarm, bringing 33 units and 140 fire-fighters to the scene.

Firefighters brought the blaze under control at 4:18 a.m.

Two residents and four firefighters suffered minor injuries, according to the FDNY Office of Public Informa-

tion.

A family living on one of the upper levels was displaced by the fire, but family members did not require aid with relocation to another temporary residence, according to Red Cross of Greater New York spokesman Michael de Vulpillieres.

Lotus Flame co-owner Savitri McCrea said on Monday that the restaurant was closed indefinitely.

She said she did not know the cause of the blaze, but said FDNY officials were investigating a possible electrical cause.

The restaurant had been open for two years and two months, and had earned raves from customers and the press for its Indo-Caribbean and Chinese offerings.

McCrea said she did not know when or if the eatery would reopen, and whether it would reopen at the same location.

"I cannot say at this point," she said.

# Soundview resident guaranteed a warm winter

During the winter months we are thankful for a warm place to come home to.

Soundview resident Milagros Orizal was \$9,000 away from having that luxury until she was selected for some huge generosity.

Thanks to a charitable act from the National Association of Oil & Energy Service Professionals, Orizal received a free boiler and a few young apprentices got a valuable learning experience as well.

In December, Orizal discovered her boiler was leaking and learned she needed to purchase a replacement.

"With what money?," she asked.

Pete Gonzalez, a member of the New York City chapter of OESP, had worked on Orizal's boiler in the past.

Orizal reached out to Gonzalez.

"I feel like I won the Lottery," Orizal said of learning her application had been selected.

She also said she was fearful of having no heat in the house and having the water pipes freeze over.

"I'm so happy," she added. "I never thought things like this happen to peo-

Gonzalez, who also runs his own heating company, arrived at Orizal's home with three students from the high school.

The high school seniors - Tyrese Jordan, Joshua Diaz and Justin Gonzalez - installed Orizal's boiler and were graded on the work once it was finished.

"It feels good because you're able to help someone that needs heat," said D

Jordan appreciated the chance to see the progress of the boiler as he and his classmates worked on its installa-

"When we came here and started it was just a boiler," he said. "And now when you look at it and see all the piping and everything I said, 'Wow, we did that."

Angel Gonzalez, the vice president of the New York City chapter of OESP, called the installation a "great experi-

"We have a couple of different things going on here," Angel said. "We're giving back to the students - they're gaining education here and they're gaining field experience."

"And at the same time we've given to a needy family," he continued. "So we've got two different things going on here which is a really great experi-

The students began the job on Wednesday, January 4 and finished the work on Friday, January 6.

In addition, to the boiler, the group also installed a brand new water heater next to the boiler.

"I want to say thank you so much for what Angel and Pete Gonzalez have done for my family," said Orizal. "Without them I didn't know what I was going to do."



# Mott Haven Decorator Show House launched

This summer, a landmark Mott Haven townhouse will become an elegant exhibition preserving the neighborhood's history.

The Mott Haven Historic Districts Association will launch its inaugural 'Mott Haven Decorator Show House' to raise funds supporting projects within the area's historic districts.

Interior designers will collaborate with local young up-and-coming designers to transform a landmark town-house into an elegant exhibition of fine furnishings, art and technology.


Working with fiscal sponsor South Bronx Overall Economic Development Corporation, Samuel Brooks, MHHDA president, plans to convert his threestory 442 E. 140th Street home in the Mott Haven East Historic District into a show house.

Brooks will open his home to the public for a \$20 admission with a 25% discount for 10454 residents.

All proceeds raised will improve the three historic districts' streetscapes, historical lampposts, tree guards and historical signage.


These historic districts include the Mott Haven Historic District at East 138th and 141st streets on Alexander Avenue, the Mott Haven East Historic District spanning Brook and Willis avenues on East 139th and 140th streets and the Bertine Block Historic District between Brown Place and Willis Avenue on East 136th Street.

The Mott Haven Historic District was landmarked in 1969 while the

Mott Haven East Historic District and the Bertine Block Historic District were landmarked in 1994.

The Mott Haven Historic District was the first historic district to be designated in the Bronx.

The borough is home to 12 historic districts, eight interior landmarks and 93 individual landmarks.

Brooks' home was constructed in 1889 by local developers William O'Gorman and Hermann Stursberg.

O'Gorman served as architect designing the south side townhouses in a neo-Grec style characterized by uniform Philadelphia brick façades adorned with incised geometric stone ornaments and topped by bracketed metal cornices.

Brooks, a 43-year resident, was inspired by the Kips Bay Decorator Show House and Pasadena Showcase House of Design to create MHDSH.

"There are no specific guidelines, we want the designers to come in here with an open mind," he explained.

Participating designers include Jason Tackmann, Sobro Studios Surface president; Pedro Castillo, PC Interior Renovation president and Stacey Dipersia, a TriBeCa-based interior de-

signer.

Once completed, seven New York School of Interior Design graduate students will create an Airbnb hospitality suite for tourists in the townhouse's lower level.

Brooks said MHHDA has contacted the school and is awaiting its response.

The house will attract tourists to the historic districts while educating them on the districts' architectural and historical contributions to the borough.

In addition, MHHDA and Bronx Museum of the Arts will have 50 artists visit Mott Haven to paint whatever the neighborhood inspires them to create on a 12-foot by 12-foot canvases.

The artwork will be displayed inside the show house where visitors can bid on their favorite pieces.

All proceeds raised will go to the artists.

Show house volunteers must submit their applications no later than April.

One of the reasons that I love writing about food is that it is one of the rare things in life that can be shared with friends and family across political spectrums. While culture and religion most certainly affect what is on the plate and is difficult to ignore, politics is very easy to leave off the plate.

That's not to say that food isn't affected by politics. For example, right now our president elect and his transition team are working on selecting cabinet position nominees. At the time of this writing, the Secretary of Agriculture is a position that has yet to be filled. Farmers and ranchers in rural America are not the only ones with a lot riding on this decision, and their support of Trump during his campaign makes them especially concerned about this choice.

Farm income has been going down, despite a recent boom due to the promotion of ethanol. Costs for seeds and fertilizer continue to rise as prices are stagnating. Small farmers are trying to compete with agrobusiness empires like Cargill and ADM and are finding that the costs of maintaining farmland and equipment to keep up with government regulations is breaking them. They are hoping that the new administration will select someone that is 'one of them'.

Those of us in urban America have a lot riding on this selection too. The USDA, which is under the purview of this cabinet member, oversees school lunches, food inspection and SNAP benefits. According to the CUNY Urban Food Policy Institute, in New York City alone, 1.7 million people receive SNAP, 1.1 million chil-



dren consume 650,000 federally subsidized school lunches and 200,000 breakfasts DAILY.

Whomever heads this department must also have a keen understanding of how allocating more funding to school lunch programs, free meals at senior centers and allowing more and more farmers markets to accept SNAP benefits can allow more money to be spent on local produce, creating more income for farmers. Funding for these programs are lifelines for many Americans, both urban and rural.

When it comes to food in-

spection, agribusiness and their use of Concentrated Animal Feeding Operations are the biggest offenders to our food safety. A cabinet member that is not in the pocket of these large producers, such as Smithfield and Tyson, would probably be desirable.

Farmers need to be able to hire workers for good wages that work in safe environments producing food that is nutritious and delicious. Farm workers are typically immigrant labor and we need to develop policies that allow for these migrant workers to safely work in the US, pay taxes and return home.

We need to make sure that everyone in America can eat a diet filled with nutritious and delicious food that is produced locally without chemicals,.

We need to create markets for our farmers and ranchers so that the good, healthy food that they raise with environmentally sustainable practices can be sold at a good profit.

The potential for agricultural exports is one that a Secretary of Agriculture can use as a way to buoy the rural economy. Hopefully, a renegotiation of trade deals such as NAFTA will result in American farmers receiving better prices for their crops.

We can make a difference in the life of the American farmer by simply working on changing our purchasing habits when it comes to food by avoiding highly processed foods and making every attempt to purchase whole foods that are domestically produced. I always say that the power of the purse will prevail.

Bbe the change you want to see in the world. And remain diligent.

# Opioid addiction needs urgent action

Findings from a new survey by Indivior were announced today and showed that nearly three in five (59%) of adults surveyed in Bronx believe that addiction to opioids is one of today's highest social priorities, requiring urgent attention. When asked to rank opioid addiction against other pressing social priorities, Bronx residents surveyed found it to be a bigger issue than climate change and immigration

Despite nearly universal support (90%) from survey participants to find an urgent solution to tackle the problem of addiction to opioids, the survey flagged a number of important barriers to treatment. They include a lack of awareness of local treatment options, stigma and too few local physicians who are qualified to provide treatment from their office. The majority of those surveyed (68%) feel that there are currently not enough opioid addiction resources available in their community.

Opioid addiction, whether to prescription pain relievers or illegal drugs such as heroin, is a serious, life-threatening medical condition, that produces changes in brain chemistry and function., It can affect anyone, irrespective of age, gender, race and socioeconomic status and impacts many in the Bronx community at a personal level. Approximately one third of those surveyed (30%) say they or someone close to them have misused, abused or been addicted to prescription opioids. On a national level, more than 2.4m Americans were found to suffer from substance use disorders which included abuse or addiction to prescription opioids (1.9M) and heroin (586,000) in 2014. Tragically, overdoses involving opioids killed more than 28,000 Americans in the same year. The Bronx survey showed that out of those who took part, 17% residents have had personal experience of opioid overdose (themselves or someone close to them) and 12% knew someone close to them who died because of prescription or illegal opiate abuse.

Local problem, local treatment

Nationally, only 3% of eligible physicians are currently qualified to treat opioid addiction in an office based setting with certain medications. Buprenorphine Medication Assisted Treatment (BMAT) is a treatment aimed at reducing opioid use and the risk of overdose and involves the use of the medication buprenorphine in combination with counselling and behavioural therapies. A majority of those surveyed in Bronx feel that having more local certified physicians who are qualified to treat opioid addiction within their office would reduce the number of opiate overdoses in the community and make their communities safer.

They also show a higher level of trust in local doctors for information on opioid addiction when compared to other local, state or national resources.

Under the provisions of the Drug Addiction Treatment Act of 2000 (DATA 2000), physicians who have completed appropriate training or meet other qualifications are able to obtain a federal waiver to provide Medication Assisted Treatment in an office-based setting. However, in the Bronx survey, over half (53%) of local residents were aware that opioid addiction can be treated in a local physician's office. Not surprisingly, despite 97% of Bronx residents saying they would be likely to suggest that someone they know suffering from opioid addiction seeks treatment, only one-third say they are very confident that they know where to send someone for treatment.

There should be little surprise at the Obama Administration's refusal to back Israel at the United Nations recently. Indeed, it is indisputable that the Obama White House has been remarkably consistent in its foreign policy. From his initial days in office, the President has made it clear to U.S. allies that they could not count on him to honor existing relationships. The list is extensive

As WIKILEAKS reported, the Obama Administrations agreed to surrender British nuclear secrets (without London's permission) to Moscow as part of the New START treaty. Indeed, many in the U.S. saw that treaty as a betrayal of the new President's own country.

wrote: "The centerpiece of 'New Start,' the armscontrol treaty that President Barack Obama signed with Russian President Dmitry Medvedev...will require the United States, but not

Russia, to dismantle existing delivery systems. This could cripple America's long-range conventional warhead delivery capabilities, while also severely constraining our nuclear flexibility. We will pay for this mistake in future conflicts entirely unrelated to Russia."

Obama backed away from agreements with Poland to base defensive missiles within its borders. James Joyner, writing for the Atlantic Council, noted Former U.N. Ambassador John Bolton that the action was "seen as a poke in the

> putative host countries - Poland and the Czech Republic - will undoubtedly feel jilted and let down by Washington. Former Soviet bloc countries had already begun to voice concerns that Washington's vaunted reset of relations with Moscow would come at their expense. For many, this move [was] seen as a disappointing confirma-

> The President prematurely withdrew American forces from Iraq, which created the vacuum that gave rise to ISIS. Those that had remained or had become associated with Washington were placed in severe jeopardy as a re-

Obama failed to lodge even a diplomatic protest when China stole offshore territory from the Philippines. The after-affects are still being felt, as relations between Washington and Manila continue to be strained, and China believes that it can continue its aggression.

The President utterly abandoned pro-western regimes in the Islamic world. Indeed. Obama even assisted in the elimination of the pro-western government of Egypt's Hosni Mubarak and the anti-al-Qaeda regime of Libya's Muammar Gaddafi. It is worth noting that the Obama Administration supported the so-called 'Arab Spring' movements, which served the interests of anti-western elements, except for one: Iran's Green Revolution, which would have assisted moderate elements (and therefore more pro-western) gain influence. Eli Lake, writing for Bloomberg News, describes the matter: "In his new book, 'The Iran Wars,' Wall Street Journal reporter Jay Solomon uncovers new details on how far Obama went to avoid helping Iran's green movement.

Behind the scenes, Obama overruled advisers who wanted to do what America had done at similar transitions from dictatorship to democracy, and signal America's support. Solomon reports that Obama ordered the CIA to sever contacts it had with the green movement's supporters. 'The Agency has contingency plans for supporting democratic uprisings anywhere in the world. This includes providing dissidents with communications, money, and in extreme cases even arms,' Solomon writes. 'But in this case the White House ordered it to stand down.'

Obama engaged in a unilateral withdrawal of American tanks and antitank aircraft from Europe in early 2014, a clear and open slap at America's NATO allies. There is a fascinating sidebar to this item. When candidate Donald Trump suggested that NATO members be pressured into paying their fair percentage of defense spending, the U.S. media accused him of potentially abandoning Europe. When President Obama withdrew the backbone of U.S. forces, those same media sources were utterly silent. Indeed, except for the military newspaper Stars and Stripes, the New York Analysis of Policy and Government, and a few specialty publications, the move was barely reported at all.

In complete violation of U.S. treaty obligations to the Ukraine, the White House failed to take any serious steps, other than minor sanctions, against the Kremlin in response to its Ukrainian invasion. The President could have easily imposed a massive cost on Russia by opening up U.S. federal lands to energy exploitation, which would have hit both the Russian influence on Europe and its ability to fund its misadventures.

It wasn't just nation-states that were abandoned. He failed to take into consideration the plight of Cuban dissidents when he opened relations with Cuba (a month after Havana agreed to let the Russian navy back in!)

He failed to dwell on the oppression of dissidents in Iran and China in his discussions with the governments of those nations.

Despite the continuous and blatant violations of trust and treaties with American allies, the Obama Administration never paid a domestic political price for its betrayals thanks to a fawning media that did its best to ignore the perfidious actions. What is even more worrisome is the manner in which Mr. Obama unilaterally turned U.S. foreign policy upside down without the consent of Congress.

# East Bronx History Forum events and highlights

The Huntington Free Library and Reading Room announces the East Bronx History Forum will hold its first meeting of 2017 on Wednesday, January 18 at 7:30 p.m. The East Bronx History Forum meets to discuss Bronx history and held its first meeting June 2005.

It is very interesting how one event many years ago has impacted and affected directly another community on the other side of the Bronx River. This is the case with the Morris Park community. The great fire in New York City of 1835, led to construction in 1837 of the Croton Aqueduct system and its expansion resulted in the closing of the Jerome Park Racetrack.

known as the Belmont Stakes would continue at the newly built Morris Park Racetrack in 1890, until residential expansion caused the final move to Long Island, NY.

The history of the Morris Park community gets its name and start from the racetrack founded by John A. Morris, but the story continues, long after the last horse race in 1904. 

# Art Deco in the Bronx

Spotting Art Deco buildings is not very difficult. Think of the Chrysler Building for design and ornamentation. Look for varied colors in the brickwork and geometric patterns jutting out from the building surface. Gargoyles, statuettes, rounded corners, ornamental terra cotta or tile molding and tall windows that emphasize height in the design are generally prominently featured. The term Art Deco is simply an adaptation of "Exposition Internationale des Art Decoratifs" which was held in 1925 in Paris.

The Grand Concourse, of course, has the prime examples of Art Deco buildings in the borough but there are a couple of others which shouldn't be overlooked. One is Noonan Plaza on West 168th Street between Ogden and Nelson Avenues. The other is Park Plaza at 1005 Jerome Avenue across the street from John Mullaly Park from which it gets its name. It occupies block 2504, lot 126 extending back to Anderson Avenue and was built between 1929 and 1931. Both buildings have landmark status.

Noonan Plaza was designed that the avenue really began by architects Horace Ginsbern and Marvin Fine for Bernard J. Noonan who emigrated from County Longford, Ireland in 1886. It was built in 1931 and is composed of eight interconnected buildings which house 283 families. Art Deco enthusiasts, however, are more impressed with the tan iron spot brickwork and the 15,000 foot decorative courtyard off the southeast corner of Nelson Avenue and West 168th Street accessed by an angled portico and gate house. The use of the term "garden apartments" was especially inviting for those escaping the congestion of Manhattan with its teeming masses. The word garden played like magic in their imaginations and was a definite drawing card for many.

Jerome Avenue was laid out in 1874 and paved in 1888 but it was not until the elevated mass transit line was opened in 1917

to develop. Architect Horace Ginsbern began construction on Park Plaza in 1929. It had 350' of frontage on Jerome Avenue and reached back to Anderson Avenue where it ran for another 50'. Unfortunately, a fire of suspicious origin on June 25th of that year dashed their plans and the building was not completed until 1931. Marvin Fine, who had worked with Cass Gilbert for eighteen months was responsible for the exterior. He was very careful to note the changes in appearance due to shadows and light. This would be especially helpful in selecting the right combination of shades in the brick work.

Park Plaza was originally designed as a 10-story building but because of the fire, the builders were forced to lower it to eight floors. It is composed of five sections each being separated by a courtyard but con-


nected at the rear. There are lighted by its marble walls of 800 rooms divided into suites suitable to house 250 families.

The window bays are arranged in vertical shafts to give the further appearance of height. Patterned spandrels and the artistic use of terracotta help to define the overall Art Deco design. This general theme is driven home by the effective use of varied colored brick along with their unique geometric designs.

The lobby entrance is in the center block and is high-

varied colors. Terrazzo floors and the effective use of murals help complete the scene. The entrance doors are outlined in black marble while glass blocks compliment the appearance of the foyer.

The overall look of the lobby leaves no doubt about why it is often cited as the standard when judging Art Deco buildings. Park Plaza is considered by many as the finest example Art Deco construction in the country.



It is not known whether the marbles were thrown or if they were launched using some kind of gun or slingshot.

Bronx Chamber of Commerce president and CEO Nunzio Del Greco said the incidents were an unfortunate bump in the road for many small businesses.

"It's tough enough doing business in New York City, we don't need additional problems to deal with," he said.

Del Greco said that while such acts temporarily hurt the quality of life for residents, they would not derail the ongoing economic rebirth of the Bronx.

Del Greco said security cameras were the best deterrence to such crimes, and said he was contemplating the chamber hold a workshop on small business security, as well as cyber security, during the new year.
